RE: Letter of Intent—Six Station Expansion, FMC Moses Lake Dialysis Center

Dear Ms. Sigman:

In accordance with WAC 246-310-080, Inland Northwest Renal Care Group (“IN-RCG”); parent company-Fresenius Medical Holdings, Inc, hereby submits this letter of intent to expand its existing Moses Lake Dialysis Center in the Grant County Dialysis Planning Area. In conformance with the requirements of WAC, the following information is provided:

1. Description of the Services Proposed:

IN-RCG proposes to add 6 stations to the certificate-of-need approved FMC Moses Lake Dialysis Center, located at 847 E. Broadway Ave., Moses Lake, WA 98337. This facility will continue to offer in-center hemodialysis, home dialysis training, isolation capability and a dedicated bed station.

2. Estimated Cost of the Proposed Project:

The total estimated capital expenditure for this project is \$262,541. In the interest of transparency, it should be noted that of this total, \$91,800 for dialysis stations has already been expended as back-up equipment. Further, \$74,741 in capital expenses incurred as a result of the Center’s relocation in 2014 were not included in the Department’s determination of non-reviewability (DOR #14-24, May 30, 2014), where the relocation was approved. Thus, these \$74,741 in costs are included here as a project capital expense. This request would include \$96,000 in new, incremental costs for facility water treatment expansion.

3. Description of the Service Area:

The facility will provide services in the Grant County Dialysis Planning Area.
