Dear Ms. Aylsworth:

Thank you for the May 29, 2012, submission requesting a six-month extension to the validity of Certificate of Need (CN) #1330R. CN #1330R approved the establishment of a three operating room ambulatory surgery center in Issaquah, within King County and is valid until October 1, 2012.

WAC 246-310-580 allows one six-month extension to the validity of an issued CN, provided that the applicant can demonstrate <u>substantial and continuing progress towards commencement</u> of the project. [emphasis added] Since the project approved by CN #1330R required construction, the provisions of WAC 246-310-580(2) applies to this request. This section states:

"in the case of a project involving construction, substantial and continuing progress towards commencement" includes one of the following:

- a) When review and approval by the department of the final plans for construction is required, the submission of working drawings;
- b) When plan approval is not required by the department, receipt of copies of the working drawings for construction; or
- c) In the event working drawings have not been submitted, the applicant must demonstrate that he or she has made <u>continuous progress</u> toward commencement of the project. [emphasis added]

The department considered the following information in making its decision about granting an extension to CN #1330R.

- Information submitted by Swedish received on May 29, 2012, with the extension request.¹
- Supplemental letter submitted by Swedish received on August 3, 2012.

¹ The department did not consider activity that occurred between May 26, 2006 (initial CN #1330 issued) and April 6, 2009 (Order tolling commencement deadline) to be relevant to whether there had been substantial and continuous progress toward commencement of CN #1330R. The two year commencement deadline for CN #1330R was set October 1, 2010 by the Health Law Judge in Stipulation and Order Dismissing Adjudicative Proceeding (October 1, 2010 through October 1, 2012).

- Letter from Ogden Murphy Wallace representing Overlake Hospital Medical Center received August 20, 2012.
- Letter from Evergreen Hospital received July 26, 2012.
- Quarterly progress reports submitted by Swedish Health Services (SHS) from October 1, 2010 through present. A summary of the progress reports and other documents provided during this timeline is enclosed.

Significant Factors Considered:

- No working drawings have been submitted to the department (CRS² or CN). Therefore, an extension is not justified under (a) or (b).
- The supplemental information submitted in August 2012 describes various planning activities associated with the pending opening of the new Issaquah hospital. This includes the possible relocation of an approved ASC to Redmond. However, there is nothing in the Progress Monitoring Report record to support that the approved ASC being referred to in these high level planning activities is CN #1330R. Swedish had two CN approved ASCs within this planning area.³
- March 2011 Progress Report states "Right now we are focused on CN1264R2 (Bellevue ASC) for which we applied for a site change amendment on 4/10/11. Once the situation Re: that ASC is finalized we will turn our energies to planning this ASC." Response to monitoring question about anticipated date of submission of design documents to the Construction Review Unit was "unknown at this time. Commencement deadline Oct 1, 2012." Response to monitoring question about anticipated date of commencement of construction was "unknown at this time." The progress report also shows no changes or any planned changes to the approved project.
- September 2011 Progress Report states "Following approval of site change for 1264R2A, Bellevue ASC, & opening of the ASC on the site, we have now shifted our attention to this C of N. We are discussing operational planning for the ASC." Response to monitoring question about anticipated date of submission of design documents to the Construction Review Unit was "unknown at this time. Commencement deadline Oct 1, 2012." Response to monitoring question about anticipated date of commencement of construction was "unknown at this time." The progress report also shows no changes or any planned changes to the approved project.
- December 2011 Progress Report states "Following approval of site change for 1264R2A, Bellevue ASC, & opening of the ASC on the site, we have now shifted our attention to this C of N. We are discussing operational planning for the ASC." Response to monitoring question about anticipated date of submission of design documents to the Construction Review Unit was "unknown at this time. Commencement deadline Oct 1, 2012." Response to monitoring question about anticipated date of commencement of construction was "unknown @ this time." The progress report also shows no response to monitoring questions about changes or any planned changes to the approved project.

³ On June 24, 2011 the department approved CN #1264R2A to relocate the Swedish-Bellevue ASC into the pending Issaquah hospital's outpatient surgery area.

• March 2012 Progress Report states "We have filed a letter of intent for a change of location for this project. We are preparing working drawings." Response to monitoring question about anticipated date of submission of design documents to the Construction Review Unit was "Assuming site change approved. Oct 2012." Response to monitoring question about anticipated date of commencement of construction was "Assuming site change approved. April 2013" The progress report also shows no changes in approved project. For the first time planned changes to the approved project are identified. It states "Swedish plans to file a site-change application, & submitted a LOI to do so on 4/27/12."

After consideration of the materials submitted for your extension request and the information submitted in the required Progress Monitoring Reports, the department concludes substantial and continuous progress toward commencement of CN #1330R has not been demonstrated. Therefore, the extension request submitted by SHS is denied. Certificate of Need #1330R remains valid until midnight, October 1, 2012.

This decision may be appealed. You or any affected person with standing may request an adjudicative proceeding to contest this decision within 28 calendar days from the date of this letter. The notice of appeal must be filed according to the provisions of Revised Code of Washington 34.05 and Washington Administrative Code 246-310-610.
