SB 5052 Concerning the Creation of Health Equity Zones

"The legislature finds that people of color, [Native American and Alaska Native], people experiencing poverty, and immigrant populations experience significant health disparities compared to the general population, including more limited access to health care and poorer health outcomes. The legislature finds that these circumstances result in higher rates of morbidity and mortality for persons of color and immigrant populations than observed in the general population."

Sponsored by Senator Karen Keiser 33rd Legislative District-Des Moines

Community-driven Solutions to Local Health Needs

- Identification of 2-3 geographically contiguous zones within WA
- Each Zone will establish a collaborative of local representatives across communities and sectors
- Zone collaboratives will identify their key health priorities and develop a project plan
- DOH will support efforts to securing funding
- Public health data including community storytelling will be utilized:
 - To support the Committee Advisory Council Zone selection process
 - To illustrate health inequities and create storytelling strategies that raise awareness

Initial Timeline

- Winter 2021: Hire staff and establish Community **Advisory Council**
- Spring 2022: Develop zone criteria
- Summer 2022: Zones identified
- Fall 2022: Begin support of zones
- December 2023: Report due to legislature on projects implemented and health disparities addressed

HEZ Community Advisory Council Outcomes

- Identify 2-3 geographic HEZ in Washington state using a council-approved section criteria and decision-making process.
- Develop a 1-year work plan for Health Equity Zone selection.
- Establish shared member commitments, group norms, and decision-making protocols.
- Support the gathering of broad community input and guidance to inform key decisions.

HEZ Community Advisory Council Membership

- Majority Community Representatives
 - Between 7 and 14 total members
- Sector Representatives:
 - Tribal partners,
 - Accountable Communities of Health,
 - Local Public Health Departments,
 - Governor's Interagency Council on Health Disparities,
 - Philanthropy
- External facilitator is anticipated to join in March 2022
- DOH will play a support role, not a decision-making role



HEZ Community Advisory Council Selection Timeline

Council Nomination Opens	October 25
Outreach and Information Session	November 4
Nominations Close	November 22 at Midnight
Nomination Selection Meeting	December 8 at 3:30pm
Follow-up with selected nominees	Week of December 13
First Council Meeting	January 12, 2022 at 3:30pm

Council Member Commitments and Duties

Monthly meetings through September 2022:

- Attend and fully engage in monthly meetings (2.5 hours)
- Complete pre-work and work between meetings (2 hours)
- Workgroup or stakeholder meetings (2 hours)

Compensation:

- Stipends for time and expertise up to \$280 per month
- Additional travel reimbursement will also be provided if there are in-person meetings



Council Member Selection Criteria

- Commitment to Black, Indigenous, and other people of color and historically marginalized groups
- Commitment to relationship and trust building
- Commitment to processes that center equity, racial justice, and accountability
- Interest in developing new structures and methods to address community needs
- Willingness to work through conflict and communicate preferences about difficult decisions

Continued: Council Member Selection Criteria

- Experience participating in community groups and collaborative processes
- Ability to contribute to the vision, goals and strategy of the Health Equity Zones
- Openness to using public health data and storytelling strategies to inform decisions
- Interest in exploring connections between issues of health and wellbeing in communities, to gaps in resources and inadequate systems

Council Member Selection Process

- December 8, 2021 Nomination Selection Meeting (3 hours)
 Goal: Review all information available and vote to select Council Members
- All people nominated and who nominated others will be invited to virtual meeting
- Each meeting participant will select and vote for the 7 to 14 people they feel most equitably represent Washington on the Council for Health Equity Zones

The volume of applicants may require an additional meeting

Council Member Selection Process Continued

- During the meeting, participants will discuss together:
 - Purpose and goal of Health Equity Zones
 - Purpose and goal of the Health Equity Zones Community Advisory Council
 - Council member Selection Criteria (i.e., commitment to equitable representation)
 - Aligning nominees with representation priorities
 - Review each candidate's information submitted during the nomination process

Additional Engagement Opportunities

- Early process of implementing the Health Equity Zones
- Initial statewide process with more localized efforts beginning Summer 2022
- Future opportunities to provide input on key decision points (possible examples include geographic boundaries of HEZ)
- Develop an outreach distribution list to provide updates and share community input opportunities
