OPEN SESSION

1. CALL TO ORDER AND INTRODUCTIONS – Brenda Litke, Chair

Brenda Litke called the meeting to order at 9:05 a.m.

1.1 Approval of Agenda

Brenda Litke, chair, asked if there were any additions to the meeting agenda. No additions or corrections were made. The agenda was approved as presented.

1.2 Approval of Minutes – July 30, 2021, Business Meeting

Brenda Litke, chair, asked if there were any corrections to the minutes from the July 30, 2021 board meeting. There were no corrections. The minutes were approved.

PROGRAM REPORTS – Heather Carter, Assistant Attorney General; Traci Orr, Acting Deputy Office Director and Interim Executive Director; and Kim-Boi Shadduck, Program Manager.

2. Credentialing Statistic Report

Ms. Shadduck presented the credentialing report from the last quarter, indicating that all professions are growing. The Washington Hearing Society practical exam on December 03, 2021, has three applications. A pro tem member will be proctoring for two applicants and Ms. Furry agreed to proctor for the third.

Kim-Boi Shadduck shared the following licensure statistics with the board:

- Speech Language Specialist 3,729
- Speech Language Pathology Assistant 266

3. Current Budget Report

Ms. Shadduck presented the current budget report, which indicated little variance between the estimated and actual revenue. The board should expect expense changes for staff at the next quarterly meeting due to the executive director recruitment and hiring effort.

4. Program, Rules, and Legislative Update

Ms. Shadduck shared that the International Hearing Society practical exam revisions will take effect on January 01, 2022. The Education Exam Subcommittee will conduct a special meeting to review the new exams and discuss scoring in early January.

Ms. Orr shared that the recruitment to fill the executive director position was sent to the Recruitment Office. The CR-102 for chapter 246-828 WAC will be filed so the Rules Hearing can take place at the February 4, 2022 meeting.

Ms. Carter did not have any updates from the Attorney General's Office.

IMPLEMENTATION OF ESB 5229 HEALTH EQUITY – Brenda Litke, Chair Mr. Wise summarized the bill, which aims to create model rules around health equity continuing education from the Office of Assistant Secretary. Ms. Shadduck will notify the board when given the opportunity to participate in the Rules Workshops.

The board accepted comments from the audience on issues of significance to the professions.

Mr. Giles notified the board that the FDA has released rules for over-the-counter hearing aids, and the public comment period is open for ninety days from the release of the rule.

Ms. Johnson notified the board that the WSLHA and the Washington State Academy of Audiology will be working on the SLP Audiology Compact and the Children's Hearing Aid Mandate issue for the upcoming legislative session.
