### Things You Should Know as a Military Service Member, Veteran, Eligible Spouse or Domestic Partner:

### Senate Bill (SB) 5359 (Chapter 184, Laws of 2017)

requires the Department of Health (department) to provide regular reports to the Washington State Legislature (legislature) on implementation of laws to streamline licensing processes for military service members and their spouses. **These laws are:** 

Engrossed Substitute Senate Bill (**ESSB**) 5969 (<u>Chapter 5, Laws of 2011</u>) requiring expedited licensing of military spouses; and

Engrossed Substitute Senate Bill (**ESSB**) 5307 (<u>Chapter 32, Laws of 2011</u>) requiring military training or experience to satisfy licensing requirements if substantially equivalent.

## Department of Health Legislative Reference Links:

Codified as <u>Chapter 18.340 RCW</u> Relating to Military Souses Professional Credentialing.

Codified as <u>RCW 73.04.150</u> "The regulating authorities for the department of licensing and the department of health shall file reports to the legislature biennially and the Washington state military transition council annually beginning January 1, 2018, and appear annually before the joint committee on veterans' and military affairs to provide updates on progress in their efforts to implement the requirements of Chapter <u>18.340</u> RCW, chapter 32, Laws of 2011, and chapter 351, Laws of 2011."



Military spouses or registered domestic partners occupational licensing status during displacement outside Washington state <u>Senate</u> <u>Bill (SB) 6290</u> since 2011, makes the same inactive license status available for spouses of military personnel who are deployed or transferred out of state.

While away, spouses are not required to pay annual renewal fees, and can more easily reinstate the credential when they return.



### The Department of Health is committed to:

- Identifying the various military healthcare occupations that are equivalent to Washington state professions.
- Creating a military to civilian "crosswalk" and other tools to identify equivalent professions and skill levels.
- Identifying gaps in military training that can be closed through additional courses.
- Partnering with educational institutions in order to offer programs and courses that address these gaps. Specifically, we're looking at options to address gap(s) without having professionals repeat training or experience on the civilian side that they got in the military.
