I. Executive Summary

MED-Project WA, LLC ("MED-Project") operates a Product Stewardship Plan for Covered Drugs from Households in the State of Washington, approved by the Washington State Department of Health (the "Department") on May 25, 2020 ("Approved Plan"). MED-Project is submitting this Annual Report for the period between January 1, 2020 and December 31, 2020 (the "Reporting Period") as described in Approved Plan Section X: Reporting. Per the Approved Plan, MED-Project initiated operations by November 21, 2020. This 2020 State of Washington Annual Report ("Report") focuses on MED-Project's covered activities in the Jurisdiction between when the Plan was approved on May 25, 2020, and December 31, 2020. All capitalized terms used but not otherwise defined herein shall have their respective meaning set forth in the Approved Plan.

Notifications in the Reporting Period

MED-Project submitted a number of updates during the Reporting Period. The updates included:

- The 2019 MED-Project Annual Report was submitted to the Department on July 1st, 2020.
- The MED-Project Safe Medicine Return Program Implementation Update was submitted to the Department on October 29, 2020. The update included the consultation process with the Department and local health jurisdictions, a status of all population centers projected to meet the Service Convenience Goals, and recommendations for potential supplemental services. The Department approved the Implementation Update on November 9, 2020 and requested additional information.
- Additional detail was provided in the MED-Project Safe Medicine Return Program Implementation Update, which was submitted to the Department on December 31, 2020. The Implementation Update provided additional detail on each population center that had not yet met the Service Convenience Goal.
- As described in the Approved Plan, Appendix A: Participating Covered Manufacturers, MED-Project provided the list of Covered Manufacturers participating in the Program every 30 days. MED-Project provided the list on June 15, July 15, August 15, September 15, October 15, November 15, and December 15, 2020.
- As described in the Approved Plan, Appendix D: Potential Authorized Collectors with Expressions of Interest, MED-Project provided the list of Authorized Collectors and Collection Sites participating in the Program every 30 days. MED-Project provided the list on June 15, July 15, August 15, September 15, October 15, November 15, and December 15, 2020.
- On March 1, 2021, MED-Project submitted the first MED-Project Annual Collection Report for 2020 to the Department.

2020 Operations Overview

MED-Project activated 162 Collection Sites in the Reporting Period. In addition, MED-Project distributed Mail-Back Packages to 30 Mail-Back Distribution Locations. MED-Project distributed outreach and educational materials to all participating Collection Sites. All brochures, posters, and MED-Project website pages included in this Report are representative examples from the Reporting Period.

During the Reporting Period, MED-Project began preparations for transitioning the seven jurisdictions in Washington State that currently have ordinances ("Grandfathered Jurisdictions")(Clallam, King, Kitsap, Pierce, Skagit, Snohomish, and Whatcom Counties) into the Program. The Grandfathered Jurisdictions

transition will result in the addition of approximately 390 Collection Sites and 55 Mail-Back Distribution Locations into the Program on November 21, 2021. On June 23, 2020, MED-Project met with agency representatives from the Grandfathered Jurisdictions. MED-Project reviewed the transition schedule, discussed effects of the Approved Plan on the Grandfathered Jurisdictions, and answered questions about the transition process. MED-Project also conducted meetings on September 22 and December 14, 2020. These meetings discussed:

- MED-Project activities related to COVID-19 and activities planned for the remainder of 2020 and 2021.
- An overview of MED-Project's media outreach program.
- A review of the transition timeline.
- An update on the Program.
- An overview of how Retail Pharmacies can sign up to request Mail-Back Packages for distribution to Covered Entities.

MED-Project operated throughout the COVID-19 pandemic and met all collection goals for 180 days after Plan approval. During the Reporting Period, none of the 162 activated Collection Sites had access restrictions as a result of the COVID-19 pandemic. On November 19, 2020, MED-Project distributed a notification to 522 Retail Pharmacies in the State of Washington, informing the Retail Pharmacies of the opportunity to become a Mail-Back Distribution Location. During the Reporting Period, MED-Project ran a public service announcement ("PSA") encouraging safe disposal of Covered Drugs and use of mail-back services in response to the COVID-19 pandemic.

As outlined in the Approved Plan, the goal of the Program is to provide Covered Entities with convenient, safe, and accessible methods to dispose of Covered Drugs. MED-Project anticipates a steady increase in Collection Sites through 2021, as a result of outreach and Program activities, especially if there is increased retail chain pharmacy participation in the Program.

MED-Project continues to communicate with Collection Sites to distribute outreach materials, review procedures, as needed, and improve the overall Program design.

The following sections of the Report respond to specific reporting requirements in the Approved Plan. Each section of the Report restates the corresponding Approved Plan requirement and provides the required information.

II. Covered Manufacturers Participating in the Program

- MED-Project collected 5,405.5 pounds of Covered Drugs through Collection Receptacles at Collection Sites.
- MED-Project collected 10.9 pounds of Covered Drugs through the return of 35 Mail-Back Packages.
- MED-Project collected a total of 5,416.4 pounds of Covered Drugs through all collection methods.

VI. Public Education, Outreach, and Evaluation Activities Implemented

A. Public Education Activities

MED-Project provided disposal instructions to Covered Entities for Collection Receptacle and mail-back services offered through the Approved Plan. In addition, MED-Project maintained the MED-Project website and toll-free number to provide information pertaining to MED-Project disposal options and outreach materials. The MED-Project website, toll-free number, and outreach materials, such as posters and brochures were available in English and the Specified Languages: Spanish, Chinese, Vietnamese, Russian, and Tagalog. MED-Project website information and statistics are provided in Appendices G and H, respectively.

B. Outreach Activities

MED-Project conducted the following outreach activities during the Reporting Period: provided broadcast television, radio, and digital advertising campaigns; distributed signage and brochures; and posted information to the MED-Project website. See Appendix I for examples of brochures and posters. Appendix J provides brochure and poster distribution information.

MED-Project released a public service announcement directed at residents on social media websites, digital media, and broadcast television platforms. MED-Project issued a press release on November 21, 2020, announcing the Program. It covered 22 counties across the State, generated 21 news stories, and was aired on two television stations.

The reach percentage and frequency for each media campaign is provided in the Media Outreach Summary in Appendix L.

C. Evaluation Activities

During the Reporting Period, MED-Project initiated the media campaign following initiation of the Program on November 21, 2020. Reach and frequency statistics are provided in this Report, and MED-Project will provide evaluation metrics for the media campaign in the 2021 State of Washington annual report.

VII. Packaging Recycling

Approved Plan Section X: "A description of how collected packaging was recycled to the extent feasible."

As described in the Approved Plan, while drug packaging is expected to constitute a significant amount of the waste incinerated under the Approved Plan, MED-Project has concluded that separation of inner and/or outer packaging from Covered Drugs or recycling packaging would raise three significant concerns:

- Separating and recycling drug packaging could result in the disclosure of confidential patient information appearing on prescription drug packaging.
- Separating and recycling drug packaging could increase the potential of releases and leakage of Covered Drugs.
- Separating and recycling drug packaging could increase diversion risks by adding additional steps to the collection process and because drug packaging is used in drug counterfeiting and would be a diversion target itself.

For these reasons, the Approved Plan does not provide for the separation and recycling of packaging from Covered Drugs.

VIII. Program Goals

A. Collection Amount Goals

During the Reporting Period, MED-Project met the following collection goals within 180 days of Plan approval:

- Established over 150 Collection Sites within population centers where authorized collectors are available.
- Established Collection Sites outside of population centers where an eligible potential Authorized Collector that is regularly open to the public is willing to participate in the Program. MED-Project initiated supplemental collection services in consultation with the Department, local law enforcement, local health jurisdictions, and local communities in areas where authorized collectors are not available or Collection Sites are not established.
- Initiated mail-back services through the MED-Project website and a toll-free number to all Covered Entities.

B. Public Awareness Goals

During the Reporting Period, MED-Project met the following public awareness goals within 180 days of Plan approval:

- Initiated a media campaign throughout the State for the duration of one month, during the Reporting Period. The combined State reach percentage¹ was 63% for the Reporting Period, obtained through a variety of media channels. See Appendix K; Media Outreach Summary.
- Launched the MED-Project website on August 8, 2020, providing:
 - Convenient locations webpage with an online location search for Collection Sites and Mail-Back Distribution Locations.
 - Mail-back services webpage with an online request form for Covered Entities.
 - Collection Event webpage with the dates and locations of scheduled Collection Events.
 - A Help Desk for Authorized Collectors, potential Authorized Collectors, Collection Sites, Mail-Back Distribution Locations, and Retail Pharmacies providing Mail-Back Packages to Covered Entities.
 - Downloadable and printable materials in English.
- Established a multilingual call center with teletypewriter mode available for residents.




Figure 1: Map of Collection Sites and Mail-Back Distribution Locations

Figure 2: MED-Project Website Home Page (December 2020)




Figure 3: MED-Project Website Mail-Back Page (December 2020)




Figure 4: MED-Project Website Convenient Locations Page (December 2020)




Figure 5: MED-Project Website Take-Back Events Page (December 2020)




Figure 6: MED-Project Website Safe Storage Information Page (December 2020)




Figure 7: MED-Project Website MEDinfo Page (December 2020)




Figure 8: MED-Project Website MEDfaq Page (December 2020)




Figure 10: MED-Project Website Community Feedback Questionnaire Page (December 2020)




Figure 11: MED-Project Brochure Front (English)




Figure 18: MED-Project Brochure Back (Russian)





Figure 21: MED-Project Brochure Front (Tagalog)






Figure 25: MED-Project Collection Site Poster (Spanish)
