

## Licensure Contacts by Facility Type for Health Care Personnel TB Screening

WA DOH TB Program supports the May 2019 CDC recommendations for TB screening, testing, and treatment for health care personnel. However, facilities must continue to fulfill their licensure requirements as stated in Washington Administrative Codes (WACs).

TB screening requirements are based on facility type not professional licensure. Facilities should contact their licensure as determined by their facility type for specific information and requirements.
