Total Food Dollars Redeemed WIC Farmers Market Nutrition Program – Includes dollars spent at authorized farmers markets & farm stores, and doesn't include other WIC dollars. Revenue based on growers location. Redemption period is between June 1 to October 31, 2021

FFY2021 = October 1, 2020 through September 30, 2021
