This report is based on the location of the WIC clinic where clients were seen and where the WIC checks were issued.

Total Participating Women, Infants and Children Served – The number of clients participating in WIC during FFY2021. A client is counted only once per agency in the district where they received services, even if they were in multiple categories during FFY2021. Due to factors such as client relocation during FFY2021, approximately 4.6% clients are likely counted as participating in more than one agency.

Total Food Dollars Redeemed – This includes all food purchased with WIC checks during FFY2021, including fresh fruits and vegetables. This does not include WIC Farmers Market Nutrition Program (FMNP) dollars, which is a separate grant.

Total Food Dollars for Fresh Fruits and Vegetables only – Fresh fruit and vegetable dollars are a subset of Total Food Dollars Redeemed during FFY2021. Neither include FMNP dollars.

Total Food Dollars for WIC Farmers Market Nutrition Program – Includes dollars spent at authorized farmers markets and farm stores, and does not include other WIC dollars. Revenue based on growers location. Redemption period is between June 1 to October 31, 2021.
