I told him I would not be able to fill these prescriptions and that they needed to be ERx'd in from the dr. Next day, same male voice called, impersonating the prescriber, to 'confirm' the rx's validity. I questioned him, 'You are the dr? ' He said 'Yes. The prescriptions are valid'. I let him know that we cannot accept the rxs by fax and that he will need to sent them in electronically. He hung up.

The Rx was printed on temper paper and states that prescriber was excempt from EPCS mandate under RCW 69.50.312. If you receive a written Rx from a new patient, you should verify each time.
