Open Session:

1. Opening of Public Meeting – Kenneth Pimpleton, Chair

- 1.1. Call to Order Mr. Pimpleton called the meeting to order at 9:04 a.m. Committee and agency staff members as well as public attendees introduced themselves and their area of practice.
- 1.2. Agenda Motion to approve, seconded, vote 6-0.
- 1.3. Regular Meeting Minutes from May 7, 2021 Motion to approve, seconded, vote 6-0.
- 1.4. Special Meeting Minutes from August 25, 2021 Motion to approve, seconded, vote 6-0.

2. Management Report – Ted Dale, Program Manager

- 2.1. <u>Budget Report</u> Mr. Dale briefed the committee on the budget for the SUDP program. He noted that there were still being adjustments made to the budget and the current report presented to the committee contained some errors, including the beginning balance. The program continues to run a negative fund balance (approximately -\$750,00), but there has been steady improvement in that number.
- 2.2. <u>Credentialing Report</u> Mr. Yi briefed the committee on the credentialing statistics as of October 2022. For the SUDP certification, there are 2,944 active licenses and 275 pending applications. For the SUDPT certification, there are 1,606 active licenses and 91 pending applications.
- 2.3. <u>Legislative Briefings</u> Mr. Dale asked for at least two volunteers to attend weekly briefings during the 2022 legislative session and report back to the committee. Theresa Adkison, Lisa Rudduck, Susan Cherry, Raymond Gregson, and Ken Pimpleton will attend.

3. Assistant Attorney General Report – Chris Gerard, AAG

3.1. Mr. Gerard briefed the new members on the AAG's advisory role on the committee.

4. SUDP Apprenticeship Program – Ashley Bell, Behavioral Health Programs Coordinator

4.1. Ms. Bell provided an update to the committee on the status of the implementation of EHB 1311 as well as the advisory committee's role in reviewing apprenticeship applications.

5. Legislative and Rule Updates – Ted Dale, Program Manager

The committee was briefed on the status of the implementation of bills passed in the 2021 legislative session.

- 5.1. <u>HB 1063</u> Additional renewals for SUDPTs Rulemaking was expedited and <u>filed</u> with the Office of the Code Reviser on June 22, 2021.
- 5.2. ESSB 5229 Health equity continuing education Ms. Bell briefed the committee on the implementation of the bill, including upcoming listen sessions in 2022 with the public.
- 5.3. <u>DOH rules for national certification portability</u> In the interest in providing more portability, the department is going to open <u>WAC 246-811-070</u> and remove the language

- "Verification of the additional forty-five quarter or thirty semester credits as required in WAC <u>246-811-030(1)</u> will be required upon application to the department.".
- 5.4. Future rulemaking for peer counselors and other potential apprenticeship programs Mr. Dale briefed the committee on possible bills being introduced in the 2022 legislative session, including credentials for peer counselors and behavior health technicians.

6. Public Comment - Kenneth Pimpleton, Chair

6.1. A question was received from Dr. Marcia Roi at WACASE regarding the possibility of offering a co-occurring specialist at the bachelor's level. Mr. Dale referred all of those who are interested to read the <u>sunrise review</u> that was submitted to the legislature in December 2019. Dr. Roi also inquired about how to request a change to <u>Chapter 246-811 WAC</u> and she was advised to submit a rules petition to the department.
