Tshuaj Novavax tiv thaiV kab mob yog dab tsi?

Tshuaj tiv thaiV kab mob COVID-19 nyuam qhuav tsim tshiab uas tau txais kev tso cai los ntawm Food and Drug Administration (FDA, Koom Haum Tswj Hwm Khoom Noj thiab Tshuaj), xws li Novavax, yog hom tshuaj txawv lwm cov tshuaj tiv thaiV kab mob COVID-19 uas muaj nyob rau hauv teb chaws Meskas niaj hnuv no. Novavax yog hom tshuaj ces tshiab tiv thaiV kab mob siv protein uas siv tib hom tev naus laus zis los tsim thiab siv tau ntev zoo ib yam li lwm cov tshuaj tiv thaiV kab mob nyiam siv xws li tshuaj tiv thaiV HPV (kab mob vais lav sib kis los ntawm kev sib deev), kab mob siab B, thiab kab mob npaws loj. Novavax yog xuv tshuaj uas yuav tau txhaj 2 koob siv sij hawm sib nrug 21 hnuv, uas muaj siv rau cov neeg muaj hnuv nyoo 12 xyoo nce.

Novavax yog hom tshuaj ces tshiab tiv thaiV kab mob siv protein ib txwm siv.

Yog thaum txhua cov tshuaj tiv thaiV kab mob uas tau txais kev tso cai siv twb pab tau peb qhov kev tsim kev tiv thaiV kab mob hauv nrog cev kom tuav tau thiab tawm tsam tau kab mob vais lav COVID-19, Novavax los yeej siv tib hom tev naus laus zis qub thiab swm dua coj los tsim yam tshuaj tiv thaiV kab mob no.



- Cov tshuaj ces tshiab tiv thaiV kab mob COVID-19 uas siv protein muab tus vais lav uas ua rau mob COVID-19 siv xyaw.
- Cov tshuaj no tseem muaj kuab tshuaj txhab ntxiv nrog rau cov roj thiab piam thaj los ua kom pab tau qhov kev tsim kev tiv thaiV kab mob hauv nrog cev tiv thaiV tau tus kab mob vais lav thiab tiv thaiV tau koj rau yav tom ntej.
- Cov tshuaj no tsis muaj mRNA

Cov mob cuam tshuaj nyob rau hauv Novavax muaj tsawg heev.

Cov mob cuam tshuam ua rau mob hnuv puav ntawm Novavax nws tsis txawv li lwm cov mob cuam tshuam keev muaj nyob rau lwm cov tshuaj tiv thaiV kab mob COVID-19. Mob/vos me-me, liab thiab o nyob rau ntawm qhov chaw txhaj tshuaj, thiab yuav ua rau nkees, mob leeg, mob taub hau, mob pob qij txha, xeev siab/ntuav, thiab ua npaws. Cov tshuaj ces tshiab tiv thaiV kab mob COVID-19 uas siv protein tsis tuaj yeem ua rau muab kab mob COVID-19 thiab lwm yam mob nkeeg.

Cov ntaub ntawv teev qhia tau li cas?

Tau qhib kev kawm paub los ntawm kev sim kho mob nyob rau thaum lub caij nplooj ntoo hlav xyoo 2021 paub tau tias tshuaj Novavax tiv thaiV kab mob siv los cheem tiv thaiV kev kis kab mob COVID-19 tau zoo txog 90% thiab siv tau zoo txog 100% rau kev tiv thaiV kev ploj tuag uas cuam tshuam rau kab mob COVID-19.

Yam tshuaj no qhia tau tias tsim tau kev tiv thaiV kab mob hauv nrog cev zoo heev los mus tiv thaiV txhua ces kab mob COVID-19 tau, suav nrog rau BA.5, raws li cov kev sim kho mob uas sam sim ua. Cov tshuaj tiv thaiV kab mob ces tshiab xws li Novavax tsis siv hom kab mob vais lav ciaj sia twg xyaw thiab tsis tuaj yeem hloov pauv los sis tsim kev puas lwm yam rau peb cov roj tsim nrog cev. Peb kuj tseem kawm paub tau tias Novavax:



- Muab los siv tau zoo nyob rau ntau lub teb chaws, suav nrog rau teb chaws Canada, suav txij 2021 los.
- Tsis muaj cov kuab tshuaj tov uas siv nyob rau lwm hom tshuaj tiv thaiV kab mob uas ua rau muaj kev txhaum fab rau lub cev
- Siv tib hom tev naus laus zis uas siv tsim cov tshuaj tiv thaiV kab mob uas muaj koob nrov npe xws li tshuaj tiv thaiV kab mob npaws loj, HPV, kab mob siab B, thiab kab mob sawv hlwv

Novavax tau hla kev ua ntaub ntawv rau FDA Emergency Use Authorization (EUA, Kev Tso Cai Siv Thaum Muaj Mob Nyhav los ntawm FDA) lawm thiab yog yam tshuaj siv tau, tshwj xeeb yog rau cov neeg sam sim nrhiav xaiv [cov tshuaj tiv thaiV kab mob uas yog mRNA](#).

Nyob rau yav tom ntej, kev siv tshuaj ntxiv yuav raug pom zoo rau lwm pawg neeg.

Kev txhaj tshuaj tiv thaiV kab mob tseem yog qhov kev xaiv uas zoo tshaj plaws.

Thaum tseem muaj kab mob COVID-19, tseem yuav muaj hau kev nrhiav tshuaj tiv thaiV kab mob ntxiv. Tseem ceeb uas yuav tau nco ntsoov tias kev txhaj tshuaj tiv thaiV kab mob yog yam zoo tshaj plaws. Tsis haus ces tshuaj tiv thaiV kab mob twg, kev txhaj tshuaj tiv thaiV kab mob yog qhov kev tiv thaiV kab mob COVID-19 thiab nws cov kev cuam tshuam yog qhov zoo tshaj plaws. Nrog koj tus kws pab kho mob tham seb txoj hau kev xaiv twg yog txoj zoo tshaj plaws rau koj.
