- Community-based organizations are often better-positioned to identify and address barriers at the community level than state agencies

CRITERIA FOR PARTICIPATION

If you meet the following criteria, you are welcome to apply:

- Hold deep relationships within communities experiencing disproportionate impact of environmental pollution, including but not limited to:
 - Communities in areas of high environmental pollutant exposure
 - Unhoused communities
 - Low-income communities
 - Communities of color
 - Communities on Tribal land
 - Immigrant and refugee communities
 - Communities with a high rate of limited English proficiency
- 2. Understand environmental justice issues faced by communities in Washington state
- Have demonstrated experience and commitment to equitable and anti-racist community engagement

CONFLICT OF INTEREST

You may not apply if:

- 1. You are an employee or representative of an organization that is considering applying for the grant
- You are an employee or representative of an organization that may wish to access sub-grants from the Environmental Justice Community Participation Fund
- 3. You or a direct family member may financially benefit from these grant funds in another way

If you are unsure if these apply to you, please contact DOH staff to discuss. What is important to answer is can you be fair in the decision-making process?

It is okay if you don't know the answers to this right now. There will be other opportunities to identify potential conflict of interest.

COMPENSATION

- Each Community Advisory Committee member will receive \$1000 in VISA gift cards
 - Estimated time commitment: 20-22 hours between September-December
 - Compensation rate: \$45/hour
- To receive compensation, you will need to fill out a 1099 tax form
 - This requires an address and social security number
 - This is considered taxable income and may impact access to income-dependent services like TANF or SNAP
