---

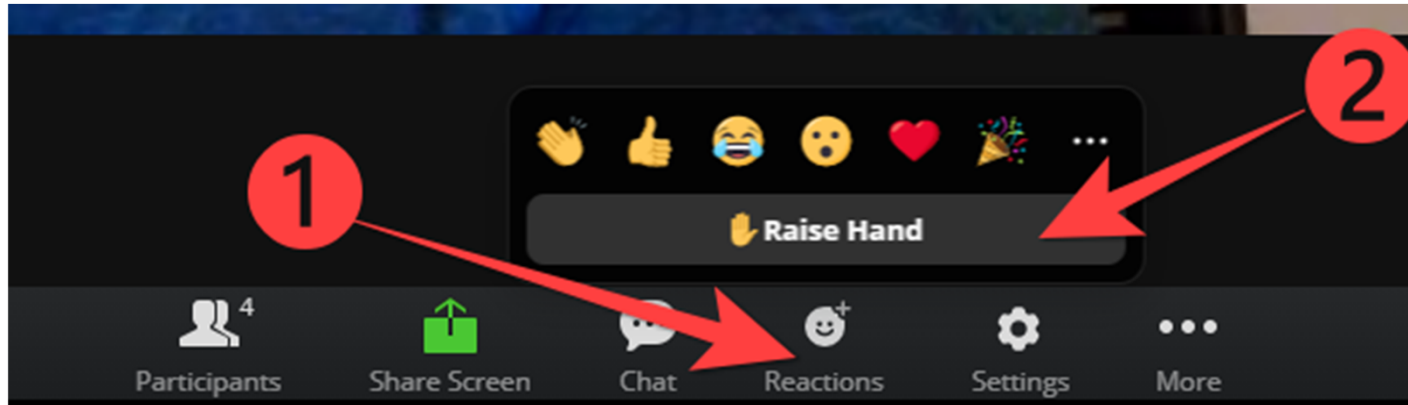

# Health Equity

---

## **What is Health Equity?**

For the Department of Health, health equity exists when all people can attain their full health potential. That means people are not disadvantaged from achieving this potential because of the color of their skin, ancestry, level of education, gender identity, sexual orientation, age, religion, socioeconomic status, the job they have, the neighborhood they live in, or whether they have a disability.

# Health Equity

---

## **Why do we need Health Equity?**

Equity and equality are not the same. Equality gives everyone the same resources. Equity gives people the resources they need. With equity, everyone has the same opportunities as others. Research shows that inequities are part of the health care system. These have always existed. The COVID-19 pandemic has highlighted the different affects that people experience. This is because of discrimination and bias in the health care system. Access to health services and health care allows all families to enjoy productive and satisfying lives. Healthier Washingtonians lead to healthier, happier families and communities.

# What does the Department seek?

- More equitable rules wherever possible
- Less complexity to processes and rules where possible
- Rules that support patient interests
- Rules that could be adaptive to new treatment modalities of the future
