1.1 The agenda was approved as submitted.

2. IMPACT OF GOVERNOR INSLEE’S PLANNED ACTIONS ON COMMISSION COVID-19 POLICIES AND GUIDANCE

2.1 Governor Inslee has announced that all remaining COVID-19 emergency proclamations and the related state of emergency will end by October 31, 2022.

In light of the planned actions of the Governor, the Commission discussed revising the following Commission temporary COVID-19 policies and guidance documents:

Mr. Gerard shared the intent of the proposed changes to the documents is to prevent the documents from expiring. The Commission can then revisit them at the next Commission Meeting.

The Commission motioned to remove the Commission COVID-19 Guidance document on October 31st and tie the removal to a message that the masking order remains in place. All commission members approved. No members opposed or abstained.

The Commission motioned to adopt the language as presented in the Temporary Commission Policy Statement on COVID-19 and Continuing Education Requirements for Chiropractors. All commission members approved. No members opposed or abstained.

The Commission motioned to adopt the guidance statement for Chiropractic X-ray Technician's and Classroom hours as amended. All commission members approved. No members opposed or abstained.
