

I. Executive Summary

MED-Project WA, LLC ("MED-Project") operates a Product Stewardship Plan for Covered Drugs from Households in the State of Washington, approved by the Washington State Department of Health (the "Department") on May 25, 2020 ("Approved Plan"). MED-Project is submitting this 2021 State of Washington Annual Report ("Report") for the period between January 1, 2021, and December 31, 2021 (the "Reporting Period") as described in Approved Plan Section X: Reporting. All capitalized terms used but not otherwise defined herein shall have their respective meaning set forth in the Approved Plan.

Notifications during the Reporting Period

MED-Project submitted a number of updates during the Reporting Period. The updates included:

- MED-Project submitted monthly Authorized and Participating Collector reports during the Reporting Period.
- On March 1, 2021, MED-Project submitted the first MED-Project Annual Collection Report for 2020 to the Department.
- On March 28, 2021, MED-Project submitted a non-substantive change notification to the Department, informing the Department of a change to Vendor contact information.
- On July 1, 2021, MED-Project submitted the Information Request Report, providing additional information requested by the Department in correspondence on September 22, 2020, and November 9, 2020.
- On December 13, 2021, MED-Project submitted a non-substantive change notification to the Department, informing the Department of changes to Vendor names and contact information.

2021 Operations Overview

MED-Project operated 600 Collection Sites in the State during the Reporting Period. Of those 600 Collections Sites, 123 sites were newly installed in 2021. In addition, MED-Project distributed Mail-Back Packages to 125 Mail-Back Distribution Locations during the Reporting Period. Of those 125 Mail-Back Distribution Locations, 41 Mail-Back Distribution Locations were activated during the Reporting Period.

MED-Project distributed outreach and educational materials to select Collection Sites and Mail-Back Distribution Locations. All promotional material included in this Report are representative examples from the Reporting Period.

MED-Project operated throughout the COVID-19 pandemic and during the Reporting Period, none of the Collection Sites or Mail-Back Distribution Locations had access restrictions as a result of the COVID-19 pandemic. Seven Collection Sites that transitioned into the Program from counties that had local ordinances, including Clallam,

King, Kitsap, Pierce, Skagit, Snohomish, and Whatcom Counties, (the "Grandfathered Jurisdictions") were restricted due to the COVID-19 pandemic during the Reporting Period. For details on COVID-19 pandemic-restricted site access statuses during the Reporting Period, see Appendix J, Table 8: Reporting Period Access Restrictions. During the Reporting Period, MED-Project ran a public service announcement ("PSA") encouraging safe disposal of Covered Drugs and use of mail-back services in response to the COVID-19 pandemic.

As outlined in the Approved Plan, the goal of the Program is to provide Covered Entities with convenient, safe, and accessible methods to dispose of Covered Drugs. MED-Project anticipates an increase in Collection Sites through 2022, as a result of outreach and Program activities, especially if there is increased retail chain pharmacy participation in the Program.

MED-Project continues to communicate with select Collection Sites to distribute outreach materials, review procedures, as needed, and improve the overall Program design.

The following sections of the Report respond to specific reporting requirements in the Approved Plan. Each section of the Report restates the corresponding Approved Plan requirement and provides the required information.

Unification of the Grandfathered Jurisdictions

In 2021, MED-Project transitioned seven Grandfathered Jurisdictions in Washington State into the Program. This transition resulted in the addition of 394 Collection Sites and 57 Mail-Back Distribution Locations into the Program on November 21, 2021. During the Reporting Period, MED-Project met quarterly with the Department and representatives for the Grandfathered Jurisdictions to transition Grandfathered Jurisdictions into the Program. MED-Project continued to provide Program services to the Grandfathered Jurisdiction in advance of the November 21, 2021, deadline. These Program services included:

- Continued operation of existing Collection Sites, Mail-Back Distribution Locations, website and call center, and media outreach and education.
- Expansion of the Collection Site network through the addition of a chain pharmacy into the Program.
- Distribution of Mail-Back Packages to participating Retail Pharmacies.
- Unification of the video and radio PSAs.
- Unification of the Grandfathered Jurisdiction websites into the State's MED-Project website and call center.

II. Covered Manufacturers Participating in the Program

MED-Project reports the collection amounts for the Reporting Period across Washington State for each of the collection methods as follows:

- MED-Project collected 158,897.2 pounds from collection receptacles.
- MED-Project collected 2,878.1 pounds through the return of 6,858 Mail-Back Packages.
- MED-Project collected a total of 161,775.3 pounds through all collection methods.

There were no safety or security problems during collection, transportation, or disposal of Covered Drugs during the Reporting Period, except for those described in Appendix F.

VI. Public Education, Outreach, and Evaluation Activities Implemented

Approved Plan Section X: "A description of the public education, outreach, and evaluation activities implemented. MED-Project will provide all promotional and education materials developed for the Program with each annual report."

A. Public Education Activities

MED-Project provided disposal instructions to Covered Entities for Collection Receptacles and mail-back services offered through the Approved Plan. In addition, MED-Project maintained the MED-Project website and toll-free number to provide information pertaining to MED-Project disposal options and outreach materials. The MED-Project website, toll-free number, and promotional materials, such as posters and brochures were available in English and the Specified Languages: Spanish, Chinese, Vietnamese, Russian, and Tagalog. MED-Project also provided the MED-Project website, toll-free number, and outreach materials in Korean, Khmer, and Punjabi as part of the unification of the Grandfathered Jurisdictions into the Program. All promotional materials, such as posters and brochures, that were developed for the Program are provided in Appendix G.

B. Outreach Activities

MED-Project conducted the following outreach activities during the Reporting Period: provided broadcast television, radio, and digital advertising campaigns; posted to social media platforms; sent out email blasts; distributed promotional materials; and posted information to the MED-Project website. The reach percentage, frequency, and target rating points for each media campaign is provided in the Media Outreach Summary in Appendix H.

C. Evaluation Activities

Reach, frequency, and target rating point statistics for evaluation of broadcast television, radio, and digital advertising campaigns are provided in Appendix H of this Report. During the reporting period MED-Project made available a customer feedback page on the MED-Project website. Community Feedback for the Program is gathered

via webform on MED-Project.org website for residents, health-care providers, law enforcement officers and regulators.

In 2021, All respondents to the community feedback form identified as residents. Of the feedback received:

- 93% of respondents indicated that they had heard, read, or seen something in the past year about the opportunity for residents to safely dispose of their unwanted medicine.
- 54% of those respondents heard of MED-Project through television, print or social media advertising.
- 31% of those respondents have used drop off locations or mail-back services in the past year to dispose of their medicines.
- All respondents who used drop off locations or mail-back services indicated the program was easy to use, easy to locate, and easy to access.

VII. Packaging Recycling

Approved Plan Section X: "A description of how collected packaging was recycled to the extent feasible."

As described in the Approved Plan, while drug packaging is expected to constitute a significant amount of the waste incinerated under the Approved Plan, MED-Project has concluded that separation of inner and/or outer packaging from Covered Drugs or recycling packaging would raise three significant concerns:

- Separating and recycling drug packaging could result in the disclosure of confidential patient information appearing on prescription drug packaging.
- Separating and recycling drug packaging could increase the potential of releases and leakage of Covered Drugs.
- Separating and recycling drug packaging could increase diversion risks by adding additional steps to the collection process and because drug packaging is used in drug counterfeiting and would be a diversion target itself.

For these reasons, the Approved Plan does not provide for the separation and recycling of packaging from Covered Drugs.

VIII. Program Goals

A. Collection Amount Goals

During the Reporting Period, MED-Project performed against the following collection amount goals within 12 months of Plan approval:

- Established over 40 additional Collection Sites for a total of 190 Collection Sites.




Figure 1: Map of Existing and New Collection Sites During the Reporting Period

 Figure 1 provides a visual representation of how MED-Project met this collection goal.
- Continued to provide supplemental collection services in consultation with the Department, local law enforcement, local health jurisdictions, and local communities in areas where Authorized Collectors are not available or Collection Sites are not established.
- MED-Project collected 10,936.2 pounds toward the collection goal of 22,500 pounds from Collection Sites between six and 12 months after Plan Approval.
 This excludes the amount collected in the Grandfathered Jurisdictions during the same time period.

During the Reporting Period, MED-Project performed against the following collection amount goals within 18 months of Plan approval:

- Incorporated Grandfathered Jurisdictions into the Program for a total of 600
 Collection Sites in the Program by the end of the Reporting Period.
 - MED-Project incorporated 394 Collection Sites from Grandfathered Jurisdictions.
 - MED-Project incorporated 57 Mail-Back Distribution Locations from Grandfathered Jurisdictions.
- MED-Project collected 21,734.5 toward the collection goal of 28,500 pounds from Collection Sites between 12 and 18 months after Plan approval. This excludes the amount collected in the Grandfathered Jurisdictions during the same time period. Based on the trend between the two goal periods, MED-Project expects to meet these collection goals in 2022.

B. Public Awareness Goals

During the Reporting Period, MED-Project met the following public awareness goals within 12 months of Plan approval:

- Sustain continued outreach campaigns throughout the State for the duration of one month at least three times per calendar year, designed to be viewed by 50% of State residents using the following media channels:
 - TV broadcast
 - Radio broadcast
 - o Print media
 - Digital media

 Translate the MED-Project website into the Specified Languages (Spanish, Chinese, Vietnamese, Russian, and Tagalog).

During the Reporting Period, MED-Project met the following public awareness goals within 18 months of Plan approval:

- Sustain continued outreach campaigns throughout the State for the duration of one month at least three times per calendar year, designed to be viewed by 50% of State residents using the following media channels:
 - TV broadcast
 - o Radio broadcast
 - o Print media
 - o Digital media

The Authorized Collector staff discovered the event the morning of January 25, 2021, when they arrived at the store to open the pharmacy. The Authorized Collector staff were not able to determine if any contents were removed from the Covered Drugs box and liner. The box and liner were sealed by the Authorized Collector staff and shipped for destruction the next day.

Corrective Action Taken: MED-Project notified the Authorized Collector of potential reporting obligations under the DEA regulations. MED-Project performed a root cause analysis and identified corrective and preventative actions to: (1) develop and implement recommendations to improve the Authorized Collector guidance for reporting events to the police and DEA; (2) enhance pre-installation verification of monitoring systems such as surveillance cameras and quarterly inspection of surveillance system status; and (3) review of the incident with the collection receptacle manufacturer.




Figure 2: MED-Project Brochure Front (English)




Figure 9: MED-Project Brochure Back (Russian)




Figure 13: MED-Project Brochure Back (Tagalog)




Figure 18: MED-Project Brochure Front (Punjabi)






Figure 23: MED-Project Mail-Back Poster (Spanish)






Figure 31: MED-Project Mail-Back Poster (Tagalog)
