




English Interpreter

Group Norms

- Be accountable for your impact (vs. your intention)
- Move up, move back
- Notice your own defensive reactions and attempt to use these reactions as entry points for gaining deeper self-knowledge, rather than as a rationale for closing off.
- Recognize how your own social positionality (e.g., race, class, gender, sexuality, ability) informs your perspectives and reactions to your colleagues and facilitators
- Acknowledge power differences between DOH employees and group participants.
- Accept and expect non-closure
- Ask about access needs

Work Overview

Workgroup goals/objectives to work on together

- 1) Create data infographics that reflect the Latinx/Latino community that are simple to understand to share with community members
 - Using WA DOH Dashboard for easily sharing or demonstrating to Latinx/Latino community what is currently happening with COVID-19 cases, vaccines, boosters etc.

 - For example: podcast and







The Latinx 5-11 age group









Rates of COVID-19 Deaths by Vaccination Status in Ages 5+ Years

(Data from June 2022, people ages 5+, as compared to people vaccinated with at least a primary series)






Unvaccinated people aged 5 years and older are 2.8 times more at risk of Testing Positive for COVID-19






Since the start of the pandemic Latinx have almost always had the highest COVID-19 case rates of any race ethnicity in Washington




June 25, 2022 COVID-19 case rates by race ethnicity in Washington
