II. WA Portal overview – Fathiya Abdi

- Link to the Latinx Partner Space
- WA Portal is a virtual engagement platform that can be used to connect with one another, access meeting materials and notes, and find resources from DOH and other partners.
- o If you are new to WA Portal, you should have received an email from Sydney Boothe with instructions on how to access the Latinx Partner Space for the first time. If you already have a WA Portal account, you can use your current login to access it.
- Once you log in, under "My Portal" you can find "My Teams" on the right sidebar, which should show the Community Collaborative Latinx Partner Space.
- Partners have expressed difficulty with receiving the materials via email, so instead you can access everything in the <u>Meeting Materials folder</u>. This includes meeting minutes and any slides that were shared in the partner space.
- Q: Who has access to the WA Portal teams? A: Only those who have expressed interest and participate in the LatinX workgroup.
- Partners would like any instructional pdfs for WA Portal that are available to be shared to the group.
- DOH can coordinate a TA/office hour session to learn more about WA Portal & navigation.

III. Updates from the group

- Latino Center for Health will be launching a project that focuses on storytelling about members of different Latino communities in Washington state. It will launch on the <u>Mexican Consulate Facebook page</u>.
- Latino Northwest Communications will be launching a bilingual video hub that will teach organizations how they can launch campaigns to serve the Latino community in different ways. The first wave of videos will be COVIDfocused but will shift to other topics.
- A partner expressed surprise about vaccine hesitancy in the Latinx community when there are such big gatherings at soccer fields. People have not had the chance to learn about the vaccine or even about the virus.
 - The <u>Care-A-Van</u> may be a potential option to bring vaccines to community gatherings and share COVID-19 resources

IV. COVID-19 School-Based Programs and Resources – Bella Mendez

- o How might we continue to reach out to youth and families?
- Only 43.5% of Hispanic Washington residents have received their COVID-19 booster shot. While older adults have a high rate of vaccination and having a booster, younger adults (such as the 18-34) also have low rates of those with a booster shot (43.1%).
- o There are new COVID-19 webpages from DOH that include information on getting a COVID-19 vaccine, safety and effectiveness, vaccine requirements, school and childcare, life after the vaccine, and vaccine booster and additional doses. The pages also include links to other inlanguage resources. We will review and update the webpages regularly. The pages are easy to navigate and include visual tiles for different topics. Spanish is still available at VacunaDeCovidWA.org.

- There are also new print materials for parents/youth and general COVID-19 materials that are available in English and Spanish and many of them are available in additional languages.
- Links to DOH Vaccine Facts pages, which address common questions, myths, and facts about the COVID-19 vaccine in text and video format:

- Social media continues to be a key way to disseminate health information and materials are posted in both English and Spanish on their respective DOH Facebook pages.

- O Q: Does the Care-A-Van have vaccine providers that speak Spanish?
 - In the <u>Care-A-Van request form</u>, you can list the type of resources you would like to have the event including primary language spoken
- Q: Is there a simplified version of the <u>COVID dashboard</u> for people who are not familiar with how to navigate and/or interpret the graphs and information?
 - The DOH COVID-19 Vaccine Planning and Response team is currently working on community specific impacts of COVID based on the COVID-19 data dashboard such as vaccination uptake. We can invite them to a future session to share impacts on LatinX population.
 - We may be able to have a graphic that is updated monthly that presents this data in an accessible way, but we need to check if DOH has the capacity for this.

V. What resources or information are missing?

- Fall would be a good time to re-launch COVID-19 resources or messaging we create. We can use the summer to create awareness before the cold weather in the fall comes.
- There is a definite need for resources in various Indigenous languages.
- o Resource ideas:
 - A podcast with partners, at least in Spanish but possibly in Indigenous languages.
 - A directory of interpreters that can translate material into different Indigenous languages who would keep cultural appropriateness in mind when translating.
 - Resources targeted at youth (such as TikTok). They are the cultural brokers for their families.
 - Highlighting that youth do have the ability to consent to vaccination. Some youth want to get vaccinated but are unhoused and do not have a parent to give consent for that

- vaccination. However, this topic needs to be approached with cultural sensitivity and nuance.
- Tomas Madrigal, DOH Equity & Social Strategist working on creating a workspace for community partners who serve our Indigenous communities. We will invite him to our next meeting to share current efforts.
