1. CALL TO ORDER

The open session of the business meeting was called to order at 10:42 a.m. by Lisa vanHaagen, Chair.

- 1.1 Introductions of committee members and staff.
 - The committee members, staff, and audience were introduced.
- 1.2 Public Comment The public will have an opportunity to provide comments. If you would like to comment during this time, please limit your comments to two minutes. Please identify yourself and who you represent, if applicable, when the Chair opens the floor for public comment.

• Ms. Emerick, Policy Director for the Washington Acupuncture and Eastern Medicine Association (WAEMA), shared the benefit under Medicaid for Acupuncture is on hold due to next year's budget cuts.

1.3 Approval of Agenda

- Ms. Barcena requested to amend the agenda to include item 8.2 Washington State Acupuncture and Eastern Medicine Association (WAEMA) rule petition.
- A motion was made to approve the November 18, 2024 agenda with requested amendments.
- The motion was seconded, and the committee unanimously approved the November 18, 2024 agenda as amended.
- 1.4 Approval of Meeting Minutes from July 26, 2024
 - The committee discussed including the discussion of ultrasound to the minutes.
 - Ms. Crawford suggested including the topic as an agenda item at the next meeting.
 - A motion was made to approve the July 26, 2024 minutes.
 - The motion was seconded, and the committee unanimously approved the July 26, 2024 minutes.
- **2. COMMITTEE RECRUITMENT UPDATE** staff provided a committee member update.
 - Ms. Barcena shared the committee has been recruiting for a public member.
 - The Secretary has appointed Phillip Padelford and he has accepted the position.
- **3. ELECTION OF OFFICERS** the committee nominated and elected chair and vice-chair for the 2025 calendar year.
 - Lisa vanHaagen was nominated and unanimously elected as Chair for the 2025 calendar year.
 - Kristine McGinley was nominated and unanimously elected as Vice-Chair for the 2025 calendar year.

- **5. LEGISLATIVE MEET-ME-CALL PARTICIPANT** The committee determined and voted on who will be the legislative liaison and meet me call participant for the 2025 legislative session.
 - The committee delegated Christina Jackson as the 2025 legislative liaison with Lisa vanHaagen as secondary.
 - The committee delegated Kristine McGinley as the 2025 meet me call participant with Lisa vanHaagen as secondary.
- 6. NATIONAL CERTIFICATION COMMISSION FOR ACUPUNCTURE AND ORIENTAL MEDICINE (NCCAOM) MONTHLY UPDATES the committee received updates from meetings that occurred July-October by Ms. McGinley.
 - Ms. McGinley outlined the main points discussed during the NCCAOM monthly meetings she attended.
 - Ms. McGinley was unable to attend the September 18, 2024 meeting. She requested the recording from NCCAOM and will share with the committee once received.
 - Ms. McGinley shared the October 24, 2024 meeting included a discussion with the national leaders of the AHM Coalition. The topics included advancing Chinese medicine in the United States and integrating acupuncture into the American healthcare system.
 - Ms. McGinley reviewed the October 30, 2024 meeting which gave detailed information on Medicare and Medicaid acupuncture coverage.
 - The committee discussed US House Bill H.R. 3133 and the differences in insurance coverage of acupuncture procedures and practitioners.
 - Ms. Sherman commented that several local Medicare plans are dropping acupuncture coverage in the next year.
- 7. UPDATE ON DRY NEEDLING/INTRAMUSCULAR THERAPY FOR PHYSICAL THERAPISTS IN WASHINGTON STATE the committee received an update from Ms. vanHaagen.
 - Ms. vanHaagen shared the information provided by the Board of Physical Therapy on the intramuscular needling endorsement process.
 - As of November 14, 2024, a total of 72 intramuscular needling endorsements have been issued.
 - Three acupuncture and eastern medicine practitioners are supervising the physical therapists for the clinical review hours.
 - Ms. vanHaagen shared the physical therapist intramuscular needling endorsement application packet, current fees, and intramuscular needling informed consent form.
 - The committee discussed the complaint and discipline process of a physical therapist engaged in unlicensed practice of acupuncture.

- **8. RULE PETITION** the committee reviewed and discussed the rules petition.
 - 8.1 Occupational English Test (OET) request to accept exam as an option for English verification for applicants who have taken required NCCAOM examinations in other languages.
 - Ms. Barcena explained ibTOEFL is the only exam currently accepted and referred to WAC 246-803-240.
 - The committee discusses the differences in the ibTOEFL and OET exams.
 - A motion was made to open rules to explore inclusion of the OET as an accepted exam.
 - The motion was moved, seconded and unanimously passed.
 - 8.2 Washington State Acupuncture and Eastern Medicine Association (WAEMA)
 - Ms. Barcena shared WAEMA submitted a rules petition to clarify if oxygen can be
 used in treatment outside of emergencies and to expand scope of practice to include
 ozone treatment. The petition was received July 22, 2024 and denied due to
 limitations in statutory authority.
 - Ms. Shultz shared her appeal to the petition denial she received on September 17, 2024. She refers to RCW 18.06.010 that states oxygen can be used for patient care.
 Ms. Shultz asks for ozone to be recognized as a nutritional substance and to consider the naturopathic scope of practice 18.36A.040.
 - The committee discusses the appeal and considers providing feedback to the Secretary.
 - Ms. Knieps clarifies this committee does not have the authority to change the RCW and the legal analysis has been provided.
- **9. LICENSURE APPLICATION AND ELIGIBILITY REQUIREMENTS** the committee reviewed application and eligibility for initial licensure.
 - Ms. Barcena explained the current rules for initial licensure for approved and foreign schools do not require "active practice" like those outlined for licensees with an expired license of over three years.
 - The committee discussed and decided not to update the rules to align licensing requirements.
 - The Secretary will review unique applications on a case-by-case basis.
 - Ms. Hudakova shared her experience in obtaining an acupuncture and eastern medicine practitioner license in Washington state.
 - Ms. Crawford suggested the credentialing team needs to review Ms. Hudakova's individual application.
- **10. PROGRAM MANAGEMENT REPORT** information was provided to the committee by the program manager and executive director.

- 10.1 Interim Operating Budget Report
 - Ms. Crawford presented the budget report to the committee. The fund balance has continued to decline as expected and no rate changes are suggested at this time.

1.3 Approval of Agenda

- The motion was seconded, and the committee unanimously approved the January 27, 2025 agenda as amended.
- 1.4 Approval of July 26, 2024 revised meeting minutes

- 1.5 Approval of November 18, 2024 meeting minutes
 - Ms. McGinley requested to amend Item 5 to state the committee delegated Kristine McGinley as the 2025 meet me call participant with Lisa vanHaagen as secondary.
 - Ms. McGinley requested to amend Item 9 to clarify the Secretary will review unique applications on a case-by-case basis.
 - The November 18, 2024 meeting minutes will be reviewed at the next meeting after corrections are made.
- 2. 2025 MEETING SCHEDULE the committee received an update on the 2025 meeting locations.
 - Ms. Barcena explained there is a state budget freeze in effect and staff are not authorized to travel at this time.
 - A motion was made for 2025 physical meeting locations to be held in Tumwater, WA with an option to join virtually.
 - The motion was moved, seconded and unanimously approved.
- **3. 2025 LEGISLATIVE UPDATE** the committee received an update on legislation that may impact the profession.
 - Ms. Barcena provided an update to the committee on the legislative session that started on January 13, 2025.
 - The department will notify legislative liaisons of bill updates by email rather than weekly meetings.

- Ms. Barcena described Senate Bill 5254 regarding patient rights to access and protecting their healthcare information.
- Ms. Barcena described House Bill 1507 that proposes limiting healthcare nondisclosure agreements between healthcare providers and patients related to medical malpractice, or any tort or crime.
- Ms. Emerick shared Senate Bill 5242 proposes an interactive screening program to improve access to behavioral health might increase licensure fees.
- Ms. Emerick also shared House Bill 1034 cannot be amended to include physical treatment as a non-opioid drug treatment of pain.
- 4. NATIONAL CERTIFICATION COMMISSION FOR ACUPUNCTURE AND ORIENTAL MEDICINE (NCCAOM) MONTHLY UPDATES the committee received an update from meetings that occurred from November–January from Ms. McGinley.
 - Ms. McGinley attended the NCCAOM town hall meetings on December 4, 2024 and January 22, 2025.
 - Ms. McGinley provided the NCCAOM town hall meeting presentations for the committee's review. She provided a brief description of the topics covered including the AHM coalition, NCCAOM standards, and the current strategy for acupuncturists to become recognized as providers by Medicare.
- 5. UPDATE ON DRY NEEDLING/INTRAMUSCULAR THERAPY FOR PHYSICAL THERAPISTS IN WASHINGTON STATE the committee received an update from Ms. vanHaagen.
 - Ms. vanHaagen attended the December 9, 2024 Board of Physical Therapy meeting.
 - The Board of Physical Therapy has discontinued tracking intramuscular needling endorsement application data.
 - Ms. vanHaagen stated it would be useful for the committee to know on an annual basis how many intramuscular needling endorsements have been issued to physical therapists.
 - Ms. Barcena will reach out to the HELMS team and Board of Physical Therapy program manager for more details on what intramuscular needling endorsement data will be collected in the new licensing system.
 - Ms. Barcena will distribute the Physical Therapist Intramuscular Needling Endorsement Application Packet to the committee members to review.
- 6. 2025-2027 BUSINESS PLAN the committee voted to adopt.
 - Ms. Barcena provided the committee a copy of the 2025-2027 business plan.
 - No suggestions were made by the committee.

from foreign schools. (1) An applicant for an acupuncturist or

acupuncture and Eastern medicine practitioner license who has

graduated from a foreign acupuncture or Eastern medicine

practitioner program not accredited, or approved by the

secretary must:

- (a) Have at least a bachelor's or master's degree in

 Eastern medicine or acupuncture from an institution of higher

 learning which is approved by the foreign country's ministry of
 education/health, or other governmental entity;
- (b) Have graduated from a program of Eastern medicine or acupuncture education with requirements substantially equal to those required of graduates of secretary-approved programs; and
- (c) Demonstrate fluency in reading, speaking, and understanding the English language by taking the examinations required in WAC 246-803-240 (2)(a) through (c) in English or by successfully pass an English proficiency examination approved the secretary passage of the test of English as a foreign language in WAC 246-803-240(3).

- (2) An applicant for an acupuncturist or acupuncture and Eastern medicine practitioner license must submit to the department:
 - (a) A completed application.
 - (b) The application fee required under WAC 246-803-990.
- (c) Original copy of school transcripts from the Eastern medicine or acupuncture program showing degree and degree date.
- (d) A credentialing evaluation report from the International Consultants of Delaware (ICD).
- (e) Verification of clinical training as required in WAC 246-803-230.
- (f) Verification of successful completion of the examinations as required in WAC 246-803-240.
- (g) Verification of all acupuncturist, acupuncture and Eastern medicine practitioner or health care licenses held, submitted directly from the licensing agency. The verification shall include the license number, issue date, expiration date and whether the acupuncturist or acupuncture and Eastern medicine practitioner has been the subject of final or pending disciplinary action.

- (CPR) certification. The training in CPR shall consist of a minimum of one quarter credit or equivalent. Red Cross certification or documentation of equivalent training may be substituted for the one quarter credit.
 - (i) Any additional documents requested by the secretary.
- (3) The department recognizes the ICD for credential evaluations. The applicant shall request that the ICD send their evaluation directly to the department. To obtain a credentialing evaluation report, the applicant shall submit to the ICD:
 - (a) Transcripts;
 - (b) Appropriate fees; and

(c) Other requested documentation.

WAC 246-803-240 Examinations. (1) The examinations administered by the National Certification Commission for Acupuncture and Oriental Medicine (NCCAOM) are the official examinations for licensure as an acupuncturist or acupuncture and Eastern medicine practitioner.

- (2) An applicant for licensure as an acupuncturist or acupuncture and Eastern medicine practitioner must pass the following examinations:
 - (a) Foundations of Oriental medicine examination;
 - (b) Acupuncture with point location examination;
 - (c) Biomedicine examination; and
- (d) Council of Colleges of Acupuncture and Herbal Oriental Medicine (CCAHOM) clean needle technique course.
- (3) If the applicant takes the examinations listed in subsection (2) of this section in a language other than English, they must also successfully pass an English proficiency examination approved by the secretary. take and pass the internet-based test of English as a foreign language (ibTOEFL) examination with an overall score of not less than 89. This is done by obtaining scores on the ibTOEFL of at least:

- (a) Twenty-four on the writing section;
- (b) Twenty-six on the speaking section;
- (c) Twenty-one on the reading section; and
