This report is based on the location of the WIC clinic where participants were seen and where the WIC checks were issued. (It doesn't include incomplete and missing data. DOH did not analyze the level of incomplete or missing data. Data errors may occur when staff do not enter complete and accurate information.) TOTAL PARTICIPANTS is the number of women, infants, and children participating in WIC during FFY21. A participant is counted only once per clinic in the counties where they received services, even if they were in multiple categories. Due to factors such as participants relocation, approximately 4.6% participants are likely counted as participating in more than one county. FOOD DOLLARS REDEEMED includes all food purchased by WIC participants during FFY21 except the WIC Farmers Market Nutrition Program (FMNP) fresh fruits and vegetables, which is a separate grant. FRUITS & VEGETABLES dollars are a subset of total food dollars redeemed. Neither include FMNP dollars. WIC FMNP includes dollars spent at authorized farmers markets and farm stores, and does not include other WIC dollars. Revenue is based on grower's location. FMNP redemption period is between June 1 to October 31, 2021. For more details, contact WICDataRequests@doh.wa.gov.
