Kobalak, jōt COVID-19 teej ko rej bōk ien mour ko rej aitoklak jän U.S. Food and Drug Administration (FDA, Rā eo an Mōñā im Uno ko Rekajur), im ej lelak ñan teej ko raan in jemlak kōjerbale eo oktak jän ta eo kwōj loe ilo bōq eo. Kwōj māroñ in loe [FDA laajrak in teej eo aitoklak ien aer mour](#) (ilo Kajin Pälle im Spanish) ñan lale ewi ian teej ko emōj an oktak raan in jemlak an jerbal. Jokdoon ñe juōn teej emōj an kääł raan eo ej jemlak ilo mōkta lak, ekkar ñan DOH, kwōj māroñ in kōjerbale wōt teej eo ñe enij pāāj e kantūrol in joñan an eman.

Kwōj māroñ in loe wāwen an jerbal im kantūrol in joñan an eman alikkar eo ilo pepa in kōmelele eo. Wāwen an jerbal kantūrol in lale joñan an eman ilo eloñ teej ko ilo-mweo ej lukkun lale lain eo iturin "C" emōj an būriñ ilo cartridge in teej eo ej walak ñe jāmbōl eo ej deļoñ ie. Ñe lale kantūrol in joñan an eman enij bōjrak, kwōj aiku in jolak teej ko.

Ewi wāwen an juōn teej aitoklak ien an mour?

Ro rej kōmmāne COVID-19 teej ko rej aiku in kōmman ekatak ko ñan lale joñan an juōn teej māroñ in jerbal. FDA ej lale melele kein ñan kalikkar ñe aitoklak raan in an jemlak an jerbal. An aitoklak an mour COVID-19 tej ko ej eman ilo an laplak melele ej duōjtok kin joñan an teej kein māroñ in jerbal.

Jej tomak im kōjatdikdik ke melele kein renij jibāñ lewaj alikkar ilo am kōjerbale teej kein ekar ñan raan eo ej jemlak ilo bōq eo.
