1. Opening of Public Meeting – Kenneth Pimpleton, SUDP, Chair and Michael Fitzpatrick, LMFT, Chair

- 1.1. Call to Order The meeting was called to order at 9:02 a.m. Committee and agency staff members as well as public attendees introduced themselves and their area of practice.
- 1.2. Agenda Motion to approve the February 11, 2022 agenda as amended, seconded, vote 12-0 (Substance Use Disorder Professional Advisory Committee vote 7-0, Mental Health Counselors, Marriage & Family Counselors, and Social Workers Advisory Committee vote 5-0).
- 1.3. Minutes Motion to approve the September 10, 2021 joint meeting minutes, seconded, vote 12-0 (Substance Use Disorder Professional Advisory Committee vote 7-0, Mental Health Counselors, Marriage & Family Counselors, and Social Workers Advisory Committee vote 5-0).
- 2. Program Manager Reports Ted Dale, Program Manager and Brandon Williams, Program Manager

Mr. Dale is serving as the Program Manager for the Substance Use Disorder Professional Advisory Committee and Mr. Williams is serving as the Program Manager for the Mental Health Counselors, Marriage & Family Therapists, and Social Workers Advisory Committee.

- 2.1. Mental Health Counselors, Marriage & Family Therapists, and Social Workers Advisory Committee Budget Report – Mr. Williams presented the current budget numbers. The following is the current fund balance for the three programs:

3. ESSB 5229 Implementation – James Chaney, Executive Director

3.1. Mr. Chaney provided an overview and upcoming events regarding the implementation of ESSB 5229, which requires health care professions that are subject to continuing education requirements to adopt rules by January 1, 2024 that would require licensees to complete health equity continuing education training at least once every four years.

4. Assistant Attorney General Report – Jake Miller, AAG

4.1. Mr. Eaton, who is the assistant attorney general for the Mental Health Counselors, Marriage & Family Therapists, and Social Workers Advisory Committee was unable to attend. Mr. Miller, who serves as assistant attorney general for the Substance Use Disorder Certification Advisory Committee was representing both committees. Neither AAG had any updates.

5. Legislation Update and Discussion – Ted Dale and Brandon Williams, Program Manager

- 5.1. Proposed legislation of interest Mr. Dale and Mr. Williams provided an overview of legislation of interest for their programs
 - <u>HB 1802</u> Disability membership on committees
 - HB 1865 Peer Support Specialist likely to pass
 - <u>HB 2040</u> Cut the number of hours needed for certification of licensed counselors..
 - <u>HB 2053</u> Create a behavioral health workgroup. Did not make the cut
 - <u>SB 5491</u> Clarifying firearm rights, effects mental health professions
 - <u>SB 5596</u> Disclosure restrictions for licensed counselors moving through
 - SB 5638 Expedited approval of LC associates currently multiple versions
 - <u>SB 5884</u> Behavioral health specialist
 - <u>SB 5889</u> Mental health evaluation coverage
 - <u>SB 5894</u> Behavioral health in primary care insurance bill
 - <u>SB 5644</u> Behavioral health co-responders

- 5.2. Mr. Dale and Mr. Williams updated the committee regarding the implementation of current legislation from the 2021 session.
 - <u>SHB 1007</u> This legislation removes the limitation on distance supervision for both the Social Worker Advanced Associated license and the Social Worker Independent Clinical Associate license. This has been implemented.
 - <u>HB 1063</u> This legislation allows the Secretary of Health to grant additional renewals to Licensed Counselor Associates and SUDPTs during a declared state of emergency by the governor. Expedited rule making process was started for this bill and are just waiting the 45-day waiting period to put it into effect. Requests have already been coming in and have been approved/denied depending on the reasoning if it meets the bills requirements. This has been implemented.
 - <u>HB 1311</u> This legislation adds an apprenticeship option to meet the educational component for certification as a SUDP and SUDPT. The rules process has been started, with an upcoming hearing to collect public comments and concerns. Implementation in progress, the draft language should be filed sometime soon with the Office of the Code Reviser.
 - <u>HB 1504</u> This legislation creates a change for the agency affiliated counselor profession, that allows student interns to apply for registration if they work in an agency that hires them. The rules process is currently being done. Implementation in progress, the draft language has been filed with the Office of the Code Reviser and pending a public hearing.

6. Public Comment – Ken Pimpleton, SUDP, Chair, and Mike Fitzpatrick, LMFT, Chair

6.1. There were two comments from the public. The first was a request to centralize information regarding policy statements related to the pandemic. The second comment was an inquiry about the status regarding distance CEUs and Mr. Williams confirmed there are currently no restrictions and will be permanently changed in the WAC in the upcoming year.
