


DWSRF Program

Lead Service Line Loans

- 49 percent must go to DACs as loan principal forgiveness
- Up to 100 percent loan principal forgiveness for DAC
- Lead Service Line Inventory Loans
 - First come, first served
- Lead Service Line Replacement Loans
 - Must replace entire service line public and private sides
 - Scored

Lead Service Line Funding Percentages



Lead Service Line Loans

- Eligible Applicants:
 - Group A community systems.
 - Group A nonprofit noncommunity systems.
 - Tribal systems not receiving SRF tribal set asides.
- Ineligible Applicants:
 - Group B systems.
 - Group A noncommunity, for-profit systems.
 - Federal and state-owned systems.

Lead Service Line Inventory Loans

Eligible Inventory Projects:

- Development of the service line inventory due October 16, 2024.
 - Include wages for staffing dedicated to inventory development.
 - Intern to complete records reviews.
 - Consultant
 - Customer interviews, meter box inspections, potholing (requires cultural/historical review)
- If you need a planning document, must be included in the scope of work.

Ineligible Projects:

- Any other non-inventory work
- Service line replacement

Lead Service Line Replacement Loans

- Eligible Replacement Projects:
 - Replacement of entire lead or galvanized-needingreplacement service lines – from water main to building
 - Partial replacements if public side replaced in the past 5 years
- Ineligible Projects:
 - Main replacements
 - Non-lead or non-galvanized service line replacement
 - Meter replacements, unless meter predates 1986 and has lead components

Take Aways

- Lead Service Line funding is proportional with 49 percent allocated for disadvantaged communities.
- Funding for inventories and lead service line replacements
- Contact your regional planner about your planning document.
