I. Introduction

MED-Project WA, LLC ("MED-Project") submits this proposed Drug Take-Back Program (the "Plan") on behalf of the Covered Manufacturers identified in Plan <u>Appendix A</u> and pursuant to the Washington Drug Take-Back Program, codified as Chapter 69.48 RCW (the "Law").

The Law requires Covered Manufacturers¹ to establish and implement a Drug Take-Back Program (the "Program") that complies with the requirements of the Law independently, as part of a group of Covered Manufacturers, or through membership in a Drug Take-Back Organization. <u>Appendix B</u> contains a table that denotes how the Plan addresses each component of RCW 69.48.050.

II. Definitions

Carrier is a common or contract carrier used to transport Covered Drugs.

Collection Event means a one-day event conducted by MED-Project with oversight by law enforcement at a location accessible to the public for the collection of Covered Drugs from Covered Entities.

Collection Receptacle means a secure kiosk provided by MED-Project for the collection of Covered Drugs at a Collection Site.

DEA is the U.S. Drug Enforcement Administration.

DEA Rule is the DEA Final Rule, "Disposal of Controlled Substances," 79 Fed. Reg. 53,520 *et seq.*, adopted on September 9, 2014.

DOT is the U.S. Department of Transportation.

Help Desk is the MED-Project website, call center, and email-in database for potential authorized collection sites, Authorized Collectors, Collection Sites, and Mail-Back Distribution Locations that can be reached at the MED-Project website (med-project.org), 1-833-633-7765 (1-833-MED-PROJECT), or washington@med-project.org.

Inhaler Mail-Back Packages are pre-paid, pre-addressed mail-back packages provided by Vendor for the collection and disposal of inhalers.

Injector Mail-Back Packages are pre-paid, pre-addressed, United States Food and Drug Administration-cleared sharps container mail-back systems provided by Vendor for the collection and disposal of Pre-filled Injector Products.

Mail-Back Distribution Location means a public facility, such as a town hall or library, that offers Mail-Back Packages to Covered Entities.

Mail-Back Packages are pre-paid, pre-addressed mail-back containers, envelopes, packages, or systems provided by Vendor for the collection and disposal of Covered Drugs.

On-Demand Collection Service is a service method where Authorized Collector employees manage removal and packaging of full Collection Receptacle inner liners provided by Vendor prior to Carrier pickup.

Patients are Covered Entities of the State who are in possession of Covered Drugs.

Plan is this submittal, including as amended or supplemented.

Pre-filled Injector Products are pre-filled injector products with a retractable or otherwise securely covered needle from which Covered Drugs cannot be removed.

¹ All capitalized terms used but not otherwise defined shall derive their respective meanings from the Law.

Program is the MED-Project drug take-back program in this Plan. For a period of 12 months after the Program begins operating, MED-Project programs operating in counties enforcing a grandfathered ordinance will not be included in the Program.

Scheduled Collection Service is a service method where MED-Project provides for a Service Technician to help prepare Collection Receptacle inner liners provided by Vendor for Carrier pick-up.

Substance Use Disorder Treatment Program is defined in RCW 71.24.025.

Specified Languages are Spanish, Chinese, Vietnamese, Russian, and Tagalog.

Service Technicians are personnel, provided by Vendor, trained to help prepare inner liners for shipment and disposal.

Standard Mail-Back Packages are pre-paid, pre-addressed mail-back envelopes provided by Vendor for the collection and disposal of Covered Drugs, except for inhalers and Pre-filled Injector Products.

State means the State of Washington. For a period of 12 months after the Program begins operating, State will not include counties enforcing a grandfathered ordinance.

Vendor is any vendor hired by MED-Project to provide goods and/or services under the Program.

III. Collection System

MED-Project notified Retail Pharmacies, hospitals or clinics with on-site pharmacies, and law enforcement agencies of the opportunity to serve as a Collection Site 120 days prior to submitting the Plan. MED-Project asked if Retail Pharmacies, hospitals or clinics with on-site pharmacies, and law enforcement agencies were interested in participating in the Program, whether they currently host a collection receptacle or other services for the disposal of Covered Drugs, whether pharmacies are DEA registrant collectors, and if the potential Authorized Collector would like more information regarding the Program. To identify Retail Pharmacies, hospitals or clinics with on-site pharmacies, and law enforcement agencies, MED-Project obtained a list of licensed pharmacies and licensed hospital pharmacies from the Washington State Department of Health and a list of law enforcement agencies from the Washington State Criminal Justice Training Commission. MED-Project is identifying Substance Use Disorder Treatment Programs that will be notified of the opportunity to serve as a Collection Site.

A potential Authorized Collector can contact MED-Project for Program information or to express interest in participating in the Program by contacting the Help Desk, completing an online questionnaire, or writing to the MED-Project mailing address. MED-Project will commence good faith negotiations with a potential Authorized Collector no later than 30 days after the potential Authorized Collector expresses interest in participating in the Program without compensation. MED-Project will seek to include a Retail Pharmacy, hospital or clinic with an on-site pharmacy, or law enforcement agency as a Collection Site within 90 days of its expression of interest. If MED-Project has not met the service convenience goal described in RCW 69.48.060 in a population center, MED-Project will seek to include a long-term care facility or Substance Use Disorder Treatment Program as a Collection Site in the Program within 90 days of its expression of interest. Participation as a Collection Site is contingent upon execution of an agreement with MED-Project, adherence to all applicable laws, regulations, and other legal requirements, and completed installation of a Collection Receptacle.

If MED-Project excludes any potential Authorized Collectors from participation in the Program for reasons other than those stated in the Plan, the reason(s) will be provided to the Department. To date, MED-Project has not excluded any potential Authorized Collectors from the Program.

A. Equitable and Reasonably Convenient Access

The Program will initiate operations within 180 days of the Department's approval of the Plan. MED-Project will set up a collection system that provides equitable and reasonably convenient access to residents across the State consistent with RCW 69.48.060. MED-Project will seek to establish a collection system that meets the requirements of RCW 69.48.060(3)(c)(i), which provides that "[e]ach population center [as described in RCW 69.48.060(3)(c)(iii)] must have a minimum of one collection site, plus one additional collection site for every fifty thousand residents of the city or town located within the population center." MED-Project will rely upon the State's Office of Financial Management website to identify cities and towns. MED-Project will give preference to locating Collection Sites at Retail Pharmacies, hospitals or clinics with on-site pharmacies, and law enforcement agencies, and will work to distribute Collection Sites geographically to provide reasonably convenient and equitable access to all residents of the population centers. Additionally, MED-Project will provide Mail-Back Packages upon request to Covered Entities and to Retail Pharmacies that offer to distribute Mail-Back Packages to Covered Entities.

On islands and in areas outside of population centers, MED-Project will seek to locate Collection Sites at each eligible potential Authorized Collector that is regularly open to the public and is willing to participate in the Program. RCW 69.48.060(3)(c)(iii).

MED-Project is working to provide equitable and reasonably convenient access to all State residents through executed agreements with Retail Pharmacies, hospitals or clinics with on-site pharmacies, or law enforcement agencies, and will seek to establish additional Collection Sites in areas outside of population centers where potential Authorized Collectors are available.

<u>Appendix C</u> provides a list of existing locations hosting a collection receptacle that MED-Project will attempt to convert to Collection Sites. There are additional potential Authorized Collectors that are not listed in <u>Appendix C</u> because they do not currently host a collection receptacle. Many potential authorized collectors have expressed interest in participating in MED-Project's program. Those include potential authorized collectors with and without existing collection receptacles. The full list of potential authorized collectors that have expressed interest is available in <u>Appendix D</u>.



The Program will meet the convenience standard in RCW 69.48.060(3) on the first day that the Program initiates operations, including for population centers and underserved areas. If there are areas where Collection Sites are not established, MED-Project will seek to establish a Mail-Back Distribution Location for each missing Collection Site to supplement service.

90 days after Plan approval, MED-Project will meet with the Department to review areas that are at risk of being underserved by Collection Sites, including population centers. MED-Project will use the outcomes of this meeting and any consultations the Department has with local health jurisdictions to plan for supplemental services in areas that may be underserved, including as the Department determines pursuant to RCW 69.48.060(3)(d) and WAC 246-480-060. By 120 days after Plan approval, MED-Project will consult with the Department, local law enforcement, the local health jurisdiction, and the local community to plan supplemental collection services in areas that may be underserved by Collection Sites, per RCW 69.48.060(3)(d). Where required, supplemental collection services will begin 180 days after Plan approval and may include Mail-Back Distribution Locations or periodic Collection Events to be held at least twice per year unless otherwise determined through consultation with the local community.

As a potential option to supplement service, MED-Project may distribute Standard Mail-Back Packages directly to Covered Entities in areas outside of population centers that do not have a Collection Site or Mail-Back Distribution Location. Distributing Mail-Back Packages directly to Covered Entities will not be a supplemental service for areas underserved by Collection Sites except as determined in consultation with the Department, local law enforcement, local health jurisdiction, and the local community per RCW 69.48.060(3)(d). As part of its consultation with the Department for each supplemental service proposed, MED-Project will provide the Department with documentation of who was consulted, what the feedback was for the different groups consulted, and the proposed supplemental services and locations.

MED-Project will consult with the Department, local law enforcement, local health jurisdictions, and/or the local community through a webinar when establishing supplemental collection services in underserved areas. MED-Project may conduct webinars, as needed, in any areas that continue to be underserved. MED-Project will consider feedback from the webinars when establishing supplemental collection services, including feedback on the number, location, and type of supplemental services. MED-Project will also provide a website where the Department, local law enforcement, local health jurisdictions, and the local community can provide feedback about the Program, its collection system, and number, location, and type of supplemental service in any areas that continue to be underserved. Written feedback can also be sent to the MED-Project mailing address. MED-Project will consider feedback provided through the MED-Project website at med-project.org and mailing address when establishing supplemental collection services.

As MED-Project achieves equitable and reasonably convenient access to Collection Sites, supplemental services will be discontinued.

B. Collection Sites

The Program will initiate operations within 180 days of approval of the Plan by the Department. MED-Project's collection system will be safe, secure, and convenient on an ongoing, year-round basis and provide equitable and reasonably convenient access for Covered Entities across the State. Authorized Collectors participating in the Program must use a MED-Project Collection Receptacle complying with all applicable laws, regulations, and other legal requirements, including any applicable on-site storage and collection standards adopted by rule pursuant to chapter 70.95 or 70.105 RCW.

To be eligible to participate in the Program, an Authorized Collector, long-term care facility, or Substance Use Disorder Treatment Program must maintain all applicable licenses, registrations, and credentials in good standing, safely and securely collect and store Covered Drugs, and comply with an agreement to participate in the Program and all applicable laws, regulations, and other legal requirements. Collection of Covered Drugs (excluding Pre-filled Injector Products) will begin at Collection Sites once agreements have been executed with MED-Project and Collection Receptacles have been installed.

MED-Project Collection Receptacles will have a consistent design and use plain language and pictograms to instruct residents on the use of collection receptacles, including information about what is and is not accepted in the Collection Receptacle. Collection Receptacle signage will prominently display a toll-free telephone number and website for the Program so members of the public can report a full or damaged kiosk or inquire about the program. Collection Receptacle signage will inform Covered Entities who deposit Covered Drugs that they should completely cross out, remove, or otherwise make unreadable all personally identifiable information on the drug containers and packaging before placing them in the Collection Receptacle. Appendix E provides sample images of the MED-Project Collection Receptacle and Collection Receptacle signage.

MED-Project will offer to convert to the Program any existing locations hosting a Collection Receptacle that can meet all requirements described in the Plan. Converting existing locations hosting a Collection Receptacle will create a more consistent and easily recognizable collection system for Covered Entities.

Pre-filled Injector Products cannot be deposited into Collection Receptacles and will be collected and disposed of via Injector Mail-Back Packages.

1. Collection Site Locations

All Collection Sites shall meet DEA and Washington State Pharmacy Quality Assurance Commission ("WSPQAC") requirements, if applicable, and accept all Covered Drugs from Covered Entities during the hours that the Collection Site is normally open for business with the public. The DEA Rule only permits "manufacturers, distributors, reverse distributors, narcotic treatment programs, hospitals/clinics with an

on-site pharmacy, and retail pharmacies" and certain long-term care facilities to host collection receptacles that collect controlled substances. DEA Rule § 1317.40(b). If an Authorized Collector does not meet this requirement, then it is not eligible to serve as a Collection Site.

Pharmacies, hospitals/clinics with an on-site pharmacy, and Substance Use Disorder Treatment Programs may participate as a Collection Site only if they modify their DEA registrations to become authorized collectors.

2. Collection Receptacle Placement and Maintenance

All Collection Receptacles in the Program will be securely placed and maintained inside a Collection Site's physical location in accordance with DEA Rule §§ 1317.75(d)(1) and 1317.35(a)(3). Collection Receptacles at pharmacies, hospitals/clinics with an on-site pharmacy, and law enforcement agencies must be located in an area that is open to the public.

At pharmacies, Collection Receptacles will be placed in the immediate proximity of a designated area where controlled substances are stored and at which an employee is present (*i.e.*, can be seen from the counter), pursuant to DEA Rule § 1317.75(d)(2). At hospitals or clinics with an on-site pharmacy, Collection Receptacles will be placed in an area regularly monitored by employees but not near areas of the facility where urgent or emergency care is provided. DEA Rule § 1317.75(d)(2)(i). At Substance Use Disorder Treatment Programs, Collection Receptacles will be placed in a room that does not contain any other controlled substances and is securely locked with controlled access. *See* DEA Rule § 1317.75(d)(2)(ii). At long-term care facilities, Collection Receptacles will be placed in a secured area regularly monitored by long-term care facility employees. DEA Rule § 1317.75(d)(2)(iii).

When servicing a Collection Receptacle, Authorized Collector employees and/or a Service Technician will inspect the Collection Receptacle for any needed maintenance, including cleaning. The Authorized Collector employees and/or Service Technician will submit any maintenance requests through the Help Desk. MED-Project will provide for the inspection of Collection Receptacles at least semi-annually to monitor for general wear and tear and clean the Collection Receptacle, as necessary, to maintain proper function in addition to the regular inspection when Authorized Collector employees and/or a Service Technician services a Collection Receptacle.

Authorized Collectors and Collection Sites will be able to request maintenance through the MED-Project website and Help Desk. MED-Project will assess maintenance requests and initiate a response within one business day. Most maintenance requests will be resolved within 2 business days. Minor maintenance issues will be resolved within 5 business days.

3. Inner Liner Handling and Disposal

Authorized Collector employees and Vendor will follow DEA requirements for servicing Collection Receptacles. Per these requirements:

- Authorized Collector employees shall hold the two keys to unlock the Collection Receptacle, unless the Collection Site is a law enforcement agency.
- Vendor and Authorized Collectors participating in the Plan shall keep all records required under the DEA Rule, including those required under DEA Rule §§ 1304 and 1317.35.
- Inner liners provided in the Collection Receptacle shall be opaque to prevent visual recognition of the contents.

Each inner liner and box provided by the Vendor will be pre-paid and pre-addressed for transport and disposal.

a. Long-Term Care Facility Inner Liner Handling and Disposal

MED-Project will provide collection and disposal services as described in Section III.B at long-term care facilities. In addition to the requirements applicable to pharmacies, a long-term care facility must:

- Only collect covered drugs possessed by individuals who reside or have resided at the facility.
 RCW 69.48.060(2)(b).
- Locate Collection Receptacles in a secured area regularly monitored by long-term care facility employees. DEA Rule § 1317.75(d)(2)(iii).
- Lock or make Collection Receptacles otherwise inaccessible when long-term care facility employees are not regularly monitoring the Collection Receptacles. DEA Rule § 1317.75(f).
- Have an authorized retail pharmacy or a hospital/clinic with an on-site pharmacy install, manage, and maintain the Collection Receptacle. DEA Rule § 1317.80(b).
- Have one employee of the Authorized Collector and one supervisor-level employee of the long-term care facility designated by the Authorized Collector or two employees of the Authorized Collector perform or supervise the installation, removal, transfer, and storage of inner liners. DEA Rule § 1317.80(c).
- Store sealed inner liners for no more than three business days upon removal. DEA Rule § 1317.80(d).
- Transfer controlled substances in Schedules II, III, IV, and V into an authorized collection receptacle located at the long-term care facility if disposing of controlled substances on behalf of an ultimate user who resides, or has resided, at the long-term care facility. When disposing of such controlled substances, disposal shall occur immediately, but no longer than three business days after the discontinuation of use by the ultimate user. DEA Rule § 1317.80(a).

MED-Project will work with long-term care facilities to identify additional applicable inner liner handling and disposal requirements if the waste collected at the long-term care facility must be managed as a hazardous or dangerous waste. Pick-up of sealed inner liners at long-term care facilities will take place within three business days of removal.

b. Substance Use Disorder Treatment Program Inner Liner Handling and Disposal

DEA Rule § 1317.75(f) states that, "[e]xcept at a narcotic treatment program, the small opening in the outer container of the collection receptacle shall be locked or made otherwise inaccessible to the public when an employee is not present (e.g., when the pharmacy is closed), or when the collection receptacle is not being regularly monitored by long-term care facility employees." DEA Rule §§ 1301.72 through 1301.74 establish additional physical and other security controls and requirements that may apply to the containers used as Collection Receptacles. At a Substance Use Disorder Treatment Program, a collection receptacle must be located in a room that does not contain any other controlled substances and is securely locked with controlled access. See DEA Rule § 1317.75(d)(2)(ii).

4. Collection Methods

An Authorized Collector may participate in the program via either the Scheduled Collection Service method or On-Demand Collection Service method. For both methods, MED-Project provides for the collection, transport, and disposal of Covered Drugs at no cost to the Authorized Collector.

If an Authorized Collector elects to participate via the On-Demand Collection Service method, the Authorized Collector employees will prepare the inner liner for shipment following instructions provided by Vendor. The On-Demand Collection Service method will enable Authorized Collectors to control the timing for servicing the Collection Receptacle, avoiding disruptions to operations that may result from scheduled visits by Vendor or storage limitations. The Authorized Collector employees will seal the inner liner for

packaging and transport and schedule a Carrier to pick up the packaged inner liner at a time of their choosing or offer the packaged inner liner during a regular Carrier pick up.

If an Authorized Collector elects to participate via the Scheduled Collection Service method, a Service Technician will come to the Collection Site on a predetermined schedule to help prepare the inner liner for shipment and disposal. Authorized Collectors taking part in the Scheduled Collection Service method will have regular, year-round scheduled pick-ups by a Carrier based on the specific Collection Site's business hours and volume of collected medications. Authorized Collectors participating under the Scheduled Collection Service method will receive regularly scheduled Collection Receptacle service based on historical trends of Covered Drugs collected per service.

Authorized Collectors participating via the On-Demand Collection Service method will receive replenishment inner liners and boxes automatically when the first returned inner liner and box from any other kit of three inner liners and boxes ships, using a system that is designed to stock the Authorized Collector with spare inner liners and boxes prior to exhausting on-site supplies. The automatic replenishment system for inner liners and boxes or the regularly scheduled service based on historical trends will limit situations in which an Authorized Collector must lock a Collection Receptacle that has become full before receiving a replenishment inner liner and box or regularly scheduled service.

An Authorized Collector participating via the On-Demand Collection Service method that must lock a full Collection Receptacle can order additional inner liners and boxes through a system designed to fulfill orders within five business days. An Authorized Collector participating via the Scheduled Collection Service method can order a Collection Receptacle service in addition to the regularly scheduled service by submitting a maintenance request. Requests for additional inner liners and boxes and maintenance requests, including requests for prompt service, will be received through the MED-Project website and Help Desk.

Authorized Collectors may change their choice of collection method by providing written notice to MED-Project. A collection method change will initiate within 30 days of such notification unless the Authorized Collector requests a longer timeframe.

5. Collection Receptacle Service

When servicing a Collection Receptacle in compliance with all applicable laws, regulations, and other legal requirements, except at a long-term care facility, Authorized Collector employees or Service Technician(s), under the supervision of the employee(s) of the Authorized Collector, will:

- Check the Collection Receptacle for any damage.
- Unlock the Collection Receptacle and immediately remove and seal the inner liner following procedures meeting all DEA requirements.
- Replace the inner liner and box with a replenishment inner liner and box provided by Vendor.
- Match the unique identifier of the inner liner to the tracking number on the shipping label,
- Package the inner liner for transport.
- Prepare the materials for shipment and perform applicable pre-transportation functions to comply with the United States Department of Transportation Hazardous Materials Regulations.
- Schedule a pick-up from the Carrier to be completed within a few business days or offer the packaging holding the sealed inner liner for pick-up by routine Carrier service at the Collection Site.

Authorized Collector employees will maintain control of the inner liner at all times. The Collection Site will store the inner liner in compliance with all applicable laws, regulations, and other legal requirements until Carrier pick-up. Long-term care facilities will be serviced in accordance with DEA Rule § 1317.80.

Collection Site and Authorized Collector employees, Vendor, and Carrier shall manage Covered Drugs in compliance with all applicable laws, regulations, and other legal requirements. Covered Drugs will be destroyed in compliance with all applicable laws, regulations, and other legal requirements at a municipal waste combustor, medical waste incinerator, or hazardous waste incinerator.

6. Help Desk

MED-Project will manage a Help Desk available through the MED-Project website at <u>MED-Project.org</u>, 1-833-MED-PROJECT (1-833-633-7765), or <u>washington@med-project.org</u> to support the following functions and assistance:

- Answer questions and monitor comments from Authorized Collectors, potential Authorized
 Collectors, pharmacists and pharmacies, Collection Sites, and/or Mail-Back Distribution Locations.
- Respond to providers, hospitals, pharmacies, and other entities that wish to distribute Mail-Back
 Packages and/or promotional materials.
- Direct and respond to requests for service from Authorized Collectors, Collection Sites and/or Mail-Back Distribution Locations.

Authorized Collectors, potential Authorized Collectors, pharmacists and pharmacies, and/or Mail-Back Distribution Locations will be able to obtain educational and outreach materials, order more Mail-Back Packages in bulk, and communicate with MED-Project about questions, concerns, or report issues through the Help Desk, including on the MED-Project website. *See* Appendix H. Potential Authorized Collectors, including pharmacists/pharmacies, may also use the Help Desk to request program information and express interest in participating in the Program. When reached by phone, the Help Desk will identify to callers that they are calling MED-Project.

Participating Collection Sites will be able to log into a support system at MED-Project.org on the main landing page, confirm their site information, and have access to instructional materials including written instructions, downloadable forms, and/or video instruction guides. Additionally, Authorized Collectors will be able to request step-by-step instructions for servicing a Collection Receptacle by calling the Help Desk. Messages received from Collection Sites will be returned within one business day.

C. Mail-Back Services

MED-Project will provide three types of Mail-Back Packages including Standard Mail-Back Packages, Inhaler Mail-Back Packages, and Injector Mail-Back Packages.

Requests by Covered Entities to receive Mail-Back Packages will be taken through the MED-Project website, call center, and/or at Retail Pharmacies that request to distribute Mail-Back Packages. All Mail-Back Packages will be prepaid and pre-addressed and provided at no cost to Retail Pharmacies and Covered Entities upon request. The provision, collection, and disposal of Covered Drugs via Mail-Back Packages will comply with all applicable laws, regulations, and other legal requirements.

All Mail-Back Packages will have inserts covering:

- How to use the Mail-Back Package.
- What materials may go into the Mail-Back Package.
- Mailing restrictions with a notice that only packages provided by Vendor will be accepted for destruction.
- How to return the Mail-Back Package.
- Information about other options for disposing of Covered Drugs.

Appendix F provides sample images of the Mail-Back Packages and package inserts.

1. Mail-Back Distribution Locations

MED-Project may establish Mail-Back Distribution Locations to supplement service in any area of the State that is underserved by Collection Sites. Mail-Back Distribution Locations will be located in staffed public facilities, such as libraries, town halls, or law enforcement agencies, and will distribute Mail-Back Packages to Covered Entities. <u>Appendix G</u> provides a list of sites MED-Project may target to establish Mail-Back Distribution Locations.

Upon request, MED-Project will provide Mail-Back Packages to Retail Pharmacies that offer to distribute them for the Program. Mail-Back Packages will be provided at no cost to the Retail Pharmacy. Retail Pharmacies that offer to distribute Mail-Back Packages to Covered Entities will be able to log into a support system at MED-Project.org on the main landing page, provide their US Postal Service shipping address, and request Mail-Back Packages in units of 50, up to 250 at a time, to be sent to the Retail Pharmacy.

Mail-Back Distribution Locations and Retail Pharmacies may request Mail-Back Packages through the MED-Project website or Help Desk. The frequency of requests will be monitored and the fulfillment system will be designed to provide reminders to Mail-Back Distribution Locations to help maintain inventory. Requests will be promptly fulfilled. MED-Project will provide Standard Mail-Back Packages, Inhaler Mail-Back Packages, and Injector Mail-Back Packages as requested by a Mail-Back Distribution Location or Retail Pharmacy.

D. Collection Events

MED-Project may hold periodic Collection Events to supplement service to any area of the State that is underserved by Collection Sites. Federal, state, tribal, or local law enforcement shall oversee all Collection Events. MED-Project will arrange Collection Events in advance with local law enforcement agencies and conduct Collection Events in compliance with all applicable laws, regulations, and other legal requirements.

MED-Project will contract with local law enforcement to oversee Collection Events. These contracts will provide for the collection, transportation, and disposal of Covered Drugs from Collection Events and include requirements for participating law enforcement. MED-Project will work with local law enforcement to accommodate any reasonable requirements.

1. Procedure

Collection Events will be staffed in compliance with DEA requirements and as requested by local law enforcement. MED-Project will provide adequate staffing and resources to assist local law enforcement with logistics, coordination, and other needs during the event. MED-Project will promote Collection Events as described in Section IV.

Vendor will work in coordination with MED-Project and law enforcement to implement procedures for the collection of Covered Drugs at Collection Events in compliance with all applicable laws, regulations, and other legal requirements and meeting the expectations of the planned event. Material will be placed in a compliant collection receptacle and securely shipped to meet all applicable laws, regulations, and other legal requirements. Any material that is not a Covered Drug or does not meet legal requirements will be rejected as described in section VIII.B.4.

Covered Drugs will be packaged in inner liners, matched to the unique inner liner identifier on the shipping labels, and the inner liners will be prepared for shipment in compliance with all applicable laws, regulations, and other legal requirements. Collected material will be weighed following the completion of each Collection Event. Sealed inner liners will remain under the control and custody of law enforcement to the point of secure transfer, storage, or destruction.

E. Separation and Recycling of Packaging

RCW 69.48.050(2)(k)(ii) and (iii) require that MED-Project consider separation of Covered Drugs from packaging to reduce transportation and disposal costs and recycling of drug packaging. MED-Project has considered and evaluated options for the separation and recycling of drug packaging.

Separating and recycling drug packaging collected under the Plan would require the management of separate waste streams at Collection Sites: a waste stream for drug packaging and a waste stream for the drugs themselves. While drug packaging is expected to constitute a significant amount of the waste incinerated under the Plan, MED-Project has concluded that separation of inner and/or outer packaging from Covered Drugs or recycling packaging would raise three significant concerns:

- Separating and recycling drug packaging could result in the disclosure of confidential patient information appearing on prescription drug packaging.
- Separating and recycling drug packaging could increase the potential of releases and leakage of Covered Drugs.
- Separating and recycling drug packaging could increase diversion risks by adding additional steps to the collection process and because drug packaging is used in drug counterfeiting and would be a diversion target itself.

For these reasons, the Plan does not provide for the separation and recycling of packaging from Covered Drugs.

F. Disposal of Covered Drugs

Covered Drugs will be destroyed in accordance with all applicable laws, regulations, and other legal requirements.

Vendors used by the Program are identified in Table 1. The transporters used by the Program are identified in Table 2. MED-Project will dispose of Covered Drugs using facilities located outside of the State. The waste disposal facilities used by the Program, including their names, addresses, type, and federal or state waste permit type and number, are identified in Table 3.

IV. Drug Take-Back Program Promotion

MED-Project will create a system of promotion, education, and public outreach about the safe storage and secure collection of Covered Drugs through the MED-Project website, call center, printed materials, broadcast media, email blasts, digital media, and social media outlets. Education and public outreach will promote the use of the Program so that where and how to return Covered Drugs is widely understood by residents, pharmacists, Retail Pharmacies, health care facilities and providers, veterinarians, and veterinary hospitals. MED-Project will promote the program by providing consumers, pharmacies, and other entities with educational and informational materials. This system may include signage, written materials to be provided at Collection Sites, Mail-Back Distribution Locations, Retail Pharmacies providing Mail-Back Packages to Covered Entities, and Collection Events, and advertising or the distribution of other promotional materials. MED-Project will provide all promotional and education materials developed for the Program with each annual report.

MED-Project will prepare educational and outreach materials that emphasize that Patients should follow the instructions on medications exactly as provided, including labeling information and Medication Guides accompanying the medicine, and to consult their healthcare providers with any questions. In addition, MED-Project educational and outreach materials will promote that Patients follow any storage instructions as provided on the medicine label and/or on the patient information accompanying the medicine, such as keeping the medicine in a secure location safely away from people or pets that might come in contact with it.

Key points of emphasis will include:

- The importance of taking medicines as prescribed by health care providers.
- The importance of adhering to and completing provider prescribed therapy.
- The safe storage of Covered Drugs.
- Discouraging stockpiling of Covered Drugs.
- Discouraging the disposal of Covered Drugs in solid waste collection, sewer, or septic systems.
- Describing how to return Covered Drugs via the Drug Take-Back Program.
- How to find and use Collection Receptacles, Mail-Back Distribution Locations, and Retail Pharmacies providing Mail-Back Packages to Covered Entities.
- How to properly use the mail-back services provided.
- How to find and participate in Collection Events.

MED-Project promotional and educational materials will encourage Covered Entities to protect their personal information by ensuring that identifiable information is not present before depositing containers into Collection Receptacles or Mail-Back Packages.

If more than one drug take-back program is approved by the Department, MED-Project will seek to coordinate its promotional activities with other approved programs after the other program is approved and MED-Project has implemented the MED-Project website where Covered Entities can easily identify, understand, and access the collection services provided by any approved drug take-back program. Coordination efforts will include providing a single website and toll-free telephone number to access information about collection services for all approved programs.

A. Website

MED-Project will develop an accessible, mobile-friendly website with translations in the Specified Languages. The website will provide information for Covered Entities about Collection Sites, Mail-Back Distribution Locations, Retail Pharmacies providing Mail-Back Packages to Covered Entities, scheduled Collection Events, and how to request up to three Mail-Back Packages at once. The website will also discourage flushing Covered Drugs or placing them in the garbage and provide information about the

importance of safe usage and storage of Covered Drugs and the importance of disposing of Covered Drugs a Patient no longer needs.

MED-Project will deploy search engine optimization. Search engine optimization is designed such that the site displays prominently in search results related to drug storage and disposal. The list of Authorized Collectors, Collection Sites, Mail-Back Distribution Locations, Retail Pharmacies providing Mail-Back Packages to Covered Entities, and scheduled Collection Events will be updated at least quarterly. MED-Project will place links to its social media websites on the MED-Project website landing page.

In addition to the information provided to residents, Authorized Collectors will be able to request step-bystep instructions and access on-demand videos explaining how to service Collection Receptacles through the MED-Project website or Help Desk.

Appendix H contains a sample mockup of the MED-Project website and its supporting pages.

MED-Project's website will allow Covered Entities, Collection Sites, Mail-Back Distribution Locations, local health jurisdictions, law enforcement, community members, and the Department to provide feedback about the Program, in any areas that are determined to be underserved. Pharmacies, health care facilities, Authorized Collectors, Collection Sites, Mail-Back Distribution Locations, and other interested parties can also access materials for dissemination to Covered Entities.

Mail-Back Distribution Locations and Retail Pharmacies will be able to request bulk Mail-Back Packages through the MED-Project website. Authorized Collectors utilizing the On-Demand Collection Service method will be able to review step-by-step instructions and videos explaining how to service Collection Receptacles. Authorized Collectors and Collection Sites will also be able to notify MED-Project of a needed maintenance service, including a Collection Receptacle service in addition to the regular service schedule, or order additional boxes and inner liners at Collection Sites participating via the On-Demand Collection Service method, including the need for prompt service.

Potential Authorized Collectors will be able to inquire about Program information and how to become an authorized Collection Site on the MED-Project website.

B. Call Center

MED-Project will establish a toll-free telephone number, at 1-844-MED-PROJECT (1-844-633-7765), staffed by live agents for Covered Entities to obtain information about Collection Sites, Collection Events, mail-back services, educational materials, and other aspects of the Program. Callers with medical emergencies will be directed to call 911. Patients with medication-related questions will be directed to contact their health care provider(s).

The call center will provide information about:

- Items that can be disposed of.
- Disposal options.
- Collection Sites, Mail-Back Distribution Locations, Retail Pharmacies providing Mail-Back Packages to Covered Entities, and Collection Events in the caller's specified zip code.
- Directions to the MED-Project website.
- How to request Mail-Back Packages.

Covered Entities can request Mail-Back Packages through the toll-free number, as well as through the MED-Project website. If Covered Entities call the toll-free number, requests for Mail-Back Packages will be taken by an agent without requiring the Covered Entity to visit the MED-Project website.

C. Materials

MED-Project will create printable materials about the Program that describe safe storage and how to safely dispose of Covered Drugs through the Program, including information about how to request Mail-Back Packages. MED-Project will also create materials to advertise Collection Events, as needed, for distribution in local areas where Collection Events are conducted. The materials will be provided on the MED-Project website and to pharmacies, health care facilities, and other interested parties for dissemination to Covered Entities. <u>Appendix I</u> provides a sample of the materials.

Materials will use plain language and explanatory images to promote and explain Program collection services, including where and how to return Covered Drugs, and identify discouraged disposal practices to all Covered Entities, including Covered Entities with limited English proficiency, and pharmacies. In accordance with RCW 69.48.070(1)(e-f), MED-Project will make available on the MED-Project website and distribute promotional printed materials to Retail Pharmacies, health care facilities, and other interested parties so they can provide these materials to Covered Entities. Distribution methods include providing material at the time of Collection Receptacle installation, when activating Mail-Back Distribution Locations and Retail Pharmacies, or by request on the MED-Project website or call center. To further expand outreach, MED-Project will send a letter via email or through the mail to Retail Pharmacies, health care facilities, and veterinary hospitals. This letter will introduce MED-Project to the Retail Pharmacies, health care facilities, and veterinary hospitals of Washington on how they can request more such materials.

D. Media Outreach

MED-Project will promote the Program using a combination of advertisements and outreach through broadcast and website Public Service Announcements ("PSAs") and other digital, print, and social media. Social media will include websites such as Facebook and Twitter. These outlets will allow MED-Project to promote the safe use, storage, and disposal of Covered Drugs and inform Patients and the public of available Collection Sites, Mail-Back Distribution Locations, and scheduled Collection Events.

MED-Project will conduct an outreach campaign throughout the State using the following media channels:

- TV broadcast.
- Radio broadcast.
- Print media.
- Digital media.

The level of activity will be designed to be viewed by 50% of State residents over the age of 18 during the calendar year. From time to time, MED-Project may conduct additional targeted campaigns to further enrich the outreach program based on consultation with local jurisdictions.

Links to MED-Project's social media websites will be placed prominently on the MED-Project website landing page.

E. Disclaimer

The written and verbal education and public outreach materials distributed under the Program will include a disclaimer similar to: "This material has been supplied for the purpose of compliance with law and does not necessarily reflect the views of MED-Project or the companies participating in the MED-Project Product Stewardship Plan."

V. Goals

The short- and long-term goals of the Program are provided in Table 4.

VI. Patient Privacy

Instructions at each Collection Site will inform residents that they should completely cross out, remove, or otherwise make unreadable all personally identifiable information on drug containers and packaging before depositing them in the Collection Receptacle. In cases where people follow the instructions, there will be no personally identifiable information.

In addition to Collection Receptacle signage, all MED-Project promotional and educational materials encourage residents to protect their information by ensuring that identifiable information is not present before depositing containers into Collection Receptacles. Examples of MED-Project signage and MED-Project webpages are available in <u>Appendix E</u> and <u>Appendix H</u>.

As added protection, the inner liners for the Collection Receptacle will be opaque rather than clear, in compliance with the DEA Rule. This will prevent anyone from seeing any information on the containers placed in the Collection Receptacles.

VII. Change Management

Per RCW 69.48.050(5)(a), MED-Project will submit Plan changes that substantially alter Program operations to the Department in writing for prior written approval at least fifteen days before the changes are scheduled to occur. Changes requiring prior approval of the Department include changes to participating Covered Manufacturers, collection methods, achievement of the service convenience goal described in RCW 69.48.060, policies and procedures for handling Covered Drugs, education and promotion methods, and selection of disposal facilities.

Per RCW 69.48.050(5)(b), MED-Project will notify the Department at least seven days before implementing changes to the Program that do not substantially alter Program operations. Changes that do not substantially alter Program operations include Collection Site locations, methods for scheduling and locating periodic Collection Events, and methods for distributing Mail-Back Packages. MED-Project will notify the Department of changes to the Program's official point of contact no later than fifteen days after the change, and no later than ninety days after changes to ownership or contact information for participating Covered Manufacturers.

Given the volume of anticipated changes in participating Covered Manufacturers, and because MED-Project may not have prior notice of such changes, MED-Project will notify the Department of changes in participating Covered Manufacturers by providing the Department an updated list of participating Covered Manufacturers every 30 days. Specifically, MED-Project will make available a Covered Manufacturer list and list of Collection Sites every 30 days.

VIII. Compliance with Applicable Laws

MED-Project will require that Vendor, Authorized Collectors, Collection Sites, Mail-Back Distribution Locations, and Retail Pharmacies providing Mail-Back Packages to Covered Entities comply with all applicable laws, regulations, and other legal requirements. The Program requires that Vendor maintain policies and procedures to be followed by persons handling Covered Drugs collected under the Program for safety, security, and compliance with all applicable laws, regulations, and other legal requirements.

Authorized Collectors and Collection Sites must comply with applicable provisions of chapters 70.95 and 70.105 RCW, including rules adopted pursuant to those chapters that establish collection and transportation standards, and federal laws and regulations governing the handling of Covered Drugs, including DEA regulations.

The Plan is designed so all entities participating in the Program shall follow all applicable laws, regulations, and other legal requirements including, but not limited to, the regulatory programs listed in Table 5.

A. Policies and Procedures

MED-Project contracts and agreements with Vendor(s), Authorized Collectors, Collection Sites, Mail-Back Distribution Locations, and Retail Pharmacies providing Mail-Back Packages to Covered Entities require that all entities participating in the program comply with all applicable laws, regulations, and other legal requirement per RCW 69.48.050(2)(f).

MED-Project Vendor contracts for vendors who handle Covered Drugs collected under the drug take-back program will generally require that Vendor:

- Follow all applicable laws, regulations, and other legal requirements.
- Maintain all professional and governmental permits, licenses, consents, authorizations and certifications required by applicable laws for the performance of program services.
- Provide program services in timely, professional and commercially diligent manner according to generally accepted industry and professional standards.
- Provide certification that all applicable employee trainings are complete.

- Complies with industry-standard safety and security procedures.
- Is not under any action, suit, or proceeding before or by any court or governmental authority pending which could materially affect the Vendor's performance to provide the program services and the Vendor shall immediately notify MED-Project of any such action.
- Obtain written notice for pre-approval before changing transporters or disposal facilities.
- Use commercially reasonable measures to prevent theft or diversion of Covered Drugs.
- Report safety, security or other procedural deviations.
- Maintain comprehensive information security programs and will notify MED-Project in the event of a data breach.
- Maintain complete and accurate records, such as books, documents, accounting procedures and practices. MED-Project may audit such records.
- Provide written reports related to the program services.

Agreements with Authorized Collectors generally require that the Authorized Collector will:

- Maintain compliance with all applicable laws regarding the collection, handling, processing, and disposal of Unwanted Medicine.
- Possess all required authorization to enter into an agreement for program services.
- Identify a responsible manager and provide qualified staff.
- Have qualified staff unlock and lock the Collection Receptacle.
- Complete documentation under all applicable laws for Collection Receptacle delivery, installation, or removal and for Covered Drug collection, storage, transportation, or disposal.
- Securely maintain any documentation required under the Program.
- Provide the documentation upon request to MED-Project.
- Make the Collection Receptacle available to the public during business hours unless there is a safety, security, service, maintenance, or other condition requiring the Authorized Collector to lock the Collection Receptacle.
- Promptly notify MED-Project of any service or maintenance concerns.
- Collect and store Covered Drugs and cause the transportation and disposal of Covered Drugs.
- Establish and implement procedures limiting Collection Receptacle key access to qualified staff.
- Lock the Collection Receptacle and cooperate with MED-Project for Collection Receptacle removal upon termination of the agreement.
- Report any theft, unexplained loss, or diversion of Covered Drugs, safety or security problem, or environmental incident.

Mail-Back Distribution Locations and Retail Pharmacies providing Mail-Back Packages to Covered Entities must sign an agreement with MED-Project. Mail-Back Distribution Location agreements will generally:

- Require distribution of Mail-Back Packages to Covered Entities in compliance with all applicable laws, regulations, and other legal requirements.
- Require that Mail-Back Packages be made available to Covered Entities free of charge (for example, via a request by a Covered Entity to a pharmacist at a Retail Pharmacy).
- Provide a process for site to request additional Mail-Back Packages.
- Prohibit disposal of commercial waste through Mail-Back Packages.
- Require Mail-Back Packages be stored in a secure area and labels will not be modified or removed.
- Require Mail-Back Packages be stored to avoid damage or package compromise.
- Prohibit collection of resident personal information.
- Prohibit handling, collection, or storing Mail-Back Packages containing Covered Drugs from Covered Entities and prohibit shipping Mail-Back Packages on behalf of Covered Entities.
- Complete documentation under all applicable laws and by MED-Project for distributing Mail-Back Packages.

- Securely maintain any documentation required under the Program.
- Provide the documentation upon request to MED-Project.

Agreements for Collection Events require that law enforcement will generally:

- Maintain compliance with all applicable laws regarding the collection, handling, processing, and disposal of Covered Drugs.
- Possess all required authorization to enter into an agreement for Program services.
- Collect and store Covered Drugs and cause the transportation and disposal of Covered Drugs.
- Report any theft, unexplained loss, or diversion of Covered Drugs, safety or security problem, or environmental incident.

B. DEA Controlled Substances Act and Implementing Regulations

Under the DEA Rule, collection of controlled substances is generally limited to Schedule II, III, IV, or V controlled substances that are lawfully possessed by an ultimate user. *See* DEA Rule §§ 1317.75(b); 1317.70(b). Schedule I controlled substances, controlled substances that are not lawfully possessed, and other illicit or dangerous substances will not be collected. Additionally, as these provisions of the DEA Rule limit collection of controlled substances to those lawfully possessed by an ultimate user or certain other persons, pharmacies are prohibited from disposing of their own inventory or stock through the Program. *See id.*; see also § 1317.05.

The DEA Rule provides that law enforcement agencies can continue to accept controlled substances for disposal, however, the DEA Rule also provides that Retail Pharmacies, reverse distributors, hospitals/clinics with on-site pharmacies, narcotic treatment programs, and certain other entities, can register with the DEA as "collectors" and become authorized at their discretion on a voluntary basis to accept controlled substances.

The DEA Rule:

- Provides for the collection of controlled substances at any collection site included under 21 CFR 1317.40(b).
- Provides for the use of mail-back programs to collect controlled substances.
- Establishes detailed collection, recordkeeping, security, and other measures for all approved collection methods.
- Provides that all collected pharmaceutical products be destroyed so that the products are rendered non-retrievable.

Controlled substances collected pursuant to the Program may be commingled with non-controlled substances at Collection Sites and in Standard Mail-Back Packages per the DEA Rule. *See* §§ 1317.75(b); 1317.70(b).

1. DEA Registration Modification

Pursuant to DEA Rule. § 1301.51(b), pharmacies and narcotic treatment programs may modify their registrations to become authorized collectors by submitting a request to the DEA or online at www.DEAdiversion.usdoj.gov. This request must contain:

- The registrant's name, address, and registration number (as printed on the registration certificate).
- The collection methods the registrant intends to conduct.
- A signature in accordance with § 1301.13(j).

MED-Project will consult with participating pharmacies, as requested, regarding how to modify DEA registrations to become authorized collectors.

2. Collection Receptacles

Pursuant to DEA Rule § 1317.75(e) and (f), Collection Receptacles at pharmacies, hospitals and clinics with on-site pharmacies, narcotic treatment programs, and long-term care facilities will:

- Be securely fastened to a permanent structure.
- Be securely locked, substantially constructed containers with a permanent outer container and removable inner liner.
- Include a small opening in the outer container that allows contents to be added to the inner liner but does not allow removal of the inner liner's contents.
- Prominently display a sign indicating that only Schedule II-V controlled and non-controlled substances are acceptable to be placed in the Collection Receptacle.
- Except at a narcotic treatment program, have the small opening in the outer container locked or made inaccessible to the public when a Collection Site employee is not present, or when the collection receptacle is not being monitored by long-term care facility employees. DEA Rule § 1317.75(f).

The proposed design of the pharmacy Collection Receptacle⁵ satisfies these requirements through heavy gauge steel; multiple locking mechanisms, including:

- A locking mechanism on the drop-slot.
- A tamper-resistant drop-slot.
- Commercial hinges.

The locking mechanism on the drop-slot will prevent Collection Receptacle overflow once the Collection Site locks the container upon reaching its maximum level. MED-Project pharmacy Collection Receptacles will come with signage required under the DEA Rule⁶.

Under DEA Rule § 1317.60(a), Collection Receptacle inner liners will:

- Be waterproof, tamper-evident, and tear-resistant.
- Be removable and sealable immediately upon removal without emptying or touching Collection Receptacle contents.
- Make the contents of the inner liner not viewable from the outside when sealed.
- Clearly indicate the size of the inner liner.
- Bear a permanent, unique identifier for tracking purposes.

While the DEA Rule does not require law enforcement agency Collection Receptacles to meet these same requirements, MED-Project will offer these Collection Receptacles and inner liners to law enforcement agencies.

Section 1317.75(g) provides that pharmacy Collection Receptacle inner liner installation or removal shall be performed "by or under the supervision of at least two employees of the authorized collector." Section 1317.60 limits inner liner access to employees of the collector and requires two employees to seal the inner liner upon its removal from the permanent outer container.

⁵ MED-Project will coordinate with other drug take-back programs to develop clear, standardized instructions with a consistent design for Covered Entities on the use of Collection Receptacles.

⁶ Specifically, as required under § 1317.75(e)(4), all Collection Receptacles will prominently display a sign stating that: "Only Schedule II-V controlled and non-controlled substances that are lawfully possessed by the ultimate user are acceptable to be placed in the kiosk. Schedule I controlled substances, illicit or dangerous substances, and any controlled substances not lawfully possessed by the ultimate user may not be placed in the kiosk."

The pharmacy Collection Receptacle sealed inner liner must not be opened, x-rayed, analyzed, or otherwise penetrated. DEA Rule § 1317.60(c). Section 1317.75(c) prohibits the counting, sorting, inventorying, or individual handling of any substances deposited into a pharmacy Collection Receptacle.

Authorized Collectors participating in the Program shall keep all records required under the DEA Rule, including those required under §§ 1304 and 1317.35. At Collection Sites that are law enforcement agencies, Vendor and the law enforcement agency shall keep any records of removal, storage, or destruction of the collected Covered Drugs in a manner consistent with the law enforcement agency's recordkeeping requirements for illicit controlled substances evidence per DEA Rule § 1317.35.

The law enforcement agency shall store Covered Drugs in a manner to prevent the diversion of controlled substances consistent with its standard procedures for storing illicit controlled substances. Collected Covered Drugs shall be transferred to the disposal facility in a manner to prevent the diversion of Covered Drugs and consistent with the law enforcement agency's standard procedures for transferring illicit controlled substances.

3. Mail-Back Services

Per DEA Rule § 1317.70(c), Standard Mail-Back Packages will be:

- Nondescript with no markings or information potentially indicating that they contain Covered Drugs, including controlled substances.
- Water and spill-proof, tamper-evident, tear-resistant, and sealable.
- Pre-addressed with and delivered to Vendor's registered address.
- Provided with a unique identifier enabling tracking.

When using mail-back services, Patients and persons lawfully entitled to dispose of a Patient/decedent's property will not be required to provide any personally identifiable information. See § 1317.70(d).

Per § 1317.70(e), Vendor will only accept Standard Mail-Back Packages provided by Vendor or packages lawfully forwarded under DEA requirements. Within three business days of receipt, Vendor will notify the DEA if it receives Standard Mail-Back Packages likely containing controlled substances that Vendor did not make available or did not agree to receive per DEA requirements.

Per § 1317.70(f), when Standard Mail-Back Packages are received, only Vendor employees will handle the Standard Mail-Back Packages; Standard Mail-Back Packages will not be opened, x-rayed, analyzed, or otherwise penetrated upon receipt by Vendor.

If Vendor needs to store filled Standard Mail-Back Packages, they will follow all applicable security requirements of DEA Rule Section 1317, including securely storing Covered Drugs constant with the requirements for Schedule II controlled substances.

All Covered Drugs will be destroyed promptly. Vendor will keep all records required under the DEA Rule, including those identified in § 1304.22(f).

4. Collection Events

At least one law enforcement officer will oversee the collection at all Collection Events pursuant to DEA Rule § 1317.65(a), (b). Law enforcement officers shall maintain control and custody of all Covered Drugs collected at Collection Events from collection until the Covered Drugs are securely transferred, stored, or destroyed, as required by DEA Rule § 1317.65(b). Only ultimate users and persons authorized to dispose of an ultimate user decedent's property in lawful possession of controlled substances in Schedules II-V may transfer these substances to law enforcement during the Collection Event. DEA Rule § 1317.65(e). No other person shall handle controlled substances at Collection Events under DEA Rule § 1317.65(e); however, Vendor may assist law enforcement in the collection of Covered Drugs at Collection Events. Disposal of Controlled Substances, 79 Fed. Reg. 53520, 53539 (Sept. 9, 2014).

Vendor and law enforcement shall maintain all records of removal, storage, or destruction of the collected Covered Drugs in a manner consistent with the law enforcement agency's recordkeeping requirements for illicit controlled substances evidence pursuant to DEA Rule § 1317.35. Any collected Covered Drugs shall be stored to prevent the diversion of controlled substances and consistent with the law enforcement agency's standard procedures for storing illicit controlled substances. Any storage of Covered Drugs by Vendor shall also comply with the applicable security requirements of DEA Rule §§ 1301 and 1317, including the requirement that Covered Drugs be securely stored in a manner consistent with the security requirements for Schedule II controlled substances.

C. State of Washington Waste Management Program

MED-Project, Vendor, and other entities participating in the Program shall comply with any applicable provisions of the State's waste management program. MED-Project will require Vendor to comply with applicable State waste management program requirements. MED-Project will monitor Vendor compliance through reporting and, on an as-needed basis, audits. MED-Project will also require other participating entities to comply with State waste management requirements to the extent applicable. MED-Project will monitor Collection Sites through semi-annual inspections.

D. Washington State Pharmacy Quality Assurance Commission

If WSPQAC establishes such rules regarding the Program, MED-Project will alert participating Collection Sites that are licensed pharmacies. MED-Project requires participating entities to comply with all applicable laws, regulations, and other legal requirements. MED-Project will monitor Vendor compliance with WSPQAC rules regarding the Program through reporting and, on an as-needed basis, audits. MED-Project will monitor Collection Site compliance with WSPQAC rules regarding the Program through semi-annual inspections.

IX. Proprietary Information

Proprietary information submitted to the Department as a part of the Program is exempt from public disclosure under RCW 42.56.270. MED-Project will identify, in writing, proprietary information when submitting information to the Department.

MED-Project acknowledges that the Department may use and disclose proprietary information in summary or aggregated form that does not directly or indirectly identify proprietary information of a transporter, individual Covered Manufacturer, or MED-Project.

MED-Project may seek to enjoin the release of information provided under RCW 42.56.540 upon notification that the Department has received a request for disclosure under chapter 42.56 RCW that includes information identified by MED-Project as proprietary.

X. Reporting

By July 1, 2020, and each July 1st thereafter, MED-Project will submit to the Department a report describing implementation of the Program during the previous calendar year.⁷ The report will include:

- A list of Covered Manufacturers participating in the Program.
- The amount, by weight, of Covered Drugs collected, including the amount by weight from each collection method used.
- A list of Collection Sites with addresses.

⁷ By July 1, 2020, MED-Project will only provide changes that occur to the participating Covered Manufacturers list, or any significant changes to the annual budget, that occur after the submission of this Plan because there will be no other operational information available from the 2019 calendar year to report.

- The number of Mail-Back Packages provided.
- Locations where Mail-Back Packages were provided, if applicable.
- Dates and locations of Collection Events held, if applicable.
- The transporters and disposal facility or facilities used.
- Whether any safety or security problems occurred during collection, transportation, or disposal of Covered Drugs, and, if so, completed and anticipated changes to policies, procedures, or tracking mechanisms to address the problem and improve safety and security.
- A description of the public education, outreach, and evaluation activities implemented. MED-Project will provide all promotional and education materials developed for the Program with each annual report.
- A description of how collected packaging was recycled to the extent feasible.
- A summary of the Program's goals for collection amounts and public awareness, the degree of success in meeting those goals, and, if any goals have not been met, what effort will be made to achieve those goals the following year.
- The Program's annual expenditures itemized by the following categories, consistent with WAC 246-480-040(5) and WAC 246-480-080(2):
 - Administrative costs.
 - Collection and disposal costs.
 - Communications costs.

Within thirty days after each annual period of operation, MED-Project will submit an annual collection amount report to the Department that provides the total amount by weight of Covered Drugs collected from each Collection Site during the prior year. Due to the timing of when MED-Project receives collection data from Vendor, the report will contain final collection data for the first three quarters of the previous year and preliminary data for the fourth quarter of the previous year. MED-Project will submit final collection data for the fourth quarter of the previous year within 60 days after each annual period of operation.

If MED-Project encounters a safety or security problem during collection, transportation, or disposal of Covered Drugs, MED-Project shall notify the Department as soon as practicable after encountering the problem.

XI. Program Costs and Fees

Through agreements with Authorized Collectors and Vendor, MED-Project will pay all administrative and operational costs associated with establishing and implementing the Program. Consistent with RCW 60.48.090(1), such administrative and operational costs include, but are not limited to:

- Collection and transportation supplies for each Authorized Collector.
- Purchase of secure Collection Receptacles for each Authorized Collector.
- Ongoing maintenance or replacement of Collection Receptacles when requested by an Authorized Collector.
- Mail-Back Packages.
- Compensation of Authorized Collectors, if applicable.
- Operation of periodic Collection Events, including the cost of law enforcement staff time.
- Transportation of all collected Covered Drugs to final disposal.
- Environmentally sound disposal of all collected Covered Drugs.
- Program promotion and outreach.

Appendix J provides MED Project's budget estimate for the Program in accordance with WAC 246-480-040(5). The budget covers a 12-month calendar period of anticipated operations from June 2020 through May 2021. Program spend will be reported in the report described in Section X. The budget estimate does

not include MED-Project programs operating in counties enforcing a grandfathered ordinance. Administrative and operational costs of the Program will be apportioned among participating Covered Manufacturers in a fair and reasonable manner.

XII. Grandfathered Drug Take-Back Programs

RCW 69.48.160(1)(a) allows a county to enforce a grandfathered ordinance for 12 months after a drug take-back program approved under RCW 69.48.050 begins operating. After 12 months, the Law preempts all existing or future laws enacted by a county, city, town, or other political subdivision of the State regarding a drug take-back program or other program for the collection, transportation, and disposal of Covered Drugs, or promotion, education, and public outreach relating to such a program.

MED-Project will work with any county enforcing a grandfathered ordinance and the Department to incorporate the local program into the Program on or before the end of the 12-month period after the Program begins operating. During this period, MED-Project will meet quarterly with the counties enforcing grandfathered ordinances to:

- Review the status of current services under existing program.
- Identify any gaps between current program services and the services provided under the State Program.
- Establish a schedule for transitioning the existing program into the State Program.

After the end of the 12-month period, MED-Project will maintain a network of Collection Sites that meets the requirements established in RCW 69.48.060(3)(c).
