SUBJECT: Building Community Capacity for Equitable COVID-19 Recovery – Funding Opportunity

In accordance with chapter 43.376 RCW, the Washington State Centennial Accord of 1989, and DOH Consultation and Collaboration Procedure, please be advised the Washington State Department of Health (DOH) has a total of \$1,500,000 to distribute to organizations serving communities disproportionately impacted by COVID-19.

DOH invites your representatives to *collaborate* with us on the equitable distribution of the Building Community Capacity for Equitable COVID-19 Recovery funds. Organizations may receive up to \$40,000 for projects that help improve equitable access, distribution and administration of COVID-19 vaccines, health information, and prevention resources as well as community capacity building and mobilization to advance health equity by addressing the structural and social determinants of health amplified by the COVID-19 pandemic. **Interest forms are due by August 28, 2023 at 5:00 p.m.**

Building Community Capacity for Equitable COVID-19 RecoveryA Funding Opportunity

Dear Community Organizations,

The Washington State Department of Health is offering a one-time funding opportunity for community-rooted organizations serving communities disproportionately impacted by COVID-19 to support equitable access to COVID-19 vaccines, information, and resources. The Washington State Department of Health strives to ensure the equitable distribution of these funds from the Centers for Disease Control and Prevention to address COVID-19 health disparities among populations at high-risk and underserved, including minoritized populations and rural communities. Projects supported by this funding will improve equitable access, distribution and administration of COVID-19 vaccines, health information, and prevention resources as well as community capacity building and mobilization to advance health equity by addressing the structural and social determinants of health amplified by the COVID-19 pandemic. All projects must meaningfully center priority communities disproportionately impacted by COVID-19, lead with racial equity, and must address one or more priority intersections. A list of priority communities and intersections are detailed in the "Eligibility" section below.

There is \$1,500,000 in total funding. Contracts will be between \$5,000-\$40,000.

Eligible Organizations

Funding is open to community-rooted, community-led, and community-based organizations that **serve one or more priority communities** and **one or more priority intersections** (as listed below).

Priority Communities:

- American Indians/Alaska Natives
- Black/African American
- Hispanic/Latino/Latina
- African Diaspora
- Asian
- Native Hawaiian/Pacific Islander

Priority Intersections:

- People living in rural communities
- People with disabilities
- Religious minorities
- Lesbian, gay, bisexual, transgender, and queer (LGBTQ+) persons
- People over 65 years old
- People who are incarcerated
- Immigrant/refugee communities

- People with limited English proficiency
- Agricultural workers
- Unhoused people/people experiencing homelessness

Organizations encouraged to submit an interest form include but are not limited to:

- not-for-profit organizations, Urban Indian and/or tribal-related organizations, faith-based organizations, and organizations that have fiscal sponsorship; and
- rural health centers, community health centers, and federally qualified health centers.

The Department of Health recognizes that community-rooted and community-led organizations and groups are better positioned and equipped to listen, understand, and respond to the needs of their community members in the most culturally relevant and linguistically appropriate way. They are also better equipped to use a trauma-informed lens or approach to their interventions so as to not perpetuate further harm, fear, and distrust.

Contingent on funding availability, DOH may open a second funding round.

Interest Form Review Process

There may be more interest than funding available. A review process is established to provide transparency. The Center for Community Relations & Equity will review all interest forms to verify projects are responsive to funding priorities and community needs and for equity and geographic considerations. Submissions will

also be reviewed by a committee of the <u>Community Collaborative</u> to ensure an equity and social justice lens is applied in the prioritization, planning, and decision making related to recovery efforts. The following guidance will be used to approve each project for funding:

- **1. Health Equity** How does the project center priority communities? How does the project or activity involve community?
- 2. Feasibility How feasible is the project in terms of time, budget requests, and available resources?
- **3. Appropriateness and relevance** How well do the goals address COVID-19 vaccines and health concerns? How clearly are the goals and objectives stated? How many people will benefit?
- **4. Budget** Budget is \$40,000 and appropriate as it relates to the work.
