Re: Healthcare Preparedness and Response

Dear Honorable Tribal Leader:

In accordance with chapter <u>43.376 RCW</u>, <u>Washington State Centennial Accord of 1989</u>, and <u>Washington State Department of Health (DOH) Consultation and Collaboration Procedure</u>, in government-to-government relations with Indian tribes and tribal organizations in the development of policies, agreements, and program implementation that directly affects Indian tribes and tribal people, I'm writing today to invite your collaboration, in the development of a Healthcare Preparedness and Response Steering Committee.

Following the COVID-19 response and to begin implementing learning from that response, the DOH intends to re-develop a steering committee to inform the work of the Executive Office of Resiliency and Health Security. In this effort, one of the first steps that we are taking is to convene a Healthcare Preparedness and Response Steering Committee. My hope is that this group will evolve into a Public Health, Medical, and Mortuary Affairs advisory body that our agency can engage as we continue to learn from our responses to emergencies and build resilience and response capability across the state. I invite you to actively collaborate as tribes in the way that you determine and would appreciate your feedback if you have suggestions or questions about how best to work with your nation, community, and people in this area.
