OPEN SESSION

1. CALL TO ORDER – The business meeting of the Athletic Training Advisory Committee (committee) was called to order at 9:01 a.m. by Cynthia Wright, PhD, ATC, Vice-Chair.

1.1. Introductions

The committee and staff introduced were introduced by Bruce Bronoske Jr., Program Manager.

1.2. Public Comment - The public had an opportunity to provide comments. Individuals that would like to comment during this time were asked to limit comments to two minutes. 1.3. Approval of Agenda

1.4 Approval of December 20, 2021 meeting minutes

The committee appointed Larry Brown, ATC as Meet-Me-Call representatives for 2023.

- 5. STUDENT HEAD INJURY INFORMATION REPORTING TOOL (SHIRT) The committee discussed the implementation of House Bill 2731 requiring schools to report diagnosed concussions during athletic or other activities.

Mr. Bronoske presented the committee the updated bylaws. He shared the suggested updates included adding the length of a committee member term as 4 years. The OPMA language was also updated to allow special and regular meetings.

- **6. PROGRAM REPORT** Bruce Bronoske, Jr., Program Manager; James Chaney, Executive Director presented information to the committee.
 - 6.1 Interim Operating Budget Ms. Santiago provided the interim operating budget report. The budget is in good shape with revenue exceeding expenditures. Ms. Wright asked about whether a fee reduction is being considered. Ms. Santiago will look into this and will provide updated information at a future committee meeting.
 - 6.2 Board of Certification (BOC) for Athletic Trainers 2022 CARE Conference Ms. Santiago presented disciplinary statistics for the past 18 months. Discipline is very low. She shared that there have been five cases which resulted in no legal action.



- 6.3 BOC name change Mr. Bronoske provided the committee a presentation regarding licensing statistics. Statistics presented are as follows:
- 6.4 SB 5229 Health Equity Rules

Mr. Bronoske, Jr. informed the committee that the BOC Regulatory Affairs Advisory Panel (RAAP) had completed the model language. The RAAP would begin working on the agenda for the 2022 BOC Cares conference.

6.5 Definitions – The committee considered opening rules to define medical diagnosis and clinical diagnosis.

Mr. Bronoske, Jr. shared that the BOC is designating specialties. Orthopedic specialty is now available.

6.6 Athletic training publication update

Mr. Bronoske, Jr. shard the BOC has added Britain to the International Arrangement. Britain joins Canada and Ireland in BOC's International Arrangement.

6.7 Committee member terms/recruitment

Mr. Bronoske, Jr. shared with the committee information on SB 5229. The department will begin rule writing. Mr. Bronoske, Jr invited committee members to participate in the rule writing sessions. He will provide the committee information on times and dates of rules workshops.
