- 3. Audiology and Speech-Language Pathology Interstate Compact (ASLP-IC) – Nichole Kingham Furness, Audiologist, Chairperson

**c.** Ms. Shadduck reported that the program has recommended the appointment of a speech-language pathologist, a public member and speech-language pathology assistant to the Governor. As program waits for official

appointments, Ms. Shadduck will consider appointing pro tem members in the interim to address any quorum issues.

Ms. Santiago reported that House Bill (HB) 1724 has passed. Sec. 8. (1) establishes that disciplining authorities shall waive education, training, experience, and exam requirements for applicants who have been credentialed in another state or states with substantially equivalent standards for at least two years immediately preceding their application with no interruption in licensure last longer than 90 days. (2) Disciplining authorities may waive education, training, experience, or exam requirements for applicants who have achieved a national certification for the profession as determined by the disciplining authority in rule. A dedicated staff member from the Office of Health Professions is reviewing the effect of HB 1724 on each profession.

## 10.Business Plan 2023 – 2025 – Nichole Kingham Furness, Audiologist, Chairperson

Ms. Shadduck presented the Business Plan. Chairperson Kingham expressed the plan lacked outcomes. Ms. Shadduck and Ms. Santiago will present a revised Business Plan at the next regular Board meeting.
