# Washington State Department of Health Healthy Environment for All Act Tribal Capacity Grant Application

# Important Information

Application Title: Healthy Environment for All Act Tribal Capacity Grant

**Estimated Funding Range per Award:** Base award up to \$403,450; additional funds may be redistributed based on availability and need.

An additional \$11,700,000 (estimated value) may be made available to overburdened communities and vulnerable populations through a separate grant process. Tribes and tribal organizations are eligible for these funds.

**Eligibility:** Available to any Federally Recognized Indian Tribe with HEAL Act impacts to rights and interests in their Tribal Lands, as defined in RCW <u>70A.02.010</u>: "*Tribal lands*" has the same meaning as "Indian country" as provided in 18 U.S.C. Sec. 1151, and also includes sacred sites, traditional cultural properties, burial grounds, and other tribal sites protected by federal or state law.

#### Expected Period of Performance: March 1, 2024 – June 30, 2025

#### **Application Timeline:**

Applications will be accepted starting December 15, 2023 through October 31, 2024, with a priority application due date of January 31, 2024. At the close of the priority application period, DOH will begin distributing available funds amongst the Tribes that have submitted a completed application according to the schedule below.

DOH will continue to accept applications through October 31, 2024 with funds distributed on a rolling monthly basis. After the priority application period Tribal organizations will be eligible for any unspent funds, not to exceed 15% of the overall funds reserved for Tribes. Tribes receiving an initial award may also request additional project funding using unspent funds.

This schedule is subject to change at the discretion of the Washington State Department of Health (DOH).



# Overview of the Healthy Environment for All Act Tribal Capacity Grant Funding

## Purpose

The Washington State Department of Health (DOH) Healthy Environment for All (HEAL) Act Tribal Capacity Grant is a non-competitive grant program to provide funds to eligible Tribes to engage with DOH and other state agencies on Healthy Environment for All (HEAL) Act implementation. All Federally Recognized Indian Tribes with HEAL Act impacts to rights and interests in their Tribal Lands (RCW 70A.02.010) will be eligible for this non-competitive funding opportunity.

These guidelines provide information about HEAL Act Tribal Capacity Grant Program for FY 2023 only. These funds are currently only available for the FY 2023 through 2025 biennium (ending June 30, 2025). These guidelines do not apply to any possible grant rounds in future biennia if additional funding becomes available.

All grant applicants should read and understand these guidelines before entering into a grant agreement with DOH.

# Background and Statutory Direction

The <u>HEAL Act</u>, passed in 2021, is the first statewide law in Washington to create a coordinated state agency approach to environmental justice. The law requires seven state agencies to identify and address environmental health disparities in overburdened communities and for vulnerable populations. It establishes the <u>Environmental Justice Council</u> to advise state agencies on incorporating environmental justice into agency activities and requires the Department of Health to maintain and update the <u>Environmental Health Disparities map</u>.

This grant program was recommended by the Environmental Justice Council in their <u>Climate</u> <u>Commitment Act funding recommendations</u> and <u>budget priorities</u>.

In the 2023 legislative session, the Washington State Legislature passed <u>Engrossed Second Substitute Bill</u> <u>5187</u> (now Chapter 475, Laws of 2023), the operating budget. The budget establishes capacity grants to Tribes and tribal organizations and to overburdened communities and vulnerable populations to provide guidance and input on HEAL Act activities for the 2023 through 2025 biennium (p.326 lines 10-28).

The grant program specifies these areas for guidance and input to:

- agencies on implementation of the HEAL Act (including environmental justice assessments, budgeting and funding, community, and Tribal engagement),
- the Environmental Justice Council on implementation of the HEAL Act, and
- the Department of Health on updates to the environmental health disparities map.

At least 50% of the total amount distributed for capacity grants must be reserved for grants to Tribes and tribal organizations. The funding may be used for Tribes and tribal organizations to hire staff or to contract with consultants.

Department of Health held a listening session, two roundtable discussions, and consultation with Tribes regarding the development of this grant program. At consultation and the comment period following consultation, we heard a preference to prioritize funding to federally recognized Indian Tribes' rights and

interests in their tribal lands impacted by the HEAL Act. We were advised to prioritize the full 50% of the funding reserved for Tribes and Tribal organizations in the proviso for Tribes. We have followed this advice in the grant development.

Following the priority application period ending January 31, 2024, tribal organizations will have the opportunity to apply for unspent tribal funds, not to exceed 15% of the overall funds reserved for Tribes. Tribal organizations are also eligible to apply for the grant funding that will be made available to overburdened communities and vulnerable populations.

# **Funding Details**

This section provides a basic overview of the funding program, including applicant and project eligibility and funding provisions.

# Applicant Eligibility

This is a non-competitive grant program open to all Federally Recognized Indian Tribes with HEAL Act impacts to rights and interests in their Tribal Lands (RCW <u>70A.02.010</u>). Each Tribe is eligible to receive multiple funding awards based on availability of funds.

# Eligible Project Activities

Grant funds may be used to build tribal capacity to engage in HEAL Act activities between July 1, 2023 and June 30, 2025. Funds may support activities that include, but are not limited to building capacity to provide guidance and input to:

• agencies on implementation of the HEAL Act (including environmental justice assessments, budgeting and funding, community, and Tribal engagement),

- the environmental justice council on implementation of the HEAL Act, and
- the Department of Health on updates to the environmental health disparities map.

## Grant award and match

\$11.7 million is available for disbursement through the grant application detailed below. A subsequent grant opportunity will disburse \$11.7 million to what's referred to as overburdened communities and vulnerable populations. Each Federally Recognized Indian Tribe with HEAL Act impacts to rights and interests in their Tribal Lands (RCW <u>70A.02.010</u>) will be eligible for an initial award of \$403,450. At the close of the priority application period (January 31, 2023), DOH will distribute the available funds amongst the Tribes that have submitted a completed application. Applications will continue to be accepted with funds distributed on a rolling basis through the end of the application period (October 31, 2024). Tribes receiving an initial award may request additional funding.

Tribal organizations will be eligible for any unspent funds, not to exceed 15% of the overall funds reserved for Tribes and tribal organizations.

There are no match requirements; grant awards will cover 100 percent of eligible costs up to the grant award amount.



## Payment Options

Once Department of Health has approved an application for funding, each Tribe may elect whether they prefer to receive funds through cost reimbursement or through incremental advance payments.

Advance payments will be made before actual costs are incurred but as close as administratively feasible to when project costs are incurred, and actual disbursements will be made.

Department of Health retains discretion to cancel the advance payment option based on an initial risk assessment, project performance, or recipient failure to comply with agreement terms and conditions. Prior to taking this action, Department of Health will attempt to contact and work with Tribes to improve project performance and/or resolve compliance and risk related concerns.

#### Eligible costs

Funding is valid for the 2023-2025 biennium (July 1, 2023 to June 30, 2025). Funding may support costs incurred prior to application submission but no earlier than July 1, 2023. All eligible activities must be incurred by June 30, 2025; funding may not be used to support costs incurred after this date.

#### Administrative costs

Administrative costs, which can also be called overhead rate, are business and operational costs incurred for a common purpose and not directly connected with a specific project. Administrative costs are not directly assignable to a particular objective of the project such as space utilities, miscellaneous copying, telephone, motor pool, janitorial services, records, storage, rentals, etc., items not directly attributable to the project yet are required to conduct business. A list of administrative costs must be reported with the first invoice and remain constant for the life of the grant.

#### Non-allowable costs

Non-allowable costs include:

- Clinical care, except as allowed by law.
- Reimbursement of costs prior to July 2023.
- Generally, recipients may not use funds to purchase furniture or equipment. Any such proposed spending must be clearly identified in the budget.
- Other than for normal and recognized executive–legislative relationships, no funds may be used for:
  - publicity or propaganda purposes to prepare, distribute, or use any material designed to support or defeat the enactment of legislation before any legislative body.
  - the salary or expenses of any grant or contract recipient, or agent acting for such recipient, related to any activity designed to influence the enactment of legislation, appropriations, regulation, administrative action, or Executive order proposed or pending before any legislative body.
