It is my great pleasure to share the news that we have selected Candice Wilson - Quatz'tenaut (Lummi) through a competitive recruitment to serve as the first Executive Director of the Washington State Department of Health's (DOH) Office of Tribal Public Health and Relations (OTPHR). She started in her role on January 2, 2024.

Thank you to those who were able to join the listening session we held last summer with tribes and tribal organizations to offer input and priority areas of focus as we launched the OTPHR. The comments we received will help shape OTPHR's focus and priorities and look for ongoing opportunities to continue to shape OTPHR's work as we move forward.
