## SUBJECT: Collaboration - Seeking Health Care Providers for Power of Providers (POP) Advisory Group

In accordance with chapter <u>43.376 RCW</u>, the <u>Washington State Centennial Accord of 1989</u>, and <u>DOH</u> <u>Consultation and Collaboration Procedure</u>, we invite collaboration with Indian tribes and tribal organizations in the development of policies, agreements, and program implementation that directly affects Indian tribes and tribal people.

In 2021, Governor Inslee and the Secretary of Health Dr. Umair Shah established the <u>POP initiative</u> to better understand and overcome barriers to COVID-19 vaccination through partnerships with health care providers. The POP Advisory Group fosters two-way communication to inform public health policy and programs. The group meets the first Thursday of each month from 1:00 - 2:00 via Microsoft Teams.

The group is a multi-specialty team of health care providers from across the state, including medical doctors, naturopathic physicians, nurses, physical therapists, mental health specialists, pharmacists, and more. The team engages in rich dialogue with DOH about community health issues, as well as recommendations on how to address those issues. Tribal participation is critical to better understand the public health needs impacting indigenous peoples and to partner on recommended solutions.
