As I wrote to you on October 25, 2023, the Health Equity Zones Initiative is a pilot initiative that reimagines how the Department of Health collaborates with communities through community driven decision making and innovative funding mechanisms. The initiative uses an impact led approach, recognizing that those most impacted by health inequities have the best understanding of the needs, strengths, and strategies to improve the health of their community.
