## **Washington Emergency Medical Services Information System Notice & Request for Comments on Proposed Rules**

The Department of Health (department), Office of Community Health Systems, Emergency Medical Services & Trauma System is proposing revisions and additions to WAC 246-976-- Emergency medical services (EMS) and trauma care systems.

The department is considering updating and adding to the chapter to support data reporting requirements codified in RCW 70.168.090, establish clear and concise data submission standards to the Washington Emergency Medical Services Information System (WEMSIS) and produce quality, usable data for improving standards of care and best practice for the benefit and safety of the public.
