Total Food Dollars Redeemed WIC Farmers Market Nutrition Program – Includes redemptions of both farmers market benefits and monthly fruit and vegetable benefits (CVB's) at authorized markets and farm stores. Includes dollars spent at authorized farmers markets & farm stores, and doesn't include other WIC dollars. Revenue based on growers location. Redemption period is between June 1 to October 31, 2023
