### **Common Terms**


- **Biennium** A two-year fiscal period. The biennium in Washington runs from July 1 of an oddnumbered year to June 30 of the next odd numbered year. We are currently in the 2023-25 biennium.
- Fiscal year A 12-month period used for budget and accounting purposes. The state fiscal year runs from July 1 through June 30 of the following year and is named for the calendar year in which it ends (e.g., July 1, 2023, through June 30, 2024, is fiscal year 2024). The federal fiscal year runs Oct. 1 through Sept. 30
- General Fund-State GF-S refers to the basic account that receives revenue from Washington's sales, property, business and occupation, and other general taxes, and is spent for operations such as public schools, social services and corrections
- Control Numbers At the end of each legislative session an EA (Expenditure Authority) Schedule comes from OFM with total allocation for the Agency for EVERY funding source that Department of Health gets. This is our spending authority.
- Full-time Equivalent (FTE) As a unit of measure of state employees; refers to the equivalent of one person working full-time for one year.
- Rebate Revenue Revenue generated from EIP Medication purchases that receive pharmaceutical rebates.
- Non-appropriated funds Moneys that can be expended without legislative appropriation. Only funds
  in accounts specifically established in state law as being exempt from appropriation fall into this
  category.

# Washington State Budget Process

Washington enacts budgets on a two-year cycle, beginning July 1 of each odd numbered year.

- The budget approved for the 2023–25 biennium remains in effect from July 1, 2023, through June 30, 2025, and encompasses State Fiscal Years 2024 and 2025.
- By law, the Governor must propose a biennial budget in December, the month before the Legislature convenes in regular session.
- The biennial budget enacted by the Legislature can be modified in any legislative session through changes to the original appropriations.
- Since the inception of annual legislative sessions in 1979, it has become common for the Legislature to enact annual revisions to the state's biennial budget. These revisions are referred to as supplemental budgets.

General Fund State Federal Funds Rebate Revenue-Dedicated Fund & Local Foundational Public Health Covid Funding



# Pharmaceutical Rebate Revenue Info

#### Rebate Revenue -

- Washington is a grantee of the Ryan White Program, a federal program that provides grants to states and cities to create a system of care for people living with HIV. The Ryan White Program Part B is specific to state health departments and includes funding for AIDS Drug Assistance Programs (ADAP).
- Washington's ADAP is called the Early Intervention Program or EIP. Martha Grimm is currently the Supervisor for this program and its staff.
- EIP provides medications, health insurance and financial support for medical, dental and mental health services to people living with HIV who have been deemed eligible by the program. There are approximately 15,000 people in Washington living with HIV and almost 5,000 of those people are enrolled in the Early Intervention Program.
- ADAPs are statutorily eligible to receive lower prices or "rebates" on medications as part of the 340B Program. Because ADAPs or EIP are allowed and expected to purchase medications for eligible participants, we also may apply for and receives pharmaceutical rebate revenue.
- Revenue generated from Ryan White Federal funds must be used for the statutorily permitted purposes under the Ryan White Program, which are limited to core medical services.
- Revenues generated with State funds have slightly more flexibility, but medication purchases with state funds are very rare.

### Pharmaceutical Rebate Revenue Info – Cont'd

#### **Rebate Revenue – Additional Information**

- Revenue generated from Ryan White Federal funds must be used for the statutorily
  permitted purposes under the Ryan White Program, which are limited to core medical
  services.
- Revenues generated with State funds have slightly more flexibility, but medication purchases with state funds are very rare.
