

Rulemaking Process

Administrative Procedures Act - Rulemaking consists by law of three parts:

Step	Process	Activity
CR101	Preproposal inquiry	Public outreach and interested party work occurs (workshops, drafts, informal input).
CR102	Proposal	The product that goes forward for public hearing and final testimony from the public.
CR103	Adoption	Final rule is adopted, filed with the Code Reviser's Office, and becomes effective 31 days later unless another effective date is specified in rule.

Proposed Rulemaking Timeline

Nov. 2021	CR101 - WSR# 21-23-082	Announced possible rule making to address hospital financial reporting within E2SHB 1272.
Feb. – Apr. 2022	4 Interested party meetings	Interested parties met to workshop rules, creates data submittal tools, and discuss submittal procedures.
Jul. 2024	CR101 – WSR# 24-15-024 Previous CR101 withdrawn	Announced possible rule making to address hospital financial reporting within E2SHB 1272.
Aug. 2024	Interested party meeting	Interested parties meet to workshop rules.
Sep. – Nov. 2024	CR102	The formal rule is proposed, written comments are received, and public hearing held.
Dec. 2024	CR103	Final rule adoption and rules package developed.
Jan. 2025	CR103 filed	CR-103 is approved by the Secretary for filing with the Code Reviser.
Jan. 2025	Rules effective	Anticipated rule effective date. A rule becomes effective 31 days after it is filed with the Code Reviser.

Rule(s) to be Discussed and Possibly Revised

- Chapter 246-454 WAC, Hospitals System of accounting, financial reporting, budgeting, cost allocation
- WAC 246-451-010 and 246-451-050, Hospitals Assessment and Related Reports
- The Department of Health is considering updating these rule sections to address the changes within RCW 43.70.052 that effect the uniform [hospital financial] reporting system. Also, under consideration are changes to modernize rules and update out of date references.

RCW 43.70.052 (1)(c): By January 1, 2023, the department must revise the uniform reporting system to further delineate hospital expenses reported in the other direct expense category in the statement of revenue and expense. The department must include the following additional categories of expenses within the other direct expenses category:

- Blood supplies;
- Contract staffing;
- Information technology, including licenses and maintenance;
- Insurance and professional liability;
- Laundry services;
- Legal, audit, and tax professional services;

- Purchased laboratory services;
- Repairs and maintenance;
- Shared services or system office allocation;
- Staff recruitment;
- Training costs;
- Taxes:
- Utilities; and
- Other noncategorized expenses.

RCW 43.70.052 (1)(d): The department must revise the uniform reporting system to further delineate hospital revenues reported in the other operating revenue category in the statement of revenue and expense. The department must include the following additional categories of revenues within the other operating revenues category:

- Donations;
- Grants;
- Joint venture revenue:
- Local taxes;
- Outpatient pharmacy;
- Parking;

- Quality incentive payments;
- Reference laboratories;
- Rental income;
- Retail cafeteria; and
- Other noncategorized revenues.

- RCW 43.70.052 (1)(e)(i): A hospital, other than a hospital designated by medicare as a critical access hospital or sole community hospital, must report line items and amounts for any expenses or revenues in the other noncategorized expenses category in (c)(xiv) of this subsection or the other noncategorized revenues category in (d)(xi) of this subsection that either have a value: (A) Of \$1,000,000 or more; or (B) representing one percent or more of the total expenses or total revenues.
- RCW 43.70.052 (1)(e)(ii): A hospital designated by medicare as a critical access hospital or sole community hospital must report line items and amounts for any expenses or revenues in the other noncategorized expenses category in (c)(xiv) of this subsection or the other noncategorized revenues category in (d)(xi) of this subsection that represent the greater of: (A) \$1,000,000; or (B) one percent or more of the total expenses or total revenues.

RCW 43.70.052 (1)(f) A hospital must report any money, including loans, received by the hospital or a health system to which it belongs from a federal, state, or local government entity in response to a national or state-declared emergency, including a pandemic. Hospitals must report this information as it relates to federal, state, or local money received after January 1, 2020, in association with the COVID-19 pandemic. The department shall provide guidance on reporting pursuant to this subsection.

Conflicts between new RCW and existing WAC



RCW 43.70.052 (1)(c), (d), (e), and (f) reference new reporting requirements that require revisions to the uniform [hospital financial] reporting system.

Uniform reporting system = <u>Accounting and Reporting</u> Manual | Washington State Department of Health

- Has been updated to:
 - Modernize to current accounting standards
 - Reflect requirements in E2SHB 1272
- Also contains a system for modifications/updates
