## **Executive Summary**

RCW 69.48.100(1) - By July 1st after the first full year of implementation, and each July 1st thereafter, a program operator must submit to the department a report describing implementation of the drug take-back program during the previous calendar year.

WAC 246-480-080(1) - Each program operator shall submit an annual report to the department by July 1st in the format provided by the department.

Inmar Rx Solutions, Inc., a wholly owned subsidiary of Inmar, Inc. ("Inmar") operates a Product Stewardship Plan in Washington for Covered Drugs as approved by the Washington Department of Health ("Department") on May 13, 2022, pursuant to Chapter 69.49 RCW and Chapter 246-480 WAC, the Drug Take-Back Laws. The Approved Plan ("Plan") requires that Inmar submit to the Department an Annual Report on the development, implementation, and operation of the Drug Take-back Program ("Program") for the previous year. This Annual Report describes collection and outreach activity between January 1, 2023 and December 31, 2023 ("Reporting Period") pursuant to RCW 69.48.100. Capitalized terms used herein are the same as those used in the Approved Plan and the Drug Take-back Laws.



Information regarding a list of Collection Sites with addresses and locations where Mailers were provided can be found in "Appendix A - Collection Site and Mail-back Distribution Site List." 25 mailers were sent to nonresidential locations that are not mail-back distribution locations.

Any qualified potential Authorized Collector that offered to participate in the program through Inmar was included in the program within 90 days.

During this program year, agreements with Collection Sites did not stipulate a formal requirement to report a need for prompt collection, maintenance, or Inner Liner supplies. Kiosk locations possess the necessary contact information and are instructed to reach out to Inmar regarding any issues related to prompt collection, maintenance, or Inner Liner supplies.

There were 9 instances of prompt collection issues in this program year. This includes third party transportation miscommunication, pickup scheduling, or Authorized Collector staff turnover resulting in a delay of Kiosk operation. The average amount of time between when Inmar was alerted to prompt collection issues and when a response was sent back to the Authorized Collector was 2 days.

There were 39 instances of regular maintenance requests in this program year. This includes mechanical issues that may or may not affect the operation of the Kiosk. None of these maintenance requests would be classified or resulted in a safety or security concern. The average amount of time between when Inmar was alerted to a maintenance issue and when the issue was resolved was 9.8 days.

There were 13 instances of inner liner requests in this program year. This includes reordering Inner Liners to ensure there is additional stock of Inner Liner supplies. The average amount of time between when Inmar was alerted of the need for more Inner Liners and when a response was sent back to the Authorized Collector was less than 1 day.

A list of potential Kiosk locations that Inmar reached out to throughout the program year on islands and outside population centers is located in Appendix C. During its efforts, Inmar was unable to determine the Kiosk status of each contacted potential location.

#### **Mailer Distributed**

Inmar distributed 21,102 Mailers during this Reporting Period. A complete list of Mailers distributed by zip code can be found in Appendix D.

### Safety or Security Concerns

RCW 69.48.100(1)(d) - Whether any safety or security problems occurred during collection, transportation, or disposal of covered drugs, and if so, completed and anticipated changes to policies, procedures, or tracking mechanisms to address the problem and improve safety and security; WAC 246-480-080(1)(j) - Safety or security problems including, but not limited to, all instances where collection, transportation, or disposal did not follow processes described in the approved plan, including processes for prompt collection and maintenance. Safety and security problems described must include any instances where a secure collection receptacle (kiosk) is opened for a reason other than packaging the inner liner for shipping, installing a new inner liner, or maintenance on a kiosk that does not contain an inner liner. The description of whether safety or security problems occurred during collection, transportation, or disposal of covered drugs must include:

- (i) Whether the problem occurred during collection, transportation, or disposal;
- (ii) Whether the problem met criteria for reporting to law enforcement, Washington state pharmacy quality assurance commission, United States Drug Enforcement Administration, or other entity and whether the operator can confirm that the reporting happened;
- (iii) If covered drugs were lost during transportation, whether transporter has policies for safely managing undeliverable packages that might include drugs;
- (iv) If transporter delivered covered drugs to the wrong address, description of attempts to retrieve covered drugs and whether those attempts were successful;
- (v) Program operator actions to ensure problem was reported, if required; appropriate investigation occurred; and risk of similar problem occurring in the future was minimized; and
- (vi) Changes to policies, procedures, or tracking mechanisms to address the problem and improve safety and security.

During the Reporting Period no safety or security concerns occurred.



### **Public Education & Outreach**

RCW 69.48.100(1)(e) - A description of the public education, outreach, and evaluation activities implemented;

WAC 246-480-080(1)(k) - A description of public education, outreach, and evaluation activities implemented shall include the following. "Promotional material" shall have the same definition as in WAC 246-480-070(4):

- (i) List of languages that printed or downloadable public promotional material are available in, with description of any printed or downloadable promotional material not available in these languages. List or description of languages used in any television, radio, social media, or other nonprint promotional material;
- (ii) List or description of languages available on: the single website and program operator specific website; the single toll-free telephone number and program operator specific telephone number; and call centers associated with the single toll-free telephone number and program operator specific telephone number. This list or description must include the name of language service providers where applicable;
- (iii) Description of how these languages or language services meet the language needs of people in Washington;
- (iv) Copies of all promotional material, including signage and changes to websites and telephone number scripts, developed since last annual report;
- (v) Description of how education and outreach efforts were implemented including:
  - (A) Date, type, and description of all social media and email promotion activity;
  - (B) Date, frequency, reach, and description of outreach for radio, television, print, and digital media platforms;
  - (C) List of brochures and posters available from single website and program operator specific website, number of times each was viewed, and number of times each was downloaded;
  - (D) Name, address, facility type, and date of email or hard copy distribution of brochures and posters to nonresidential entities; and
- (E) Total number of views and number of unique visitors for each page of single website and program operator specific website.
- (vi) Description of evaluation activities shall include:
  - (A) Evaluation of comments, questions, and concerns received from the public including evaluation of feedback themes and actions program operator has implemented or planned in response to feedback; and
  - (B) Evaluation of public education and outreach efforts, including evaluation of education and outreach implementation described in (g)(v) of this subsection.

Pursuant to RCW 69.48.070, Inmar executed a comprehensive and measurable public awareness and education strategy to drive awareness of the Program and maximize participation. The goal of Inmar's public awareness and education efforts was to ensure that Covered Entities and Authorized Collectors understood where and how to dispose of Covered Drugs.

To accomplish this comprehensive public awareness and education strategy, Inmar deployed a combination of outreach initiatives, including printed materials and media communication. Pursuant to RCW 69.48.070(1)(a)-(g), each initiative aimed to instruct Covered Entities by providing at least one, if not all, of the following key messages:

- Promote the safe storage of Legend Drugs and Non-legend Drugs by residents before secure disposal through the Drug Take-back Program.
- Discourage residents from disposing of Covered Drugs in solid waste collection, sewer, or septic systems.
- Promote the use of the Drug Take-back Program so that where and how to return Covered Drugs is widely understood by Covered Entities, pharmacists, retail pharmacies, health care facilities and providers, veterinarians, and veterinary hospitals.

Additionally, Inmar established a Program Toll-free Phone Number and Program Website that Covered Entities can utilize to find out more information about the Program. The Toll-free Phone Number can be translated into the below languages:

A summary of each of the initiatives deployed as part of Inmar's public awareness and education strategy is provided below.

During this program year no feedback was received from the public, outside of the 9 prompt collection issues called out in the "Collection Method Locations" section of this document. Inmar works to ensure any feedback evaluations, concerns, or suggestions from the public are assessed and effectively implemented to enhance our processes and services.

#### **Educational and Outreach Materials**

In accordance with RCW 69.48.070(1)(e), materials have been created and made available to Covered Entities. Educational materials promote the safe and secure storage of Covered Drugs while educating Covered Entities on best practices for disposal through the use of the Drug Take-back Program.

#### These materials:

- Provided instruction on how to safely store Covered Drugs at home.
- Informed of the risks of disposing of Covered Drugs in inappropriate waste streams (e.g., solid waste collection, sewer, or septic systems).
- Informed Covered Entities about Collection Sites and Mail-back Program services.
- Are translated into English, Vietnamese, Chinese, Tagalog, Spanish, Russian, and Korean.
  - Based on data pulled from the US Census Bureau, these 7 languages are the most commonly spoken in the state of Washington.

During the program year educational materials were sent to 5,765 non-residential medical, law enforcement, and veterinary facilities across the state of Washington.

#### **Kiosk Signage**

Kiosk Signage was created and implemented to educate and assist Covered Entities in the proper storage and disposal of Covered Drugs. In accordance with RCW 69.48.070(1)(g) and in partnership with the other Program Operator, a common mark logo was created to provide a common symbol for Covered Entities to identify collection methods and educational materials that are part of the Program. Kiosk signage is available in English and Spanish.

During this program year, Inmar updated its Kiosk Signage. An image of the new kiosk can be found in Appendix B.

#### Welcome/Introduction Letter

A welcome/introduction letter was sent out to Police/Sheriff's Departments, Hospitals, Medical Facilities, Treatment Centers, Pharmacy's, and Indian Nations. The letter was to educate these locations on the importance of the Safe Medication Return Program and to invite them to participate in the program in a few ways: becoming a mail-back or kiosk location and being an educated voice around safe medication disposal and storage in their respective communities.



#### **Newspaper/Print Advertisement**

In accordance with RCW 69.48.070(1), Inmar worked with The Seattle Times to educate and inform Covered Entities of medtakebackwashington.org and toll-free phone number, as well as the location of Drop-off Sites, Mail-back Distribution Sites. The advertisement was included in the print versions of the newspaper and was also included in any online/digital version. Newspaper ads were printed in English.

#### **Direct Mail**

In accordance with RCW 69.48.070(1), Inmar utilized direct mail (5x7 postcard) to promote safe drug disposal and the utilization of medtakebackwashington.org. Direct mailings were translated and sent out in Spanish and English. Direct mail postcards highlighted important statistics, medtakebackwashington.org, the Program toll-free phone number, a visual of what the Kiosk looks like, and how to operate the Kiosk. Direct mail postcards were printed in English and Spanish.

#### **Programmatic Media**

In accordance with RCW 69.48.070(1), Inmar targeted Covered Entities through programmatic media that provides targeted display ads on browser sites on internet capable devices (smart phones, computers, tablets, etc.). Additionally, geo-targeting was used to focus the ads to increase awareness among Covered Entities in middle to smaller sized cities. Inmar ran ads across a prequalified list of over 200K domains including a variety of retail websites, Google, and Facebook. Impression metrics are reported directly from the individual websites where the ads are placed and are reported on a per-campaign basis. Programmatic ads were displayed in English.

#### **Influencer Marketing**

In accordance with RCW 69.48.070(1), Inmar worked with Influencers to create educational and inspirational content that Covered Entities could read and engage with. Influencer Marketing is a content creation tactic used to drive awareness and education to a targeted audience through blogs and social media outlets. Influencers create original, authentic content around their everyday lives and interests while weaving the story of safe medication return into their content. Influencer content is converted into paid ad units across social platforms and then targeted to community members across Washington. Paid advertisements for influencer content were run on a variety of platforms including Google, Facebook, and/or Instagram, and aimed to meet a specified impression goal. Influencer marketing content was displayed in English.

 During this program year, Inmar was not set up to track overall unique pageviews or clicks/downloads of the educational materials. Process improvements for the website are ongoing and are reevaluated periodically.

### **Program Recycling**

RCW 69.48.100(1)(f) - A description of how collected packaging was recycled to the extent feasible; WAC 246-480-080(1)(l) - A description of how collected packaging was recycled to the extent feasible.

DEA § 1317.75(c) prohibits handling substances (opening, x-raying, analyzing, or otherwise penetrating mailers and inner liners) after they have been deposited into a Kiosk. For this reason, Inmar is unable to separate and recycle drug packaging. Inmar encourages Covered Entities to separate unwanted Covered Drugs from their packaging and recycle the packaging prior to disposal. Even though regulations prevent us from recycling drug packaging, Inmar has an interest in reducing waste and improving our environment. Through its Rx Returns and related business lines, Inmar has saved over 20,000 barrels of oil, recovered over 11,000 megawatts of clean energy, and powered over 900 homes in the past two years alone. We will continue to look for opportunities to expand our eco-friendly efforts in the state.

### Plan Collection, Education & Promotion Goals

- 1. Establish an additional 21 Kiosks at Collection Sites in populations currently underserved by Kiosks for a total of 215 Collection Sites in the state.
  - a. Inmar successfully added 34 kiosk locations during the Reporting Period, bringing the total number of kiosks to 233.
- 2. Continue providing service through Mail-back Distribution Locations and collection events in populations underserved by Collection Sites in coordination with the Department and local health jurisdictions.
  - Inmar met this goal by operating 324 mail-back Distribution Locations during the Reporting Period.



- 3. Inmar sets a collection goal (for Collection Sites) of 20 pounds per month per Collection Site for a total of 4,300 pounds of Covered Drugs collected from 215 Kiosks monthly and 51,600 pounds in the first year after Plan approval.
  - a. Inmar did not meet the goal of 20 pounds per month per drop-off site for a total of 51,600 pounds of drugs collected from 215 Kiosks in the first year. When setting these goals, Inmar used the best available data to estimate the amount of drugs typically collected in an average Kiosk among its existing national drug take-back network. Inmar believed these goals to be something to strive for and did not account for the necessary length of time and duration that a Kiosk should exist and build awareness in a community to collect the weights established.
    - i. Inmar has goals to increase the number of kiosk locations that it operates moving into its next program year. This would further expand the reach and collection total that Inmar's program provides to Covered Entities across the state.
    - ii. Increased awareness efforts were one factor that led to an increase of weight collected from program year 1 to program year 2. Inmar will continue to keep a diversified list of awareness tactics (digital and print) live throughout the program year providing opportunities to covered entities.
- 4. Inmar estimates approximately 342 pounds of Covered Drugs to be collected by Mailers in the first 12 months (5/13/22 5/12/23) of Plan operation and 125 pounds per collection event.
  - a. Inmar successfully collected 502.75 lbs of medication during its first 12 months as a program operator. No collection events were run so there was no weight collected.
- 5. Continue public awareness and outreach campaign as described in Section IV of Plan with a goal of reaching 50% of Covered Entities in Washington by 12 months (5/13/22 5/12/23) after Plan approval.
  - a. Inmar successfully reached more than 50% of covered entities based on the breakout of unique readers/viewers/residents. Below is a breakout of the percentage of reached Washington residents over the age of 18
    - i. Digital Media 30.67%
    - ii. Newspaper 31.54%
    - iii. Direct Mail 10.18%
  - b. Public awareness and outreach tactics were run during the Reporting Period
  - c. The results of the outreach activity we ran in the Reporting Period can be found above in the Public Education & Outreach section of this document.
  - d. Inmar will utilize the data from DOH's public outreach survey to guide our strategies and initiatives aimed at enhancing public knowledge and awareness. The findings from this survey will be used to evaluate and benchmark the current effectiveness of our outreach efforts and inform future actions.
- 6. Increase collection weight by 10% each year. (i.e. Year 2 collection estimates of 22 pounds of Covered Drugs per Collection Site, 5.5 ounces per Mailer and 137.5 pounds per collection event.)
  - **a.** Inmar collected 12,471.77 lbs in the first program year which lasted 7 and a half months, with our program operator status being approved on May 13th. To calculate what a projected full year 1



- weight could have been we will take the total weight and divide it by the number of months, then multiply that by  $12 \{(12,471.77 / 7.5 = 1,662.90) (1,662.90 \times 12 = 19,954.83)\}$ .
- **b.** Inmar collected 32,550.30 lbs in the second program year which is an increase of 63.12% from the projected full first program year weight collected.

#### Inmar's 2024 Collection and Education/Awareness Goals

- Collection Goals:
  - Increase collection weight by 10% each year.
    - 35,805.33 pounds collected across all collection methods
- Education/Awareness Goals:
  - Continue public awareness and outreach campaign as described in Section IV of Plan with a sustained reach of 50% of Washington residents.


