# **Important Social Security Number Information:**

If you have a Social Security Number, the law requires you to disclose it on your application for a professional or occupational license. 42 U.S.C. § 666(a)(13); RCW 26.23.150. It will be used under the state's child support enforcement program to locate individuals for purposes of establishing paternity and establishing, modifying, and enforcing support obligations. You are not required to have or obtain a Social Security Number to apply for or obtain a license from the Department of Health. If you do not have a Social Security Number, you are still eligible to apply for and obtain a credential if you meet the requirements. Please see the Declaration of No Social Security Number Form. 

# **Application Instructions Checklist**

**Important background check Information:** Washington State law authorizes the Department of Health to obtain fingerprint-based background checks for licensing purposes. This check may be through the Washington State Patrol and the Federal Bureau of Investigation (FBI). This may be required if you have lived in another state or if you have a criminal record in Washington State. This would be at your own expense.

All information should be printed clearly in blue or black ink. It is your responsibility to submit the required forms.

_	<b>Application Fee.</b> This fee is non-refundable. You can check the online <u>fee page</u> for current fees.
_	Select if the following applies: Spouse or Registered Domestic Partner of Military Personnel
	1. Demographic Information: Social Security Number: You must list your social security number on your application. You are not required to have or obtain a Social Security Number to apply for or obtain a license from the Department of Health. Please see the Declaration of No Social Security Number Form. Please call the Customer Service Center at 360-236-4700 if you do not have one.

**National Provider Identifier Number (NPI):** The National Provider Identifier (NPI) is a standard unique identifier for health care professionals available from the Federal Centers for Medicare and Medicaid Services. The NPI is a 10 digit numeric identifier. If you have a NPI number, provide this on your application.

Legal Name: List your full name: first, middle, and last.

**Definition of legal name:** "Legal name" is the name appearing on your official certificate of birth or, if your name has changed since birth, on an official marriage certificate or an order by a court. The court must have the legal authority to change your name. We may ask you to prove your legal name. If you use any name other than your legal name on this form, your application may be denied.

**Birth date:** Provide month, day, and year of your birth.

**Address:** List the address we should use to send any information. Be sure to include the city, state, zip code, county, and country. This will be your permanent address with the Department of Health until we have been notified of a change. See <u>WAC 246-12-310</u>.

**Phone, Fax and Cell Numbers:** Enter your phone, fax and cell numbers, if you have them.

**Email:** Enter your email address, if you have one.

**Other Name(s):** Indicate whether you are known or have been known under any other names. If you have a name change, you must notify the Department of Health in writing. You must include proof of this change. See <u>WAC 246-12-300</u>.

2. Personal Data Questions:
 All applicants must answer the same personal data questions. They are focused on your fitness to practice the essential skills of this profession.
If you answer "yes" to any questions in this section, you must provide an appropriate explanation. You must also provide the documentation listed in the note after the question. If you do not provide this, your application is incomplete and it will not be considered.
<ul> <li>Question 5 includes misdemeanors, gross misdemeanors and felonies. You do not have to answer yes if you have been cited for traffic infractions. You can get copies of court records through the county courthouse where the conviction, plea, deferred sentence, or suspended sentence was entered.</li> </ul>
<ul> <li>Another jurisdiction means any other country, state, federal territory, or military authority.</li> </ul>
<b>3. Education:</b> List in date order your educational preparation and post-graduate training. Attach additional pages if you need more space.
<b>4. Experience:</b> List in date order all experience and practice from date of graduation from professional college. Attach additional pages if you need more space.
5. Music Therapist Board Certification (MTBC): List your certification number if applicable.
6. Other License, Certification, or Registration: List all states where credentials are or were held. List all active, inactive and expired credentials. Specifically list credentials granted as temporary, reciprocity, exemption or similar with type, date, grantor, and if credential is current.
7. Applicant's Attestation: You must sign and date this for us to process the application.


# For Spouses and Registered Domestic Partners of Military Personnel Being Transferred or Stationed in Washington:

Under state law, if you are the spouse or state-registered domestic partner of a servicemember of any branch of the U.S. Military, to include Guard or Reserve, and are applying for a health care professional credential in this state, you may be eligible to have the processing of your application expedited to receive your credential more quickly.

Documents to submit with your application should include the following:

- A copy of your spouse's or registered domestic partner's military transfer orders to Washington State.
- One of the following:
  - A copy of your marriage certificate to show proof of marriage; or
  - A copy of a state's declaration or registration showing you are in a state registered domestic partnership with a member of the U.S. military.

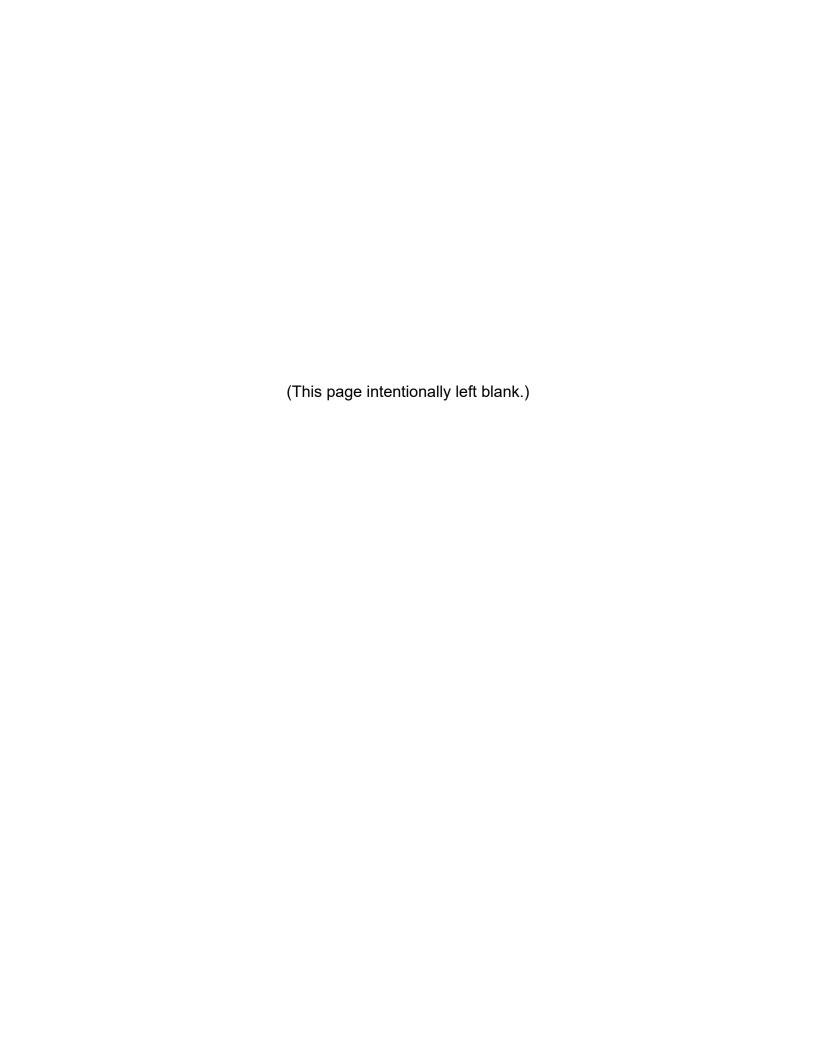

# **License Requirements**

	ink you for applying to become a music therapist in Washington State. In order to lify for licensure, you must complete the following requirements:
	Application and fee;
	Verification of current certification as a Music Therapist Board Certification (MTBC) from the Certification Board for Music Therapists (CBMT). The department may request that you submit verification of your current certification directly from the CBMT.

	<ul> <li>Have a bachelor's degree or higher from a program that is aproved by the American Music Therapy Association (AMTA).</li> </ul>
	Official Transcripts: Have your college or university mail your transcripts with the degree and date of graduation listed to the Department of Health. Transcripts must come to us directly from the school. Non-posted transcripts or student copies are not acceptable.
	Examination:
	Provide proof of completion of the national MTBC examination.
	Out-of-state verification form to be completed by the state(s) you are or have held licensure. The state will complete its portion of the license verification form and mai it directly back to Washington State.
	<b>Note:</b> Many states charge a verification processing fee. Contact them prior to

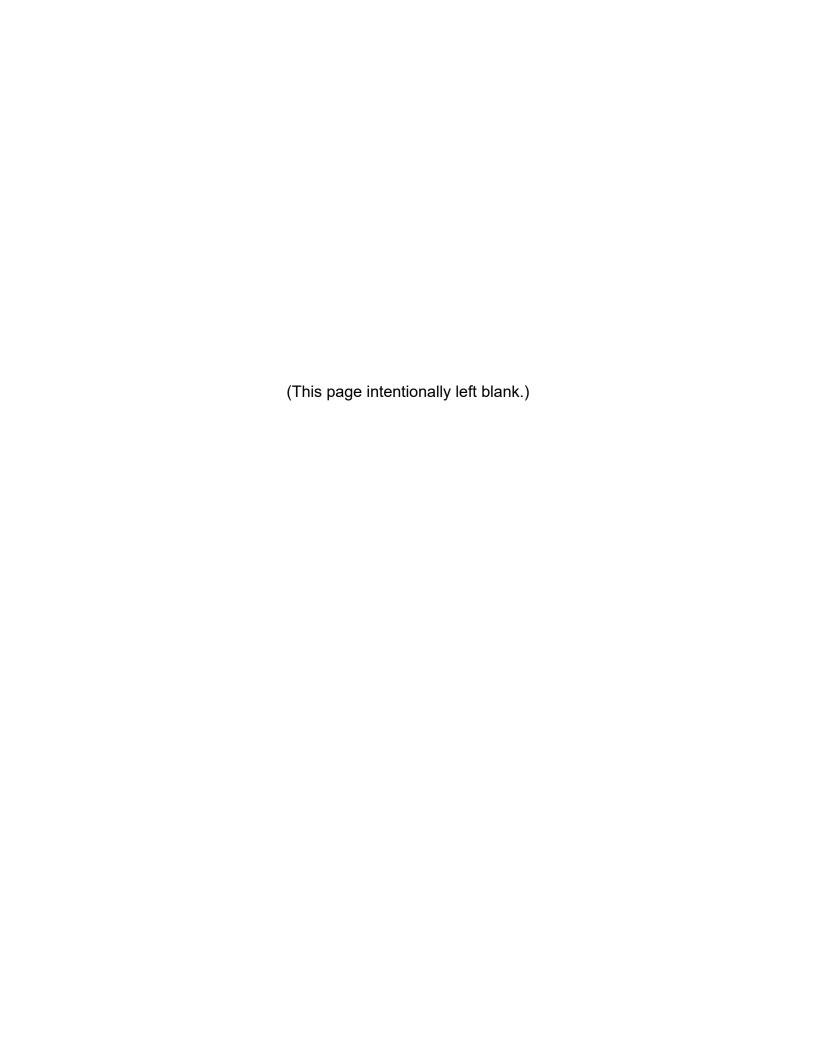
