Greetings Honorable Tribal Leaders, Partners, and Professionals,

RE: Collaboration – Workgroup on the Risk of High Potency Synthetic Opioids to Children and Youth

In accordance with chapter <u>43.376 RCW</u>, the <u>Washington State Centennial Accord of 1989</u>, and <u>DOH</u> <u>Consultation and Collaboration Procedure</u>, we invite collaboration with Tribes and Tribal organizations in the development of policies, agreements, and program implementation that directly affects Tribes and Tribal people, regarding the risk of high-potency synthetic opioids to children and youth.

<u>Senate Bill 6109 Child Welfare and Dependency – High-Potency Synthetic Opioids (2024)</u> requires the Department of Health, in collaboration with WA Department of Children, Youth and Family and the poison information centers, to convene a workgroup on exposure of children to fentanyl that will provide information for child welfare workers, juvenile courts, caregivers, and families regarding the risks of fentanyl exposure for children receiving child welfare or child protective services.

We invite you to actively collaborate as a participant in this workgroup as we develop materials regarding the risk of fentanyl to children and youth. We anticipate this workgroup will meet up to 4 times between now and June 2025. The first meeting will be held:
