New WIC-Approved Foods Coming in January



Starting on January 6, 2025, WIC participants will be able to buy newly approved foods from the following food categories:

- Bread and Buns
- Breakfast Cereal
- Brown Rice
- Cow's Milk and Goat's Milk
- Fresh Herbs
- Pasta
- Peanut Butter
- Soy Beverages
- Tofu
- Tortillas
- Oatmeal

Starting December 30, 2024, please work with your POS provider to ensure your system has uploaded the Approved Products List (APL). Upload the APL often from December 30 to January 6. This ensures your POS system will allow newly approved products and remove deactivated products. Our Foods team will be sending out a memo in mid-November, which will include the UPC/PLU information.

Please work with staff to have WIC labels reflect the updated foods during January. The updated <u>WA WIC Shopping Guide</u> and <u>Approved Product List (APL)</u> will be available only online starting January 6, 2025. There will be several updates in 2025 and we'll be printing the Shopping Guide in October, 2025...

Darigold Milk Carton Size Update




On December 15, Darigold will start shipping WIC approved half gallon (64oz) milk cartons to stores. The 64 oz size will replace their current 59 oz cartons that are not WIC approved. You can use your WIC card to buy half gallon Darigold milk as soon as it arrives in stores.

WICShopper App: I Couldn't Buy This!

The WICShopper App offers a helpful feature where WIC participants or store employees can easily reach state WIC staff by selecting the "I **couldn't buy this!"** button and filling out a brief form. This allows users to report issues when certain foods that are possibly WIG-approved or aren't scanning correctly at the store. By submitting this feedback, state WIC staff are notified of the issue, enabling them to investigate and resolve it promptly, ensuring smoother transactions for WIC participants and improving the accuracy of approved food items.



Vendor Interactive Training Schedule 2025



All WIC authorized stores must attend an interactive training within the current contract period, which ends on September 30, 2026. We have created a schedule of upcoming **online and in-person interactive trainings** this year to help you accomplish this goal. Additional trainings will eventually be scheduled for 2025 and 2026, but we encourage stores to not wait to fulfill this requirement.

572 out of **799** Washington stores still need to attend a WIC Vendor Interactive training for this contract period. We are hoping most stores can complete this requirement in 2025. We encourage you to sign up for one of our online or in-person trainings.
