<a href="#">HB 1520</a>	Pharmacists' scope of practice	<p>The bill would add a new section to chapter 18.64 RCW that allows pharmacists to prescribe certain categories of drugs including immunizations, antihistamine agents, hormonal contraception, and other medications used for the treatment of diseases, as well as drugs, drug categories, or devices that are limited to specified circumstances such as not requiring a new diagnosis or being minor and generally self-limiting in nature. The new section also has an expiration date of January 1, 2030.</p> <p>The definition for “practice of pharmacy” in RCW 18.64.011(32) is amended to include the diagnosing of conditions and diseases and the prescribing or ordering of drugs and devices as authorized by chapter 18.64 RCW and commission rules. The commission is also granted rulemaking authority to administer and implement the bill.</p> <p>RCW 69.41.030 is also amended to allow pharmacists to sell or deliver legend drugs “to the extent permitted under chapter 18.64 RCW” and removing the requirement to do so only through the creation and approval of “written guidelines or protocols” under RCW 18.64.011 and approved by a practitioner authorized to prescribe drugs.</p>	<p><b>HB 1520</b>  <i>Sponsor(s):</i> Representatives Thai, Reed, Simmons, and Macri</p> <p><i>First Reading (House):</i> 1/22/2025, referred to Health Care &amp; Wellness Committee.</p>

<a href="#"><u>SB 5201</u></a>	Access to psychedelic substances	<p>This bill establishes wellness model-based psilocybin services and establishes DOH and LCB authority to license, regulate, and enforce all provisions. Psilocybin can only be administered to a person 21 years of age or older in an approved setting, under the supervision of a licensed psilocybin facilitator or clinical facilitator. The program development period is designated from September 1, 2025 to September 1, 2027, during which DOH is to establish a Psychedelic Substances Board to advise DOH, conduct rulemaking, and establish educational trainings and exams.</p> <p>DOH must establish rules regarding qualifications, licensing and renewals, fees, education and training, substantially equivalent qualifications, testing, scope of practice, and other regulations specified in the bill for multiple new professions and facilities.
