## 2. PEDIATRIC SEDATION ENDORSEMENT

- 2.1. The Commission will review the pediatric sedation endorsement policy statement.
  - Ms. Gardner informs the Commission that there have been some challenges with building the new pediatric sedation endorsement credential into the Healthcare Enforcement and Licensing Management System (HELMS).
  - Ms. Gardner shares that on the morning of February 13, 2024, the Department of Health announced that the HELMS Project Team, Steering Committee, and liaison group decided to delay HELMS Release 2 until later this spring.
  - Ms. Gardner shares that the Mid-February credentialing freeze has been delayed until sometime in spring.
  - There will be a four-week period where pediatric sedation endorsement applications cannot be processed following the spring credentialing freeze to accommodate building the new endorsement into HELMS.
  - Until the spring credentialing freeze occurs, pediatric sedation endorsement paper applications can continue to be processed.
  - Dr. Swanson facilitates a discussion with the Commission regarding the most appropriate action to take in response to the latest HELMS update.
- 2.2. The Commission may vote to approve further extending the effective date for the pediatric sedation endorsement.
  - There is a motion to extend the pediatric sedation endorsement effective date to June 30, 2025.
  - The motion is moved and seconded.
  - A vote is taken and unanimously passes.
