# Washington State PrepMod Project Summary

January 2021-December 2024

#### **Background**

In fall 2020 the Office of Immunization within Washington State Department of Health (DOH) prepared for a mass vaccination effort after the roll-out of the first COVID-19 vaccines as part of COVID-19 Response. Federal COVID-19 response efforts encouraged mass vaccination. As a result, both traditional and non-traditional vaccine partners needed to have a tool to organize the scheduling and reporting of vaccinations. The Office of Immunization understood Washington needed a technical tool to help partners host large vaccination clinics.

#### What is PrepMod?

DOH chose the web-based software application, PrepMod. DOH supplied PrepMod free to support providers and Local Health Jurisdictions (LHJs) in creating vaccine clinics. PrepMod use also supported federal and Washington Immunization Information System (WAIIS) reporting requirements. Partners could create vaccination clinics, schedule patients, and report events to the WAIIS. PrepMod supported the administration of publicly provided vaccinations. It was very useful in events where many patients were vaccinated at the same time, often outside of the traditional health care setting.

## **PrepMod in Action**

DOH created a WA State PrepMod Team to support project work. The team on-boarded and trained 74 private health organizations, LHJs and tribal health clinics. The team trained National Guard Service Members, a team from the Federal Emergency Management Agency (FEMA) and DOH staff to support vaccination events. DOH in partnership with the National Guard Service Members supported the four, state-supported mass vaccination sites in Vancouver, Wenatchee, Tri-Cities and Spokane. Support staff tracked vaccine data that was sent to WAIIS to make sure it was complete. PrepMod was very useful in helping patients to quickly and easily find available vaccination clinic locations. PrepMod helped make it possible for providers to hold large vaccine events that would have otherwise been difficult to organize.

## **Expansion**

In late 2021 the program expanded to include flu vaccinations. The program also partnered with mobile nursing teams. In August 2022 Washington State used PrepMod in response to the Mpox outbreak. In fall 2023 PrepMod partnered with the Childhood Vaccine Program (CVP) and Adult Vaccine Program (AVP). Since the beginning of the Care-A-Van project, PrepMod provided important organizational help for vaccination events at remote locations in our state, where vaccination clinics are not always accessible. The program administered over 1.2 million vaccinations during its operation. This was possible because of the partnership of the local health jurisdictions, Tribal governments and private health organizations.


#### Care-A-Van administered almost 61 thousand COVID-19 vaccine doses.


