



What to Bring to Your WIC Appointment (New Applicant or Recertification)

Call WIC if you need to reschedule or missed your appointment!

WIC applicants have the option to complete their appointment in-person at the clinic **OR** remotely by phone.

1. **For in-person appointments only**, each person applying for WIC **must** be present at the first appointment.
2. **Identification (ID)** – Have **ONE** ID available from the list below for **each person** applying and/or recertifying for WIC.

Acceptable forms of ID include:

- ProviderOne Card (must be active)
- Driver’s license or state ID card
- Military ID
- Tribal ID card
- Work or school ID
- Passport
- Resident Alien Card, Consular ID, or National ID card from another country (Example: Green card, Immigration and Customs Enforcement (ICE) ID card)
- Birth certificate
- Health insurance or military medical card
- Social Security card
- Voter registration card
- Infants and children: Items listed above or hospital birth record, crib card, ankle bracelet, hospital discharge paperwork, newborn hearing screen or other assessment, Well Child Check-up, home birth record, note from doctor or midwife on letterhead or prescription pad with the infant’s date of birth

Note: Being on WIC does not make you a public charge and does not affect your immigration status. U.S. citizenship is not required to qualify for Washington WIC.

3. **Proof That You Live in Washington** – Bring **ONE** of the following with your name, street address, city, state, and zip code. *WIC can’t accept P.O. boxes as proof of residence.*

- ProviderOne Card (must be active)
- Washington driver’s license or state ID card
- Utility bill (gas, electricity, water, garbage, or phone)
- Medicaid, SNAP, or TANF notification letter
- Rent or mortgage statement or receipt
- Voter registration card, or state or local document that requires proof of state or local residency
- Paystub or Military Leave and Earning statement
- Other. Example: Health insurance or social service card with address

4. **Proof of Income** – Bring proof of **ALL** sources of household income. A household includes people who live together and share income and household expenses. Examples include:

- ProviderOne Card (must be active)
- Employment (pay stubs for the last 30 days)
- Military Leave and Earning statement
- Self-employment
- Unemployment benefit statement
- Public Assistance statement (FDPIR, SNAP, TANF)
- Foster Care document
- Child Support
- Spousal Support
- Supplemental Security Income (SSI)
- Scholarships or grants
- Native American Per Capita Payments
- Money from relatives or friends
- Veteran’s benefits
- Retirement/Pension (civilian or military)
- Worker’s compensation, disability or Labor and Industries

5. **Immunization Records** for infants and children under age two, if available.
