DRAFTED RULEMAKING LANGUAGE	 Link to the law Changes to WAC 246-320-281: Emergency Services (Transfer of a patient language) Changes to WAC 246-320-010: Language added for definition "Emergency medical condition" to bring the WAC into alignment with legislation that was passed in April of 2025.
