

## **NSF Certified, PFAS-Reducing Water Filter Brands (Point-of-Use Type)**

NSF is an independent organization that sets standards for the performance of water filters and other products. NSF and a few other organizations perform lab testing of the filters to verify they meet the criteria to be certified. For additional information about ensuring your filter is certified to NSF standards and other PFAS home water treatment topics, see <a href="Home Water Treatment for PFAS">Home Water Treatment for PFAS</a> 331-699 (PDF). **PFAS Certification Standard**: "**PFOS+PFOA**" means that an initial concentration of 1,500 ppt of PFAS +PFOA is reduced to 70 ppt or less. The "**Total PFAS**" standard means that initial concentration of 2,160 ppt of a mixture of PFOS, PFOA, and a number of other PFAS compounds is reduced to 20 ppt or less. It's important to note that the current certification standards for PFAS filters do not yet indicate that a filter will remove PFAS down to the levels EPA has now set for a drinking water standard. EPA is working with standard-setting bodies to update their filter certifications to match EPA's new requirements. In the meantime, remember that reducing levels of PFAS in your water is an effective way to limit your exposure.

Filters listed below are not endorsed by DOH. This is not intended to be a list of every filter approved to NSF standards for PFAS removal. We updated this information in June 2025. Check the manufacturer website for the most current information. Do-it-yourself installation instructions are included with all units, but some people may want a plumber's help.

## **Reverse Osmosis Filter Options (Point-Of-Use Filters)**

Below are some examples of RO filters on the market. Note that RO filters block PFAS from entering your tap water but send the blocked PFAS to your septic tank or sewer where PFAS can re-enter the environment. RO systems also waste water. On average, three to four gallons of water are sent down the drain for every one gallon of filtered water.
