



Grant Guidelines Update

Source Water Protection Program

More than 6.2 million people living in Washington State rely on drinking water supplies, which public water systems (PWS) source from groundwater, surface water, and springs. Protecting these source waters is the first step in providing safe and reliable public drinking water to customers.

The Source Water Protection Program focuses on PWS wellheads and watersheds. Source water protection is the primary way to reduce the risk of contamination or decline in water availability. By protecting critical sources, PWS can proactively keep water supplies clean, safe, and reliable rather than waiting for source water pollution to occur or for a well to run dry.

The Source Water Protection Local Assistance Grant provides funding for these projects.

- We are updating our grant guidelines and seeking feedback on program priorities to ensure resources are directed to projects that serve tribes and communities most impacted by water quality and quantity concerns.

- **♦ May-September**: Community Survey open.
- **♦ September 10:** Listening session 1.
- **♦ September 17:** Listening session 2.
- **♦ September 30:** Community Survey closes.
- October: Draft grant guidelines published.
- October-November: Comment period open on draft guidelines (accepted via email).
- ♦ November 30: Comment period closed.
- December 30: Final grant guidelines and Environmental Justice Assessment published.
