

PLANNED PARENTHOOD OF THE GREAT NORTHWEST, HAWAI'I, ALASKA, INDIANA, KENTUCKY PROFILE 2024

WASHINGTON STATE SEXUAL & REPRODUCTIVE HEALTH NETWORK

Planned Parenthood of the Great Northwest, Hawai'i, Alaska, Indiana, Kentucky (PPGNHAIK) receives funding devoted solely to sexual and reproductive health and related preventive health services with a focus on low-income and uninsured persons. Funding supports a variety of services, including FDA– approved birth control, STI/HIV testing, breast and pelvic exams, Pap smears and other cancer screenings, pregnancy testing and counseling, achieving pregnancy, and pre-pregnancy health. PPGNHAIK works with Washington State Department of Health to assure quality and affordable sexual and reproductive health services at its clinics in Clallam, King, Kitsap, Lewis, Mason, Pierce, Snohomish, and Thurston counties.

In 2024, PPGNHAIK served 26,338 clients during 30,068 clinic visits, representing an 18% increase in clients and a 7% increase in clinic visits from 2023. Across the state, an estimated 90% of female clients of reproductive age served in 2024 were on some form of contraceptive method, resulting in a lower risk of unintended pregnancy, unplanned births, and abortions.

Sexual & reproductive health services provided by PPGNHAIK prevented an estimated* 5,360 unintended pregnancies and 1,810 abortions, and saved over \$28M in health care costs in 2024 alone.

PPGNHAIK's sexual & reproductive health services averted unwanted reproductive health outcomes and saved healthcare-related expenses by providing contraceptive services, testing and treatment for sexually transmitted infections, and prevention of certain cancers, like breast and cervical cancer. Most notably, in 2024 the agency's services prevented an estimated 5,360 unintended pregnancies, 2,530 unplanned births, and 1,810 abortions resulting in net savings of over \$28 million associated with maternal and birth-related care, miscarriages, ectopic pregnancies, and abortions averted.
