is considering amending fees in chapter 246-254 WAC, Radiation protection fees, to cover operating costs. This may	
include updating or restructuring existing fees, making ed	itorial updates, repealing obsolete fees, or creating new fees.
Statutes authorizing the agency to adopt rules on this subject: RCW 43.70.250, RCW 43.70.110, RCW 70A.388.050	
Reasons why rules on this subject may be needed and what they might accomplish: The department is considering	
amending fees for all programs within the Office of Radiation Protection to ensure program costs are adequately covered.	
The department has completed an initial assessment and determined the current fees are not generating sufficient	
revenue to cover the operating costs over the biennium. This is necessary to address existing program deficits, reductions	
in funding from General Fund State (GFS) and Foundational Public Health Services (FPHS) accounts, and cost-of-living adjustments made in the 2025-2027 state budget (ESSB 5167). RCW 43.70.110 and 43.70.250 authorize the Secretary of	
Health to establish various fees associated with licensing and regulation of professions, occupations, or businesses.
