PASCO's Statutory Charge

- PASCO was created by the Legislature to **reduce** human exposures to pesticides.
- Charge includes:
 - Evaluate and recommend policy actions
 - Improve pesticide application safety
 - Establish baseline data
 - Improve communication
- Enhance education and prevention techniques
- North Star: All PASCO work should tie back to reducing human exposures.

2-Year Work Plan Overview

Key components & Deliverables by July 2027:

- 8 -Year Vision Plan
- Redesigned Legislative Report (annual, iterative)
- Clear processes for how PASCO recommends actions
- Key activities to proceed and monitor

Considerations:

- PASCO's time = 6 meetings, ~12 hours total
- Focus: Pausing on new ideas while we focus on the 2-Year Work Plan and scope the 8-Year Vision.

Activities in Motion

- Shared dataset progress (DOH/WSDA/L&I): working toward data integration.
- **Tri-agency collaboration**: quarterly meetings + WSDA's Training & Education (TSEP)+ Managers monthly meetings.
- Advisory Work Group Support: ongoing participation and technical expertise.

Agricultural Leadership Program (WSDA): PASCO determine next steps and recommendation

Agricultural Leadership Program (WSDA)

- WSDA has prepared updated numbers for ALP continuation.
- ALP is a key leadership development program for the agricultural sector.
- Discussion questions:
 - O How does ALP connect to pesticide application safety?
 - Would PASCO like to formally connect its support for ALP to its charge of reducing pesticide exposures?

8 Year Plan To-Do's

- Solidify committee's goals and mandate
- Identify measures of success
- Conduct updated inventory to identify gaps and recommendations for key priority areas and activities on which to focus
- Identify process for Committee "recommending" action

Timeline

- 2025-2027 = 2-Year Work Plan (6 meetings, 12 hrs).
 - Advisory committee meeting series:
 - Winter 2025/26
 - Winter 2026/27
- July 2027 = Deliver 8-Year Vision Plan.
- 2028-2035 = Implementation, refinement, new ideas.
- Discussion: What supports will help PASCO succeed (subgroups, email reviews, drop-in sessions)?
